ITEM NO.1**Decision of the Regional Transport Authority, Attingal [Rural] Dated 18.09.2021**

Heard the learned counsel represented the applicant. Fresh regular permit on the route Attingal – Kattaparambu- Trivandrum **granted** to Stage Carriage **KL 15 A 228** or suitable vehicle as applied for, subject to production of current records.

ITEM NO.2**Decision of the Regional Transport Authority, Attingal [Rural] Dated 18.09.2021**

Heard the learned counsel represented the applicant. Fresh regular permit **granted** on the route Kappil H.S – Kappil H.S to suitable vehicle as applied for subject to settlement of timings. Total route length 17 Km on which 0.8 km overlaps on notified route which is below the limit of 5% as per GO(P) 42/2009 Trans dated 14/07/2009.

To consider the application for temporary permit in respect of stage carriage KL 03 J 1881 Or New vehicle or suitable vehicle on the route Kusavoor - Kallingu junction via Perigamala, Chittoor, Iqbal College, Thennoor, Chettachal, Chayam in the surrendered vacancy of stage carriage KL 16 B 5216.

Heard the learned counsel represented the applicant. This was an application for Temporary permit in which there is no regular permit. The timings of the surrendered permit were allocated to senior operators and the issuance of the Temporary permit will create unhealthy time clash in the sector. Hence the application for the Temporary permit is **rejected**.

Heard the learned counsel represented the applicant. The running time allotted between kadakkavoor and attingal to other operators is 20 minutes. Here the applicant opted 25 minutes, and this will create unhealthy competition on the sector. Hence the application **adjourns**, u/s 71(2) of MV Act, directing the applicant to re submit the application with fresh set of timings.

Heard the learned counsel represented the applicant. The route in question comes under Area scheme vide GO(P)No. 105, 106 and 107/94/PW&T dated 24/11/1994. KSRTC strongly objected the grant of fresh permit or even issuance of Temporary permit on this route. The route portion from Pulippara to Nedumangadu Bankumukku 3.5 Kms and 3.9 Kms from Anad to Nedumangadu Bankumukku objectionably overlaps the above schemes.

As per the field report total route length is 46 kms out of which 2.8kms (more than 6 %) objectionably overlaps the Trivandrum- Shenkotta scheme, which is complete exclusion. As such this permit cannot be allowed.

Hence the application for Fresh permit on the route Kallara - Bankmukku is **rejected**. Being scheme violation, no further temporary permit to be issued on this route.

KSRTC strongly objected the grant of this permit being objectionable overlapping of 2.1 Kms between Pazhakutti and Puthanpalam, thus application for fresh permit is **rejected**.




