**Decision:**

Heard the counsel for the applicant and KSRTC and perused the connected records. KSRTC raised objection that the route Palakkad to Pollachi via Para, Kozhijampara and Gopalapuram included in the inter state agreement 1976 between the State of Kerala and Tamil Nadu in the Appendix Part B serial No.32 which provides to grant 2 permits for 2 buses with 10 single trips only, but the applicant operate 6 single trips daily.

Advocate Sri.Sajeevkumar K Gopal, the counsel appeared for the applicant in the above matter before the STA meeting held on 24.12.2021 had forwarded, written submission against the contention raised by the KSRTC. He has contented that the route Palakkad-Pollachi Via Para, Kozhijampara and Gopalapuram is included as serial number 32 of Part B of the interstate agreement. 



provisions of a draft notification will come into force only when the said draft has been finalized. Here in this case, since the draft notification No. G.O(Ms)78/Home dated, 13.01.1989 issued for amending the principal agreement of 1976 has not been finalized, the provisions for enhancement of number of single trips from 10 to 12 will not come into force and hence the contention raised by the counsel for the applicant is not legally tenable.


**Agenda:** To take decision regarding specifying category of contract carriages with respect to seating capacity for implementation of uniform colour code.

Considering the suggestions to exclude certain categories of contract carriages from uniform colour code, it is decided to exclude Motor Cabs, Maxi Cabs and LMV Contract carriages from the purview of implementation of uniform colour code.
