

**Item No. 01****Decision of the Regional Transport Authority, Kollam dated 06.04.2022**

Heard.the proposed route Punalur-Adoor is of 36.1 Km and in which a distance of 1.7 Km overlaps various notified routes,notified underG.O(p) No.42/2009/Trans dated 14.07.2009.But the objectional overlapping is less than 5% of total overlapping as specified under clause 5© of the above notification.The inspecting officer has reported that the proposed route will be beneficial to the farmers residing at the area through which the route passes through.He has also ascertained that the entire route portion is fit for operation of stage carriages having wheel base upto 4470 cm.As per the proposed timings this authority feels that the intention of the applicant is to operate service between Pathanapuram and Adoor and by this the travelling public residing at Kariyara,Kamukincherry etc will not be benefited.Hence the application for fresh permit is **adjourned** with direction to the applicant to submit modified set of timings with entire trips touching both the terminii.

**Item No. 02****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

1)Perused the judgment in WP©No.10624 of 2021 of Honourable High court of Kerala dated 21/06/2021.

2)Heard.The enquiry officer has reported that the proposed route is beneficial to the travelling public and students especially during the pandemic affected period where the passenger capacity restricted in stage carriages and the proposed route does not overlaps any notified route.The enquiry officer also reported that the proposed route is saturated.Hence the application for fresh permit is **rejected** with a view that the issuance of new permit will cause unhealthy competition between the enroute operators and the covid scenario is almost over .

**Item No. 03****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

1)Perused the Judgment in M.V.A.A No.187/2019 of Honourable STAT Ernakulam dated 18/10/2019.

2)Heard.Objection to the effect that the starting termini "Koppam"lies in Thiruvananthapuram district.But the inspecting officer has specifically mentioned that the proposed route is an intra district one.Hence the secretary R.T.A is directed to obtain a detailed report in this regard and place before the next R.T.A.Hence **Adjourned** .

**Item No. 04****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.Reconsidered the application for fresh regular permit on the route Elavaramkuzhy-Anchal and it is found that the proposed route overlaps the notified route,notified under G.O)p)No.42/2009/Trans dated 14.07.2009 for a distance of 0.6

km out of the total distance of 28.3 km. The overlapping on the notified route is within the prescribed limit specified under clause 5© of G.O(p)no.42/2009/Trans dated 14/07/2009. The enquiry officer reports that the additional strengthening of service is beneficial to travelling public especially students residing at the route area of Anchal grama Panchayath. Hence the fresh permit is **granted** to a suitable stage carriage on the route Elavaramkuzhy-Anchal via Vilakkupara, Yeroor, Anchal, Panayamchery, Earam, Vadamon, Kurivikkonam, Vadamon, Thoithala, Panayamchery. subject to the the settlement of timings.

**Item No. 05**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The total distance of the proposed route Anchal P.B.S-Eyyakodu-Moonnukallinmoodu is 20.2 km and of which a distance of 0.9 km from Anchal private bus stand Kurishinmoodu overlaps Trivandrum-Kottayam via Ranni supplementary scheme vide notification number G.O(p)No.42/2009/Trans dated 14.07.2009. The overlapping on notified route is within 5% of the total route length. K.S.R.T.C alleged that there is a discrepancy in the starting point whether it is Anchal PBS or Anchal RO junction. The enquiry officer reports that the proposed route connects two important places of Kollam district and beneficial to the travelling public. But enquiry officer did not specifically reported that the starting terminus is Anchal PBS or Anchal RO junction. Hence secretary RTA is directed to obtain a detailed enquiry report whether the starting terminus is Anchal PBS or Anchal RO Junction. Hence **Adjourned**.

**Item No. 06**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. Reconsidered the application. The proposed inter district route Pandalam P.B.S-Kattilmekathil temple is 49 km long of which a distance of 4.7 km lies in Pathanamthitta district and 16.7 km lies in Alappuzha district. Both the sister authority granted concurrence. The overlapping of the notified route is 0.7 km from Titanium junction to Sankaramangalam and is within the prescribed limit of 5% of the total route length. Hence the fresh permit is **granted** to a suitable stage carriage on the route Pandalam PBS-Kattil mekkathil temple via Iranikuzhi, Edappon, Paraj, Charummoodu, Vayyamkara, Bharanikavu, Titanium Jn, Sankaramangalam. subject to the the settlement of timings.

**Item No. 07**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.The enquiry officer reported that a portion of 2.6 km from Mammoodu to Nedumparambu is virgin and fitness certificate from the P.W.D Authorities not submitted before the authorities.On examining the time schedule submitted,this authority feels that the intention of the applicant is to operate service without touching both the terminii.Hence the secretary RTA is directed to obtain fitness certificate and place before next RTA.The applicant is also directed to submit modified set of timings with full trips touching both the terminii.Hence **Adjourned.**

**Item No. 08**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.Total distance of the proposed route is 35.4 km of which a distance of 1.5 Km overlaps various notified route notified under G.O(p)No.42/2009/Trans dated 14.07.2009. The overlapping of notified route is within 5% of the total route length.K.S.R.T.C alleged that the proposed route is saturated with K.S.R.T.C and private stage carriage services.Hence secretary RTA is directed to submit a detailed report on the frequency of stage carriage services through the proposed route and place before next RTA.Hence **Adjourned.**

**Item No. 09**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.The proposed route Kollam beach-Kottiyam is of 15.1 km long of which a distance of 0.2 km of Kollam railway station to goods shed overlaps Trivandrum-Palakkad supplementary scheme vide notification under G.O(p)No.42/2009/Trans dated 14.07.2009.The overlapping is with in the permissible limitof 5% as specified in clause 5© of G.O(p)No.42/2009/Trans dated 14.07.2009.The enquiry officer reports that the proposed route will be beneficial to the travelling public.Hence the application for fresh regular permit is **granted** to a suitable stage carriage on the route Kollam beach-Kottiyam via Andamukkom,S.M.P Palace,Railway station,Ayathil,decent junction,Puthichira,P.K Junction and Thazhuthala.subject to the settlement of timings.

**Item No. 10**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.Total length of the proposed route Kadakkal-Anchal is 19.8 km of which a distance of 0.6 km from Anchal Ro Junction to Anchal P.B.S overlaps the notified route Thiruvananthapuram-Thiruvalla via Kozhencherri notified route notified under G.O(p)No.42/2009/Trans dated 14.07.2009 The overlapping is with in the permissible limit of 5% as specified clause 5© of the above notification.The enquiry officer reported that the proposed route is beneficial to the travelling public especially farmers and students.Also the applicant is operating stage carriage service on the same route on the strength of temporary permit as per the direction of honourable S.T.A.T vide order number in M.P.No.122/2022 in MVAA No.28/2021 with a set of settled timings.In these circumstance fresh permit is **granted** to KL-06-C-6400 or a suitable vehicle on the route Kadakkal-Anchal via Derppakkadu, kanjirathummoodu, Alummukku, Karukone and Puthayam.

**Item No. 11**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

1)Perused the judgment in WP©No.2364 of 2022 dated 31/01/2022 of honbl'e High court of Kerala.

2)Heard.The total distance of the proposed route Punalur Market Jn to Achankovil is 46.9 Km of which a distance of 2 km from Mukkadavu to Alimukku overlaps notified route Trivandrum-Kottiyam via Ranni scheme notified under G.O(p)No.42/2009/Trans dated 14.07.2009 and is not objectionable since it is within the 5 % of the total route length as per clause5© of the above notification. Also a distance of 5 km from Sarkkar mukku to Elikkottur is reported to be virgin and road fitness certificate obtained.The enquiry officer has reported that major portion of the route is ill served by public transport system and will be beneficial to the travelling public including students.The applicant is operating stage carriage service on the same route on the strength of temporary permit issued under sec.87(1)c with a set of settled timigs.Hence fresh permit is **granted** for a suitable vehicle on the route Punalur market Jn-Achankovil via papper mill,elikkattur palam, kuriyottumala, mukkadavu, alimukku,Karavoor,Chanakkaman,Olappara,Kottakkayam,Mullumala,Chempanaruvi.

**Item No. 12****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

1) Perused the judgment in WP©No.1848 of 2022 dated 19/01/2022 of honbl'e High court of Kerala.

2) Heard. The total distance of the proposed route Achankovil to Punalur market Jn is 46.9 Km of which a distance of 2 km from Alimukku to Mukkadavu overlaps notified route Trivandrum-Kottiyam via Ranni notified scheme notified under G.O(p)No.42/2009/Trans dated 14.07.2009 and is not objectionable since it is within the 5 % of the total route length as per clause 5© of the above notification. Also a distance of 5 km from Elikkatur to Sarkkar mukku is reported to be virgin and road fitness certificate obtained. The enquiry officer reported that major portion of the route is ill served by public transport system and will be beneficial to the travelling public including students. The applicant is operating stage carriage service on the same route on the strength of temporary permit issued under sec.87(1)c with a set of settled timigs. Hence fresh permit is **granted** for a suitable vehicle on the route Achankovil-Punalur Market junction Via Chempanaruvi, Mullumala, Kottakkayam, Olapara, Chanakkaman, Karavoor, Alimukku, Mukkadavu, Kuriyottumala, Elikkattur palam, Sarkkar mukku, Papper mill.

**Item No. 13****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

1) Perused the judgment in WP©No.4253 of 2022 dated 28/02/2022 of honbl'e High court of Kerala

2) Heard. The proposed route Kottarakkara P.B.S to Nelpparakunnu is of 36 K.M of which a distance of 1.3 km from Kottarakkara P.B.S to Kottarakkara market Jn overlaps notified route Kollam Pampa supplementary scheme notified under G.O(p)No .42/2009 dated 14/07/2009 and is not objectionable as per clause 5© of the above notification. At present the applicant is operating service on the route on the strength of temporary permit issued under sec 87(1)c of M.V act. Hence fresh permit is **granted** for KL-14-G-2333 or a suitable vehicle/ on the route **Kottarakkara PBS - Nelpparakunnu** via Vendar, Puthoor, Bharanicavu, Sasthamcotta, Bharanicavu and Kadapuzha subject to the settlement of timings.

Heard.The proposed route Kottarakkara P.B.S to Nelpparakunnu is of 36 K.M of which a distance of 1.3 km from Kottarakkara P.B.S to Kottarakkara market Jn overlaps notified route Kollam Pampa supplimentation scheme notified under G.O(p)No.42/2009 dated 14.07.2009 and is not objectionable as per clause 5© of the above notification.Hence fresh permit is **granted** to KL-61-A-6618 or a suitable vehicle/ on the route **Kottarakkara PBS - Nelparakunnu** via Vendar, Puthoor, Bharanicavu, Sasthamcotta, Bharanicavu and Kadapuzha subject to the settlement of timings.

- 4)Heard.The proposed route Elampalloor-Chavara is 26 km long and the entire portion comes under the purview of city permit and overlap various notified route notified under G.O(p)No.42/2009/Trans dated 14.07.2009.Hence **rejected** the application for fresh regular permit on the route Elampalloor-Chavara via Keralapuram,Kadappakkada,Chinnakkada,Civil station, Sakthikulangara,Neendakara.
- 5)Temporary permit u/s 87(1)c is **rejected** since there is no urgent temporary need.

**Item No. 16****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The total distance of the proposed route is 125.6 km of which a distance of 5.2km overlaps various notified route notified under G.O(p)No.42/2009/Trans dated 14.07.2009 which is more than 5% of the total route length and violate clause 5© of the notification. On examining the proposed time schedule, this authority feels that the intention of the applicant is to operate service with out touching both the terminii .The learned counsil appeared for the applicant has argued that the proposed route does not violate clause 5© of the G.O(p)No.42/2009/Trans dated 14.07.2009. Hence secretary R.T.A is directed to obtain a detailed report on the above matter and place the matter before next R.T.A with a modified time schedule without cut trips. Hence **adjourned** the application for fresh regular permit on the route Amruthapuri-Achankovil via Ayiramthengu, Edayavanambalam, Mundukottakkal, edayanambalam, Thottathilmukku, Vallikkavu, Karunagappally, Mynagappally, Bharanikavu, Puthur, salvation army church, Kottarakkara, Pulamon kurisu jn, Govindamangalam, Pathinettampady, randalummoodu, naduthery, Pulimukku, Kanjirathummoodu, Panampattakurisu, Karyara, sarkarmukku, Pappermill, chemmanthoor stand, sarkarmukku, kuriyottumala, mukkadavu, alimikku, Karavoorperunthoyil, mahadevarmannu, olappara, cheruppittakavu and chempanaruvi.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The proposed route Paravoor-Kadakkal is an inter district one .The total route length of 31.8 km of which a distance of 2 Km from Pallickal to Kattuputhusseri lies in Thiruvananthapuram district. On examining the proposed time schedule this authority feels that the intention of the applicant is to operate the service with out touching the both terminii. The secretary RTA is to obtain **concurrence** from the RTA Attingal and place before the next R.T.A with a modified time schedule with out cut trips. Hence **adjourned** the application for fresh regular permit on the route Paravoor-Kadakkal via Parippally, Pallickal, Nilamel.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**



Heard.Renewal of regular permit in respect of stage carriage KL-23-C-3982 on the route **Karunagappally H S - Adoor** (Via) Puthiyakavu, Aramathumadom, Manappally, Thamarakulam and Charumoodu. is *granted*.

Heard.Renewal of regular permit in respect of stage carriage KL-24-A-1694 on the route Kadakkal-Kallara via Mukkunnam, Kummil, Mathra, Pangodu is *granted*.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.Renewal of regular permit in respect of stage carriage KL-25-B-4418 on the route Kallara - Punalur via Pangodu, Kummil, Kadakkal, Kanjirathummoodu, Vayala, Kottukkal, Anchal, Punalur, Alimukku and Kottakkayam is *granted*.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.Renewal of regular permit in respect of stage carriage KL-38-A-3045 on the route **Pozhikkara - Punalur** (Via) Chathannoor, Parippally, Ayoor and Anchal is *granted*.

**Item No. 125**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.1) Perused the judgment in WP©No.6730 of 2021 of honourable High court of Kerala

dated 09/07/2021.

2) Perused the judgment of Honourable High court of Kerala in WP [C] No.22911 of 2020 dated 07.01.2021.

3) Perused the order of G.O.No.316/2020/Trans dated 05/10/2020.

4)Perused the connected files and records.The matter relates to reconsideration of applications for renewal of permit and transfer of permit on the route Chavara-Kottiyam in respect of KL-02-S-154.It is understood that stage carriage KL-02-S-0154 was owned by Sri.Iqbal and the vehicle was covered by a regular permit on the route Chavara-Kottiyam.Regular permit expired on 13.10.2013.Application for renewal of regular permit along

with delay condonation request was considered and granted by RTA. But the granted renewal was not endorsed, since the permit holder failed to produce the current records. The vehicle was seized under section 11 of KMVT act and rules. There was also a labour dispute between the permit holder and crew of the vehicle. The claim petition no.20/2013 filed before honourable labour court, Kollam was disposed on 13.11.2013, directing the permit holder to pay a remuneration of Rs.819475/- to the crew members. The permit holder Sri.Iqbal failed to disburse the amount and subsequently the vehicle which was kept under the custody of Chavara police station was attached by Munsiff court for auction procedure. On auction, the vehicle was purchased by the decree holders, Sri.Thajudeen, driver, Sri.R.Prakash, conductor and Sri.Murukanandan cleaner of the vehicle KL-02-S-154. In view of order of honourable court, duplicate registration certificate was issued on 30.10.2017 and the ownership of the vehicle was transferred to the name of Sri.Thajudeen on the basis of remittance of arrears and as per declaration of other decree holders, as they untraminously appointed, Sri.Thajudeen as the sole hirer of the vehicle.

Application for renewal of permit and transfer of permit was filed by Sri.Thajudeen. Application for replacement of vehicle by stage carriage KL-05-P-6462 and renewal of permit was also filed by Sri.Iqbal represented by power of Attorney holder Sri.Rahul.

All the applications were considered and rejected by RTA in its meeting dated 21/02/2019. Honourable high court in WP(c)No.22911/2020 and wp(c) No.6730/2020 filed by Sri.Thajudeen and Sri.Iqbal, directed to take a decision on the applications filed by them.

Considered the applications on merits.

**1) Application for renewal of permit and replacement filed by Sri.Iqbal, represented by power of attorney holder, Sri.Rahul.**

Sri.Iqbal was the permit holder of vehicle KL-02-S-154. The validity of the permit expired on 13/10/2013 and the renewal of permit granted by RTA could not be claimed by Sri.Iqbal due to tax arrears. Due to labour dispute between the crew, the vehicle was attached and sold in auction. Sri.Iqbal has submitted application for renewal of permit and claimed renewal of permit and replacement by stage carriage KL-05-P-6462.

Renewal of permit is governed by section 81 of MV Act. Section 81(4) of MV Act read as "The RTA or STA as the case may be, may reject an application for renewal of permit on one or more of the following grounds, namely

- a) The financial condition of the applicant as evidenced by insolvency, or decrees for payment of debts remaining unsatisfied for a period of thirty days, prior to the date of consideration of the application.

b) The applicant had been punished twice or more for any of the following offences within twelve months reckoned from fifteen days prior to the date of consideration of the application committed as a result of the operation of a stage carriage service by the applicant,namely:-

i) plying any vehicle

1) without payment of tax due on such vehicle.

2) without payment of tax during the grace period allowed for payment of such tax and then stop the plying of such vehicle

3) on any unauthorized route.

ii) making unauthorized trips.

It is understood that the vehicle was seized for non payment of tax under section 11 of Kerala Motor Vehicle Act and rules and kept under the safe custody of Chavara police station.Honourable Labour court,Kollam had directed the permit holder,Sri.Iqbal to pay a remuneration of Rs.819475/- to the crew members for denying employment.The permit holder failed to disburse the amount and subsequently the vehicle was attached by Munsif court,Karunagappally and auctioned.

This proves that the applicant financially unstable.The vehicle covered by the permit was attached and auctioned.The applicant has defaulted his service on the route for which permit has granted.Morover he is not the owner of the vehicle for which permit was issued.This authority feels that he has no claim over renewal of permit.Since the renewal is not considered and has no valid permit at present,application for replacement is not favourably considered.Application for renewal and replacement submitted by Sri.Iqbal is *rejected* .

2) **Application for renewal of permit and transfer of permit filed by Sri.Thajudeen.**

Stage carriage KL-02-S-154 owned by Sri.Iqbal was attached by Munsiff court Karunagappally and auctioned.This stage carriage was purchased by Thajudeen and ownership was transferred to his name.

A joint application under rule 178 of KMV rules is not submitted to secretary RTA.Only the vehicle KL-02-S-154 was transferred to Sri.Thajudeen's name.The applicant cannot claim holdership of permit on the ground that a duplicate permit was issued to him.What the rule contemplates is a joint application(which posits an agreement between the parties for a mutual transfer)and the desire to transfer the permit is embodied

in the joint application. It is the joint application that gives jurisdiction to RTA and once that jurisdiction is conferred the authority can decide on the application for transfer of permit.

In this case only the vehicle was acquired by the applicant Sri.Thajudeen. The permit expired on 13.10.2013 and the same was not renewed further. There is no mutual agreement between the permit holder and the applicant has no authority to claim for transfer of permit and subsequent renewal of permit.

The applicant has no locus standi for application for transfer and renewal of permit. The condition prescribed in section 82(1) of MV Act and 81(2) and (3) of MV Act is not complied or fulfilled by the applicant.

Hence the applications stand *rejected*.

**Item No. 126**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. 1) Delay condoned.

2) The proposed variation includes the curtailment of first and last trip between Nilamel-Madathara and vary the timings of the second trip. The enquiry officer has not reported whether the curtailment will affect the public or not. The secretary R.T.A is directed to obtain a detailed report in this regard and place before next RTA. Hence *adjourned* the application for variation in respect of stage carriage KL-14-G-6577.

3) Renewal of regular permit in respect of stage carriage KL-14-G-6577 on the route NILAMEL-MADATHARA via Kariyam, Kadakkal, Chithara, Thumpamaonthodi is *granted*.

**Item No. 127**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard 1 and 2. Pursued the Judgment in WP©.No.24531 of 2021 dated 09/11/2021 of honourable high court of Kerala. The proposed variation includes one additional trip between Kallara and Kadakkal and vary of timings of first trip. The enquiry officer reports that time variation is beneficial to the travelling public. The proposed variation do not violate clause 19 of G.O(p) No.42/2009/Trans dated 14.07.2009. Hence variation sought for in respect of stage carriage KL-02-R-6039 on the route KALLARA-ANCHAL(via) Puthayam, Karukone, Mannoor, Kadakkal, Kummil, Pangodu, Kallara is *granted* subject to the settlement of timings.

**Item No. 128****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The proposed variation includes curtailment of a portion from Mukkada to kadakkal and extension from Mukkada to Vilakkupara. The enquiry officer has reported that the proposed curtailment will adversely affect the passengers from Anchal to Kadakkal. Hence variation on the route Chenkulam-Kadakkal via Punalur, Tholikkodu, Echamkuzhy, Erannoor, Karikkom, Ayilara, Yeroor, Anchal Market JN, puthayam, Muthodupalam, Thottumukku, Vayala, Chariparambu and Altharamoodu as Chenkulam-Vilakkupara via Punalur, Tholikkodu, Echamkuzhy, Erannoor, Mukkada, Yeroor, Gurumandiram and Ayilara is *rejected*.

**Item No. 129****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The proposed variation includes curtailment of 4.2 Km from Chirakkara Moolakkada to Ooninmoodu and extension of 5.4 Km from Chirakkara-Moolakkada to Meenambalam via Parippally. The enquiry officer reported that the extension of 5.4 Km from Chirakkara-Moolakkada to parippally is very much helpful to the public comes from interior portion from Chirakkara panchayath to enter national high way to Parippally. The proposed extension does not overlap any notified route. Hence variation sought for on the route Ooninmoodu –Kollam Chinnakkada Clock Tower via Chirakkara Temple, Uliyanadu, Vilappuram, Kochalumoodu, Thirumukku, Ithikkara, Kottiyam, Umayanalloor, Mylapore, Estate JN, Palathara, Muttavila, Pallimukku and SN College JN *as* Parippally – Kollam Chinnakkada Clock Tower via Meenambalam, Shastri Mukku, Chirakkara, Moolakkada, Uliyanadu, Vilappuram, Thirumukku, Ithikkara, Umayanalloor, Mylapore, Palathara, Pallimukku and College JN, extension from Chirakkara Moolakkada to Parippally via Meenambalam, deviation from Chirakkara Moolakkada to parippally and curtailment from Chirakkara Temple to Ooninmoodu is *granted* subject to the settlement of timings.

**Item No. 130****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The enquiry officer has reported that the proposed variation does not overlap notified routes and is beneficial to the farmers from the Oil Palm India Pvt Ltd. He further reports that the proposed curtailment will slightly affect the public since the frequency of service of K.S.R.T.C in this portion is in half an hour difference and another private stage carriage operating just 5 minutes later to the proposed curtailment schedule. In a view of the report, this authority feels that the curtailment will affect travelling public. Hence application for variation on the route Kadakkal-kadakkal Mannoor, Vayala, Anchal, Altharamoodu is *rejected*.

**Item No. 131****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

1) Heard. Perused the judgment of honourable Honb'le State Transport Appellate Tribunal Ernakulam In M.V.A.A No.25/2019 dated 07/02/2019. The proposed variation includes curtailment of 1.2 km from Meeyannoor panchayath Jn to Kummalloor and extension of 1.8 Km from Meeyannoor panchayath jn to Meeyannoor with curtailment of first and last trip between Kottiyam and Asramam ESI. The enquiry officer reports that the proposed extension of 1.8 Km from Meeyannoor panchayath Jn to Meeyannoor is very much helpful to the travelling public and students since it is proposed to pass through Assessia Medical college. Curtailment from Meeyannoor Panchayath jn to Kummalloor will not affect travelling facility since Kummalloor is a minor jn on the route Chathannoor to Kottarakkara and well served with private stage carriages. The enquiry officer further reported that the curtailment of trips between Kottiyam and Asramam ESI junction will not affect the travelling facility since the route is well served with public and private transport system. The proposed extension does not overlap any notified route. Hence variation *sought for* is **granted** subject to the settlement of timings.

**Item No. 132****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The proposed variation includes curtailment of one trip begin from Karunagappally at 5.02 pm to Bharanikavu via Mynagappally and variation from Karunagappally at 5.12 pm instead of 5.02, to Bharanikavu via Patharam. The enquiry officer reported that the proposed variation from Alumukku to Bharanikavu via Patharam is beneficial to public and students. The proposed extension does not overlap any notified route. The enquiry officer further reports that the proposed curtailment from Alumukku to Bharanikavu via Mynagappally will not affect the travelling public since this portion is well served by various private stage carriages and STU. Hence the variation sought for on the route Bharanikavu-Bharanikavu via Sasthankotta, mararithottam, Karunagappally K.S.R.T.C jn, Karunagappally railway station, Edakulangara, Karoorkadavu, Somavilasam, Kumaranchira, Patharam, kakkakunnu, Kozhimukku. by curtailing the route from 5.02pm beginning from Alumukku to bharanikavu via Mynagappally, ICS jn, Sasthankotta and variation from Alumukku (5.12 pm) Alumukku to bharanikavu via karunagappally railway station, Edakulangara, Karoorkadavu, Somavilasom, Kumaranchira, Patharam, kakkakunnu, Kozhimukku. is **granted** subject to the settlement of timings.

2) Renewal of regular permit is **granted**.

**Item No. 133****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The proposed variation includes curtailment of 3.5 Km from Eravipuram to Koottikkada and extension of 3.3 Km from Eravipuram to Thani junction. The proposed extension does not overlap any notified route. The enquiry officer reported that the curtailment from Eravipuram to Koottikkada does not affect the travelling facility since this portion is well served by private stage carriages and the proposed variation from Eravipuram to Thani Jn is very much helpful to the public coming from interior portion of Eravipuram to Chinnakkada. Hence variation sought for on the route **CHAVARA - KOOTTIKKADA** (Via) Foundation, Sakthikulangara, Cutcherry

Junction, Iron Bridge, Chinnakkada, Kochupilammoodu, M G Park And Kandathupalam as **CHAVARA –Thanni Junction** (via) by Curtailing the route portion from Eravipuram to Kottikkada and an extension from Eravipuram to Thanni Junction is *granted* subject to the settlement of timigs.

**Item No. 134**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. The proposed variation includes curtailment of first and last trip between Kallara and Kadakkal. The enquiry officer reported that the withdrawal of service between Kallara & Kadakkal will not affect the travelling public since the portion is well served by public transport system. Hence variation sought for on the route Kallara-Depot jn via Kadakkal, Chithara, Madathara and Chozhiyodu As First trip curtail from Kallara to Kadakkal and the trip start from Kadakkal is *granted* subject to the settlement of timigs.

**Item No. 135**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard. Fresh permit is *granted* to KI-15-7056 on the route Kollam-Madathara Via Kottiyam, Chathanoor, Paripally, Nilamel, Kadakkal. subject to the production of a set of clash free times schedule.

**Item No. 136**

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

The proposed route Pattazhi Temple-Puthoor is an inter district route of which a distance of 12.5 Km comes under Kollam district. The enquiry officer has reported that in Kollam district a distance of 7.5 km from Pakisthanmukku to Puthoor which is more than 20% of the total route length (total route length is 33.5 km). The enquiry officer has not specifically mentioned whether the proposed varied portion overlaps any notified routes. Hence secretary RTA is directed to obtain a detailed enquiry report in this regard and place before next RTA. Hence *adjourned*.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Surrender of permit in respect of KI-02-AB-9045 operating on the route Paripally ESI-Kadakkal via Parippally, Pallikkal and Nilamel is **accepted**.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Surrender of permit in respect of KI-09-V-3374 operating on the route Chavara - Malanada via Kottamkulanga, Puthensanketham, Chenankara, Padappanal, Sasthamcotta, Bharanicavu and Ezhammile is **accepted**.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Surrender of permit in respect of Kl-16-D-6111 operating on the route Paripally-Thirumukku via ESI Medical College,Block marammukku,Chirakkara Temple,Kothery, Uliyanadu is **accepted**.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Surrender of permit in respect of Kl-33-5341 operating on the route Anayadi-Anchal via Thengamam, Ador, Ezhamkulam, Padinjarevila, Kaduvathodu, Karayara is **accepted**.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Surrender of permit in respect of Kl-11-AL-7892 operating on the route Oachira-Puthoor via Kalloormukku, Manappally, Chakkuvally, Kadampanadu, Pakisthanmukku and Kadampanadu is **accepted**.

**Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

It is proposed by the Secretary RTA on deligation of the power to renew stage carriage intra district permit and inter district permit those are issued prior to 14.07.2009.Regional Transport Authority Kollam in its meeting dated 03.09.2019 deligated the power to secretary RTA to renew those permit(Intra district),which are issued prior to 14.07.2009 as item No.91.As per the Government notification No.8/2017/Trans dated 23.03.2017 in SRO No.151/2017 clause 5(b)



modified as “The existing and operating permits as on 14<sup>th</sup> July 2009 will be permitted to operate as ordinary or ordinary Limited Stop Service”.Hence for prompt and convenient despatch of business power of Regional Transport Authority to renew stage carriage intra district and inter district permits issued prior to 14.07.2009 is deligated to Secretary RTA as per Rule 133 of KMV rules 1989.Secretary RTA should publish the details of the permit in the notice board,which he intends to renew seven days prior to the date of renewal and the list of such renewed permits are to be placed before next RTA for ratification.If any of the route overlaps more than 5% of the total route length on the notified route,notice shall be issued to K.S.R.T.C for seeking their objections if any as per Kerala Motor vehicle rules.
