

**Item No.S1****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.This is an inter district route having a route length of 112.2 km and out of which a distance of 43.8 km from 7<sup>th</sup> mile to malayalapuzha lies in Pathanamthitta district.The RTA Pathanamthitta granted concurrence for the fresh permit.The total overlapping on the notified route is 4.7 km and which is less than 5% of the total route length as specified in clause 5(c) of the notification notified under G.O(p) No.42/2009/Trans dated 14.07.2009.Hence fresh permit on the route AYOOR-MALAYALAPUZHA (Via) Pooyappally, Velichikala, Kannanalloor, Kollam, Kundara hospital Jn, Mulavana, Bharanikavu, Kadampanadu, Adoor, Ezhamkulam, Chandanappally, Thazoorkadavu, Pathanamthitta & Kumbazha as (Limited Stop Ordinary Service) is **granted** subject to the settlement of timings.

**Item No.S2****Decision of the Regional Transport Authority, Kollam dated 06.04.2022.**

Heard.The total distance of the proposed route is 47.7 km of which a distance of 5 Km overlaps various notified routes notified under GO(P).No. 42/2009/Trans dated 14.07.2009.The total distance of overlapping is more than 5% of the total route length and hence violate clause 5(c) of notification notified under G.O(p) No.42/2009/Trans dated 14.07.2009.Hence **rejected** the application for fresh regular permit operating on the route Anchal R.O Jn-Kottarakkara via Thadikkadu, Thadikkadu, Kokkadu, Chakkuvarakkal, Melila, Kunnikkodu, Thalavoor, Pattazhy, Arattupuzha, Anthamon, Puthur mukku, Poovattoor, Perumkulam, Pallickal.
