Item No 1.

Heard. This is a request for functioning of the newly built Bus stand at Chapparapadavu Grama Panchayath .Under rule 344 of KMV rule the Regional Transport Authority shall in consultation with the concerned authorities of any Corporation, Muncipality, Panchayath, the Executive Engineer and the Superintendent of Police. Moreover as per the enquiry report there are certainly some limitations in the yard. It is very difficult to turn a bus inside the yard. There is no space in the yard to build stopper devices, bay separators etc. Hence the yard can use only as a Bus bay .So many improvements needed to upgrade the yard as a bus stand. So the Secretary RTA is directed to obtain report from the Executive Engineer ,PWD .Hence **Adjourned Item No 2.**

Heard. This is a request for sanctioning new Bus stop and Auto Stand before the Janakiya Policlinic, Aduthila, Pazhayangadi. As per the enquiry report the proposed Bus stop and auto stand is in between the existing Bus stops and Auto stands at RamaPuram and Aduthila with a distance of 200 meters each. Bus bays are not counstructed. There is also a small slope and curve near the proposed bus stop. Hence **Rejected.**

Item No 3.

Heard. This is a request for sanctioning new Bus stop at Kizhoorkunnu Edakkanam Valliyad road. As per the enquiry report the proposed place for sactioning bus stop is a dangerous curved area and this junction is completely drawn with median marks . The Edakkanam road junction and The Thalassery Valavupara road side is protected

by iron protection wall..It is really a accidental zone. There is no facility to build a bus stop. It is very difficult to other vehicles to overtake a bus at this proposed place So sanctioning a bus stop at this place is not practicable. Hence **Rejected.**

Heard. This is a request to rectify the mistake in the same KMC No issues granted to both the vehicles Numbers namely KL 13 V 9298 and KL 13 T 6445. The Secretary RTA is granted permission to rectify the mistake after hearing the the applicants.

- 2.This is a request for reconsidering the variation of permit and renewal of Permit on the route Pulingom-Kozhikkode via Payyanur , Thaliparamba, Kannur, Thalassery by limiting route length below 140km..The enquiry reveals that by curtailing route portion from Pulingome to Kothayimuku- (37 kms) the total route length becomes 133 kms and the objectionable overlapping of the notified sector before and after variation is same .ie from kothayimukku to Kozhikode is 133km.Hence variation granted subject to the settlement of timings and Renewal of Permit is also granted in the curtailed route.

- 1.Perused the judgment of Hon'ble High Court of Kerala in WP(C) No 26375/2022 dtd 17/08/2022
- 2.This is a request for reconsidering the variation of permit and renewal of Permit on the route Parassinikadave –Kozhikkode- Kanhangad as SF by limiting route length below 140km. The enquiry reveals that by curtailing route portion from Payyannur to Kanhangad ie 35 KM the total route length becomes 134 kms and the objectionable overlapping of the notified sector before variation is 165 kms and after variation is 130 kms. Hence **variation(**limiting route portion from Payyannur to Kanhangad) **granted** as **LSOS** subject to the settlement of timings and **Renewal of Permit is also granted** in the curtailed route.

- 1.Perused the judgment of Hon'ble STAT in M P NO 202/2021 in MVARP No 13/2021
- 2. This is a request for reconsidering the variation of permit and renewal of Permit on the route Kottiyoor ambalam-Kozhikkode via Peravoor, Nedumpoyil , Koothuparamba, Kannur, Vadakara, Koyilandi by limiting route length below 140km. The enquiry reveals that by curtailing route portion from Kottiyoor to Nedumpoyil ie 24 kms the total route length becomes 133 kms and objectionable overlapping of the notified sector before and after the proposed curtailment is same. ie, from Kannur to Kozhikode (90KMS) Hence variation granted subject to the settlement of timings and Renewal of Permit is also granted in the curtailed route .
