Item No.01

Heard. Perused the records. This is an application for the grant of regular permit on the route Perambra – Koyilandy (via) Anjampeedika, Meppayur, Arikkulam, Muthambi, Puravattur as Ordinary service. The introduction of a new service on the route will be beneficial to the travelling public. Hence regular permit as applied for is **granted** as ordinary service subject to settlement of timings.

Item No.02

Heard. Perused the records. This is an application for the grant of regular permit on the route Naduvannur-Perambra-Meppayur Via Thaarammel Mukku, Jana Vayana Club, Ekkattoor, Chathottu Thazhe and Nochad as Ordinary service. The Enquiry Officer has reported that 1.2 Kms of the produced route from Tharammelmukku to Kurudimukku is a virgin portion. Road Fitness certificate for this portion is not seen received. Hence **adjourned** with direction to place the application before the next RTA after obtaining Road Fitness Certificate from the concerned authority.

Item No.3

Heard. Perused the records. This is an application for the grant of Regular permit Kallachi- Panoor as Ordinary service (via) Nadapuram, Parakkadavu, Chettakandipalam, Kallikkandy and Parad. The enquiry report shows that 7.5 Kms of the proposed route lies in Kannur district for which concurrence of the sister RTA is needed and the same is not seen obtained. Hence **adjourned**.

Item No.4

Heard. Perused the records. This is an application for the grant of fresh regular permit on the route Maniyur-Koyilandy (via) Panikotti, Vadakara, Chaniyam kadavu, Muyipoth, Perambra, Arikulam, Muthambi as Ordinary service. On verification of the enquiry report, it is seen that the produced route will be beneficial to the travelling public on the sector. Hence **granted** subject to settlement of timings.

Item No.5

Heard. Perused the records. This is an application for the grant of fresh regular permit on the route Perambra- Koyilandy via Chenoli, Nochad, Ekkattoor, Tharammal, Kurudimukku, Parakulangara, Uralloor, Ottakadam and Muthambi as Ordinary service. The detailed enquiry report on the application shows that the proposed route is intended to be operated an ill-served sectors of the district where there is an increased demand for more travelling facilities. Hence the regular permit is **granted** subject to settlement of timings.

Item No.6

Heard. Perused the records. On verification of the report of the enquiry officer, it is seen that there is an overlapping of 2.2 Kms in the proposed route Thamarassery- Koyilandy via. Old Court Road, Mother marry Hospital, BSNL Jn, Poonoor, Balussery, Ulliyeri which is not permissible as per the existing schemes of notification. Hence **rejected**.
