Decision of the Regional Transport Authority, Kollam dated – 15/02/2023

Heard the applicant, This is an application for the Fresh regular permit on the route **Edamon Sathram- Moonnumukku**. KSRTC objected the grant of this fresh regular permit stating that this route touches Edamon and Punalur two intermediate points in the Kollam – Shencottah complete exclusion scheme ( GO (MS) NO 59371/TA-60-PW dated 19/08/1961). The report of the circle officer in this regard is not specific .Hence **adjourned** regarding the objection of the KSRTC. Hence secretary RTA is directed to obtain a detailed report and place it before the next RTA.
