

**DECISION OF THE REGIONAL TRANSPORT AUTHORITY, THRISSUR**

## **Item No 1**

1) Perused the judgment of the Hon'ble High Court of Kerala dated 20/10/2016 in WP(C) No. 33460/2016.

2) Heard the counsel appearing for the applicant, counsel of KSRTC and other affected parties. This is an application for fresh regular stage carriage permit on the route Kodannur – Nedupuzha – Thrissur – Ayyanthole as ordinary service, filed on 12/02/2016. As per enquiry report of the field officer, the total length of route is 16 Km. Out of which 6 Km, objectionably overlaps with the notified route by violating clause 5 (c) of G O (P) No. 13/2023/Tran dated 03/05/2023. The counsel representing KSRTC vehemently objected to the grant of this permit by violating the above notification.

Hence the application for fresh stage carriage permit is **rejected**.

## **Item No 2**

Heard. This is an application for a reserve bus permit for conducting substitute service in place of regular stage carriages which were already covered by valid permits and owned by the applicant, that too as a temporary measure, when those vehicles were kept off road, but aimed to ensure the travelling facility of the public.

Hence, fresh reserve stage carriage permit as per Rule 182 of KMV Rules 1989 is **granted** to KL 59 C 5500 to conduct substitute services in the following routes,

only when, the respective vehicles owned by the applicant, having valid regular permit/temporary permit are kept off – road, subject to the below mentioned conditions in SRO No. 880/75.

1. The reserve bus shall be used solely for substitute service in place of the regular route stage carriages (route buses) for which the reserve bus is authorized to conduct substitute service and not for any other purpose during the entire quarter; and
2. Tax in respect of all route buses, in place of which the reserve bus is authorized to ply, shall be paid within the prescribed period of the quarter.

3. The reserve stage carriage (reserve bus) shall be used only for 20 days at a time; subject to maximum of 2 months only in any one quarter in place of any one regular route stage carriage (route bus).
4. The reserve bus shall be used only when the regular route stage carriage is kept off the road.

### **Item No 3**

Heard. This is to reconsider the application for renewal of regular permit on the intra district route Vadookkara - Ayyanthole as Ordinary Service valid upto 11.02.2023, in respect of the stage carriage KL 08 AK 4003. Decision on this application was adjourned by this authority in the meeting held on 07.03.2023 vide Supplementary item no. 7, since this permit was originally issued after 09/05/2006 and also the route overlaps for more than 5% of the total route length. Now Govt. of Kerala has come out with latest notification on 03/05/2023 vide G O (P) No. 13/2023/Tran specifying in clause (4) that *"The existing valid regular permits as on 14<sup>th</sup> July 2009, in operation with trips and vehicles of the private stage carriage operators will be permitted to operate as Ordinary Service."* Hence renewal of permit is **granted**, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 4**

Heard. This is to reconsider the application for renewal of regular permit on the intra district route Thrissur - Guruvayur as Ordinary Service valid upto 27.07.2022, in respect of the stage carriage KL 08 AD 4050. Decision on this application was taken as *rejected* by this authority in the meeting held on 17.09.2022 vide Supplementary item no. 5, since this permit was originally issued after 09/05/2006 and also the route overlaps for more than 5% of the total route length. Now Govt. of Kerala has come out with latest notification on 03/05/2023 vide G O (P) No. 13/2023/Tran specifying in clause (4) that *"The existing valid regular permits as on 14<sup>th</sup> July 2009, in operation with trips and vehicles of the private stage carriage operators will be permitted to operate as Ordinary Service."* In view of the notification G O (P) No. 13/2023/Tran dated 03/05/2023, this authority is inclined to modify the decision and hence renewal of permit is **granted**, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 5**

Heard. This is to reconsider the application for renewal of regular permit on the intra district route Kanakkankadavu – Azhikode- Chalakudy as Ordinary Service valid up to 22.11.2022, in respect of the stage carriage KL 06 D 3528. Decision on this application was adjourned by this authority in the meeting held on 07.03.2023 vide Item no. 13 calling for a specific report, since this permit was originally issued after 09/05/2006 and also the enquiry officer reported there was an overlapping of 4 Km, which is more than 5% of the total route length. In the report of enquiry officer dated 27.06.2023, it is revealed that the overlapping is only for a route length of 2.8 Km and the overlapping portion is less than 5% of the total route length and hence not objectionable. This authority is convinced with the specific report and hence renewal of permit is

**granted**, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 6**

Heard all the concerned including the representative of KSRTC. On perusal of records, it is seen that this authority had rejected the application for renewal of permit and replacement of vehicle vide its decision dated 20/10/2012 in Supplementary item no 6. This decision was upheld by Hon'ble STAT in its judgment dated 20/01/2016 in M V A A No. 447/2012.

Challenging the above judgment a writ petition (WPC No. 28720/2016) is seen filed before the Hon'ble High Court of Kerala. This petition is yet to be disposed by the Hon'ble Court. Hence awaiting the final verdict, the decision on the application for renewal of permit is **adjourned**.

### **Item No 7**

Heard. This is an application for renewal of regular permit on the inter district route Kallampara – Thrissur – Thiruvilwamala - Mayannur – Ottapalam valid upto 25.02.2023, in respect of the stage carriage KL 48 151. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G O (P) No. 13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 8**

Heard. This is an application for renewal of regular permit on the intra district route Kuthampully - Kodungallur valid upto 01.07.2023, in respect of the stage carriage KL 11 AX 1476. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G O (P) No. 13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 9**

Heard. This is an application for renewal of regular permit on the inter district route Kodungallur – Ottapalam, Medical College valid upto 24.03.2023, in respect of the stage carriage KL 08 AR 9799. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G O (P) No. 13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 10**

Heard. This is an application for renewal of regular permit on the inter district route Kodungallur - Palakkad valid upto 27.06.2020, in respect of the stage carriage KL 47 B 2710. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G

O (P) No. 13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 11**

Heard. This is an application for renewal of regular permit on the inter district route Eloor Ferry – Kodungallur – Palakkad valid upto 27/06/2023, in respect of stage carriage KL 05 AG 2311. The route enquiry report for the route portion lying in the Thrissur district is not seen received. Secretary, RTA is therefore directed to obtain the report from the concerned enquiry officer and place the application in the next meeting of the RTA. Hence decision on the application for renewal of permit is **adjourned**.

### **Item No 12**

Heard. This is an application for renewal of regular permit on the inter district route Kodungallur - Pathirippala valid upto 28.06.2023, in respect of the stage carriage KL 56 E 5750. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G O (P) No. 13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 13**

Heard. This is an application for renewal of regular permit on the inter district route Veettikunnu School – Panamanna Temple - Ayakurissi as Ordinary Service valid upto 11/11/2022, in respect of the stage carriage KL 48 H 5115. The enquiry officers have reported that overlapping with notified route is not objectionable in the case of renewal of an existing permit. Hence renewal of permit is **granted**, subject to production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 14**

Heard. This is an application for renewal of regular permit on the inter district route Chavakkad - Pattambi as Ordinary Service, valid upto 03/10/2021, in respect of stage carriage KL 46 A 5644. The route enquiry report for the route portion lying in the Thrissur district is not seen received. Secretary, RTA is therefore directed to obtain the report from the concerned enquiry officer and place the application in the next meeting of the RTA. Hence decision on the application for renewal of permit is **adjourned**.

### **Item No 15**

1) Perused the judgment of the Hon'ble High Court of Kerala dated 12.04.2023 in WP(C) No. 12413/2023.

2) Heard. This is an application for variation of permit in respect of the stage carriage KL 48 4478 operating on the route Cherpu West Puthenkulam – Ayyanthole. Applied variation is for curtailment of route portion connecting Thrissur to Ayyanthole of all trips. The variation also

includes rearrangement of whole set of existing settled timings. While the matter was heard, en-route operators raised vehement objections against allowing this variation by pointing out that it will lead to time clashes and cause unhealthy competition among the operators.

Also a passenger's representative submitted that the applied variation will terminate the only direct stage carriage service from Cherpu West Puthenkulam to Ayyanthole causing difficulties to existing passengers solely depending this service to reach Ayyanthole Civil Station. The report of the enquiry officer is not specific on how the change in timings will be beneficial to the travelling public and students.

From the above findings this authority feels that the applied variation will not be beneficial to the travelling public and it will curtail the existing travelling facility of the public who are depending this direct service from Cherpu West Puthenkulam to Ayyanthole. Hence the application for variation of permit is **rejected**.

### **Item No 16**

Heard. This is an application for variation of permit in respect of the stage carriage KL 29 3443 operating on the route Azhikode – Kodungallur – Padanna. The applied variation includes curtailment of the portion Cheraman to Padanna (5 Km) and two extensions from Cheraman to O K Junction (4 Km) and Pay Bazar to Manjalipady (1 Km).

The report of the enquiry officer is not specific about the effects of the proposed curtailment and the benefits of the proposed extension outweighing their comparative advantages. The sufficient data including the frequency of stage carriages on the proposed and curtailed routes are also not mentioned in the report. Hence Secretary is directed to report specifically all the above in detail and resubmit the application. Hence for want of the specific report, **decision on application of variation of permit is adjourned**.

### **Item No 17**

Heard. This is an application for variation of permit in respect of the stage carriage KL 40 3219 operating on the route Vellikulangara – Thrissur – Irinjalakuda – Pulikkakadavu, to change the terminus from Pulikkakadavu to Annamanada by extending the route portion of 400 meter through a bridge. As per report of the enquiry officer, there is no virgin portion. The proposed extension is reported as beneficial to travelling public. Hence **variation of permit is granted** subject to the settlement of timings if any required for the endorsement of variation.

While the matter was heard there was an objection alleging that without obtaining permission from this authority, the permit holder is already operating on the applied varied route. **Secretary shall verify whether the objection is genuine and report to this authority.**

### **Item No 18**

Heard. This is an application for variation of permit in respect of the stage carriage KL 34 A 6391 operating on the route Padanna - Kottapuram. While the matter was considered, there was

objection from the en route operators alleging that the proposed timings in the agenda is not matching with the applied variation. Secretary shall look into the matter and resubmit this application in the ensuing meeting with the correct set of proposed timings as suggested by the enquiry officer. Hence, decision on application of variation of permit is **adjourned**.

### **Item No 19**

Heard. This is an application for variation of permit in respect of the stage carriage KL 48 A 4707 operating on the route Wadakkanchery – Thrissur – Ayyanthole. The variation applied is for curtailment of Karumathra route portion by deviating through Thekkumkara – Thiruvannikkavu route for a single morning trip and an extension to Veerolipadam for another trip. The report of the enquiry officer is not specific in various aspects. Hence Secretary is directed to specifically look into this matter and submit a detailed report before this authority. The report of Secretary shall contain : 1) whether the comparative advantages of extension outweigh the effects of curtailment of trips and comparative merits and demerits of the curtailment and rescheduling of trip through deviated route. 2) whether variation is in accordance with the stipulations set by clause (19) of G O (P) No. 13/2023/Tran dated 03/05/2023. 3) whether the extended portion overlaps with the notified route and the details, if any.

Hence decision on the application for **variation of permit is adjourned**, for want of the compliance of the above directions.

### **Item No 20**

1) Heard. This is an application for renewal of regular permit on the inter district route Thrissur – Perinthalmanna valid upto 01/04/2021, in respect of the stage carriage KL 08 AQ 5099. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G O (P) No. 13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

2) The decision on variation of permit is **adjourned** as per the request of the counsel representing the applicant.

### **Item No 21**

1) Heard. This is an application for renewal of regular permit on the intra district route S N Puram – Irinjalakuda - Chalakudy as Ordinary Service valid upto 11.10.2021, in respect of the stage carriage KL 06 C 6599. This permit was originally issued after 09/05/2006 and also the route overlaps for more than 5% of the total route length. Now Govt. of Kerala has come out with latest notification on 03/05/2023 vide G O (P) No. 13/2023/Tran specifying in clause (4) that *"The existing valid regular permits as on 14<sup>th</sup> July 2009, in operation with trips and vehicles of the private stage carriage operators will be permitted to operate as Ordinary Service."* In view of the notification G O (P) No. 13/2023/Tran dated 03/05/2023, renewal of permit is **granted**, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

2) As per dictum laid down by the Hon'ble High Court of Kerala in Usman vs RTA Malappuram, applications for renewal of permit and replacement cannot be considered simultaneously. The decision on the application for **replacement of vehicle is adjourned** without looking into its merits for considering later by the RTA, after revalidation of the regular permit.

## **Item No 22**

1) Perused the judgment of the Hon'ble High Court of Kerala dated 12.04.2023 in WP(C) No. 12545/2023.

2) Heard the counsel representing the permit holder/petitioner. On perusal of records, it was found that the regular permit in respect of KL 17 7009 was valid upto 16/12/2018. Application for renewal of permit was filed on 30/11/2018. The vehicle was not operational for the past 5 years, though the application for renewal of permit was filed. The reasons for not making the permit operational for the conveyance of travelling public are not seen submitted by the permit holder, even after, notice issued by the Secretary under Rule 152 of KMVR 1989. The applicant was also heard by Secretary on 18/05/2023 as per directions of the Hon'ble High Court of Kerala.

While the matter was heard, there was objection raised by an operator alleging that the vehicle KL 17 7009 is neither in existence nor under the possession of the permit holder. Hence Secretary shall enquire the whereabouts and possession of the vehicle and submit a report before this authority. The applicant is also directed to show cause reasons if any for not making the permit operational for the conveyance of travelling public for a long period of 5 years. Hence, decision on these applications for renewal of permit and replacement of vehicle, are **adjourned**.

## **Item No 23**

Heard. Considering the request of the applicant, the replacement of the stage carriage KL 45 6226 by KL 05 X 7498 is **granted** for making the permit operational, since the permit renewal was already granted by this authority vide decision in item no. 130 dated 07/03/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues and tax of the outgoing vehicle, if any and remittance of application fees, if not paid.

## **Item No 24**

1) Perused the judgment of the Hon'ble STAT in MVAA No. 35/2022 dated 18/05/2022 and the judgment of the Hon'ble High Court of Kerala dated 09/06/2023 in WP(C) No. 14268/2023.

2) Heard the counsel representing the applicant. This is to reconsider the application for renewal of permit in respect of the Stage Carriage KL 08 Y 3950 as per the judgment of the Hon'ble STAT dated 18/05/2022 in MVAA No. 35/2022. As per the decision of this authority dated 24/01/2021 in Supplementary Item No. 1, the above application for renewal of permit was rejected based on Section 51(9)(a)(i). This decision is impugned before the Hon'ble tribunal in MVAA 35/2022.

The operative portion of the judgment reads, “Section 51(a)(a) specifically says that in a case where the financier has refused to issue the certificate applied for, after giving the applicant an opportunity of being heard renew or refuse to renew the permit. Here, the first respondent failed to consider the affidavit filed along with the application for renewal. Without considering that, the first respondent was carried away by the sole reason that the financier refused to issue no objection certificate for renewal and also taken the possession of the vehicle. Hence, the permit is rejected as per the Sec. 51(a)(ai). Consequently, the first respondent rejected the application for replacement also. This was against the spirit of S.51 of the Motor Vehicles Act. This being the situation, I hold that the impugned order was passed without resorting to the legal procedures mentioned in Sec. 51 and Sec. 86 of MV Act and it is liable to be set aside.”

In view of the above findings the Hon’ble Tribunal set aside the above decision of this authority and directed to reconsider the renewal as well as replacement application in accordance with law after hearing all the parties concerned. The point to consider is whether the decision of rejection of the renewal application is by complying the legal procedures mentioned in Sec. 51 and 86 of M V Act 1988.

On perusal of records, it is clear that the application for renewal of permit is filed on 14/12/2017. Along with the application for renewal of permit no NOC from financier was submitted as required under Section 51(6) of M V Act 1988. Also along with application for renewal of permit no mandatory declaration as stipulated in Section 51(8) of MV Act 1988 (in lieu of NOC of financier )was produced.

In the absence of NOC from the financier, or declaration (affidavit) mentioned above, this authority is not in a position to consider the same as directed by Hon’ble STAT in its judgment in MVAA No. 35/2022 dated 18/05/2022. This authority is of the view that all legal procedures stipulated in Section 51 of M V Act 1988 had been followed scrupulously and exercised its discretionary power as mentioned in Section 51(9 (a)(i).

Hence by complying the judgment of Hon’ble Tribunal **the application for renewal of permit is reconsidered and decision taken as rejected.** In the view of the above decision on the application for renewal of permit, **application for replacement of vehicle is also rejected.**

### **Item No 25**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 26**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 27**

1) Perused the judgment of the Hon'ble High Court of Kerala dated 12.01.2018 in WP(C) No. 1320/2018.

2) Heard the counsel representing the applicants. The petitioner, Sri Sarathkumar has acknowledged the notice for the meeting, but not appeared before this authority. Hence assuming that he has no objections to file, transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 28**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 29**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 30**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 31**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 32**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 33**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 34**

Heard, the counsel representing the applicants and the objector. The objection against allowing transfer of permit is filed by Chairman, We-one Kuries (P) Ltd, Thrissur . On perusal of records the vehicle is not under any agreement of hypothecation, hire purchase or lease. No prohibitory order refraining this authority from considering this application in favour of the applicants is produced by the objector. Hence by overruling the objection, transfer of permit is

**allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 35**

Heard. The decision on the application for transfer of permit **is adjourned**, for want of revalidation of the permit .

### **Item No 36**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 37**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Item No 38**

Secretary RTA shall watch the service of stage carriages as mentioned above and a feasibility report along with the recommendations from Police Authorities shall be submitted before this authority for finalization of the decision.

2) The decision on the application for **replacement of vehicle is adjourned** for want of revalidation of the regular permit.

On perusal of records, it is seen that the permit is valid upto 25/02/2028. The applicant surrendered the original permit on 24/04/2023 intimating his inability to continue the stage carriage service. Hence as per Rule 183 of Kerala Motor Vehicle Rules 1989, the **surrender of the permit is accepted** with effect from 24.04.2023

Secretary shall **cancel the permit** and issue proceedings subject to clearance of arrear of Motor vehicle tax, Govt. dues if any and production of NOC from financier, if applicable.

### **Item No 145**

Heard. Considered the request of Secretary, RTA Palakkad (Vide Endt. No. J1/53/2023/P dtd 11.05.2023) for the concurrence of this Regional Transport Authority for fresh regular permit in respect of a suitable stage carriage on the route Thiruvilwamala – Palakkad Stadium Bus Stand for the portion of the route from Thottumukku to Thiruvilwamala (7.2 Kms) which falls within the jurisdiction of this authority. Hence, ***concurrence for fresh regular permit for the route portion from Thottumukku to Thiruvilwamala is granted***, without prejudice to the right of the Regional Transport Authority, Palakkad to peruse other aspects and to decide on the application for fresh regular permit.

Heard. This is an application for renewal of regular permit on the inter district route Elanad - Palakkad valid upto 08.05.2023, in respect of the stage carriage KL 48 1011. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G O (P) No.

13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Supplementary Item No 4**

Heard. This is an application for renewal of regular permit on the inter district route Kodungalloor - Perinthalmanna valid upto 18.05.2022, in respect of the stage carriage KL 45 C 6060. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G O (P) No. 13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Supplementary Item No 5**

Heard. This is an application for renewal of regular permit on the inter district route Kodungallur - Perinthalmanna valid upto 25/09/2022, in respect of stage carriage KL 08 AQ 2025. Renewal of permit is **granted** as Ordinary Service as per stipulations in clause (4) of Notification G O (P) No. 13/2023/Tran dated 03/05/2023, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Supplementary Item No 6**

Heard. This is an application for variation of permit in respect of the stage carriage KL 45 L 9423 operating on the route Chathakkudam - Thrissur. The variation applied is for an extension of route from Chathakkudam to Palakkal via Cherucheri, Anakallu (8.5Km). Vehement objections were raised by the en route operators that though the route length from Chathakkudam to Anakallu is 10km, the proposed time is not sufficient to cover the running distance.

Hence enquiry shall be conducted through officer regarding the feasibility of the running time proposed by the applicant. The verified and approved set of timings obtained from the officer may be placed before this authority for reconsidering this application.

Hence decision on the application for **variation of permit is adjourned.**

### **Supplementary Item No 7**

Heard. This is an application for variation of permit in respect of the stage carriage KL 45 A 4041 operating on the route Marottichal Church- Ayyanthole. The variation applied is for curtailment of a trip to Vellanikode at Kallor to deviate via Chemmanakandam and Bharatha, and extension of a trip from Marottichal to Mannamangalam St. Sebastian's School (Cutting). No existing set of timings is mentioned in the agenda. The report of the enquiry officer is also not specific in various aspects. Hence Secretary is directed to conduct a specific enquiry on the variation application and submit a detailed report including the comparative advantages and the frequency of stage carriages on the variation applied route, along with a neat route sketch

Hence decision on the application for **variation of permit is adjourned**, for want of the compliance of the above directions.

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Supplementary Item No 9**

### **Supplementary Item No 10**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Supplementary Item No 11**

Heard. Transfer of permit **allowed**, subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

### **Supplementary Item No 12**

Applicant is absent. Hence decision on application for renewal of permit and transfer of permit (death) are **adjourned**. Secretary, RTA is directed to place the application in the next meeting of the RTA, after issuing due notice to the applicant without fail.

### **Supplementary Item No 13**

1) Perused the judgment of the Hon'ble High Court of Kerala dated 26/05/2023 in RP No. 497/2023 in WP(C) No. 40245/2022.

2) Heard. The applicant had cleared the arrears of KL 05 P 824, and had produced the records of the incoming vehicle KL 08 AJ 2244. The vehicle covered by the permit has attained 20 years of age as on 17/06/2023, set for Ordinary Service stage carriages. Due to the age restriction, the vehicle KL 05 P 824 has become unsuitable for operation and was laid up under continuous Form G. On 16/10/2021, an application for replacement of vehicle is filed with later model stage carriage KL 08 AJ 2244, owned by the permit holder himself and there is no material difference. Hence **replacement of vehicle is allowed** with direction to the Secretary to endorse the granted renewal of permit, subject to the production of NOC from financier, if applicable, clearance of Govt. dues if any and remittance of application fees, if not paid.

### **Supplementary Item No 14**

1) Heard. The applicant failed to avail the granted renewal of permit even after one year from the date of communication of the decision of grant of renewal of permit. Hence the request

for allowing maximum time for producing current records is not maintainable as per Kerala Motor Vehicle Rule 172 (3). Hence **request for allowing maximum time for producing current records of the vehicle is rejected.**

2) In view of the above decision and since there is no valid permit, **the application for replacement is not maintainable and disposed as infructuous.**

Decision on this request is **adjourned** for want of a detailed report of Traffic Authority and concerned Road Authority on the institution of bus stop at Kattungachira in front of Office of the Superintendent of Police. Secretary is directed to submit the report in the ensuing meeting of RTA , after issuing due notices to all the concerned without fail.

### **Supplementary Item No 18**

This is a belated application for renewal of permit in respect of auto rickshaw KL 08 AL 7339. Permit in respect of this vehicle is seen expired on 03/08/2022. Belated application for renewal of permit received on 24/06/2023. This authority is convinced that the applicant is prevented by good and sufficient reasons from making the application for renewal of permit in time. Hence delay condoned, renewal of permit is **granted**, from the date of application subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid. If it is revealed on the enquiry that the vehicle had conducted service after the expiry of permit, compounding fees shall be levied for permit less operation.

### **Supplementary Item No 19**

This is a belated application for renewal of permit in respect of auto rickshaw KL 64 1838. Permit in respect of this vehicle is seen expired on 15/02/2022. Belated application for renewal of permit received on 27/04/2023. This authority is convinced that the applicant is prevented by good and sufficient reasons from making the application for renewal of permit in time due to his health related issues. Hence delay condoned, renewal of permit is **granted**, from the date of application subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid. If it is revealed on the enquiry that the

vehicle had conducted service after the expiry of permit, compounding fees shall be levied for permit less operation.

### **Supplementary Item No 20**

This is a belated application for renewal of permit in respect of auto rickshaw KL 08 AX 774. Permit in respect of this vehicle is seen expired on 07/05/2022. Belated application for renewal of permit received on 21/06/2023. This authority is convinced that the applicant is prevented by good and sufficient reasons from making the application for renewal of permit in time due to his health related issues. Hence delay condoned, renewal of permit is **granted**, from the date of application subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid. If it is revealed on the enquiry that the vehicle had conducted service after the expiry of permit, compounding fees shall be levied for permit less operation.

### **Supplementary Item No 21**

This is a belated application for renewal of permit in respect of auto rickshaw KL 24 F 469. Permit in respect of this vehicle is seen expired on 29/05/2022. Belated application for renewal of permit received on 16/06/2023. This authority is convinced that the applicant is prevented by good and sufficient reasons from making the application for renewal of permit in time due to his health related issues. Hence delay condoned, renewal of permit is **granted**, from the date of application subject to the production of NOC from the financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid. If it is revealed on the enquiry that the vehicle had conducted service after the expiry of permit, compounding fees shall be levied for permit less operation.
