DECISION OF REGIONAL TRANPORT AUTHORITY VATAKARA DATED 21.08.2023

Item No: 1

Heard. This is an application for fresh regular stage carriage permit on the Inter district route Kallachi- Panoor (via) Nadapuram, Perode, Parakkadavu. Chttakandipalam, Kallikkandy and Parad as Ordinary service. It was earlier considered by this authority on 22.11.2022 vide item No.3, and adjourned on the ground that the concurrence of the sister RTA is needed and the same is not seen obtained. Now the concurrence obtained by the sister RTA Kannur held on 07.03.2023 vide item No.4. Hence regular permit as ordinary service is granted subject to settlement of timings & production of current records of suitable vehicle with in one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Item No.2

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Puthiyakavumukku- Nanminda Via. Kinaloor Estate, Govt. College, Balussery, Kurumpoil, Vattoli Bazar, Kariyathankavu, Arapeedika as Ordinary service. It was earlier considered by this authority on 11.04.2023 vide item No.9, adjourned for Road fitness certificate from the concerned authority since the route portion from Puthiyakavumukku to Rarothumukku 1 Km is virgin portion. Now the Secretary, RTA reported that the road fitness certificate obtained from concerned authority. **Hence regular permit as ordinary service is granted** subject to settlement of timings & production of current records of suitable vehicle with in one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Item No: 3

Heard. This is an application for fresh regular stage carriage permit on the intra -district route Sand Bank -Thottilpalam (Via) Vatakara, Pazhamkavu Junction, Malolmukku, Vykkilassery, Nadapuram, Kuttiadi. It was earlier considered by this authority on 11.04.2023 vide item No.13, adjourned with a direction to the Secretary, RTA to clarify the intermediates points overlap the nationalized sector on the route Vatakara – Thottilpalam. The Field Officer, RTO Vatakara categorically reported that the applied route is from Vatakara – Thottilpalam is through Vatakara, Pazhamkavu, Malolmukku, Vykilassery, Orkkatteri, Nadapuram, Kuttiadi. Based on the detailed report there is no objectionable overlapping in the notified portion. There is no serious objection against this proposal. Hence regular permit as ordinary service is granted subject to settlement of timings & production of current records of suitable vehicle with in one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Item No.4

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Muthukad- Chakkittappara (via) Peruvannamuzhi, Perambra, Chembra and Thanikandi as ordinary service. Perused the connected file and the enquiry reports of the field officer. The majority of trips proposed by the applicant are in the well served sector Perambra-Chakkittappara. Muythukad is a ill served area. Only one single trip is provided in the proposal. Hence, the applicant is directed to submit a modified set of timing proposal, providing even number of trips to Muthukad. On receipt of such a proposal from the applicant, the secretary, shall conduct an enquiry regarding its feasibility and place the matter before this authority for reconsideration. For the compliance of the above directions, the decision on the application is adjourned.

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Balussery – Vatakara Via. Manjapalam, Kootalida, Moolad, Chalikkara, Muyipoth, Thodannur. The enquiry officer reported that the portion from Vatakara - Perambra- Chakkittappara is a well served sector and Chalikkara to Baluyssery via. Kootalida is a moderately served sector. During the meeting enroute operators objected the proposal since the proposal badly affect their service. From the above facts, this authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors of Balussery-Perambra- Vatakara region and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Hence the application for fresh regular stage carriage permit is rejected.

Item No.6

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Vatakara –Payyoli Via. Thodannur, Elambilad, Maniyioor, Attakundupalam, Keezhur. The enquiry Officer reported that the proposed route from Vatakara to Thodannur and Keezhur to Payyoli are well served sectors. From the above reasons, this authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors of Payyoli- Vatakara region and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. *Hence the application for fresh regular stage carriage permit is rejected*.

Item No.7

Heard. This is an application for fresh regular stage carriage permit on the Intra-district route Perambra- Vatakara via. Payyoli, Muyipoth, Chaniyamkadavu, Palachuvad. The enquiry Officer reported that the proposed route from Perambra- Vatakara and Palachuvadu – Payyoli are well served sector. This authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors of Perambra- Vatakara region and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Hence the application for fresh regular stage carriage permit is rejected.

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Perambra-Koyilandy via. Chenoli, Nochad, Ekkattur, Tharammal, Kurudimukku, Parakulangara, Ottakandam, Naduvannur, Muthambi. The enquiry Officer reported that the proposed route is through interior and ill served areas lying between Perambra and Koyilandy touching Naduvannur. Proposed route provides connectivity with Koyilandy, Naduvannur and Perambra towns. Inhabitants of the proposed route depend on these towns for their day to day things. Considering the nature of the road, only LMV buses can be operated. There is no serious objections received against this proposal. Hence regular permit as ordinary service is granted with the condition that vehicle should be LMV subject to settlement of timings & production of current records of suitable vehicle within one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Item No.9

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Perambra-Parakulangara(Via) Chenoli, Nochad, Ekkattur, Tharammalangadi, Kurudimukku. On verification, it is found that the major focus of operation of the applicant is on the sector Perambra – Kurudimukku. Only two trip to Parakulangra. Only two trips are offered to Parakulangara. The Field officer reported that the route from Kurudimukku to parambath for a distance of 0.500 Kms the route passes through a relatively well served sector. During the meeting Bus operators Association objected the proposal. The primary preference of the applicant may lead to the severe and undesirable competition among the fellow operators and may result in traffic congestion and cause accidents, jeopardizing the safety and convenience of the general public. For the above reasons, the application for fresh regular stage carriage permit is rejected.

Heard. This is an application for fresh regular stage carriage permit on the route Pasukkadavu-Perambra Via Maruthomkara, Kuttiadi, Valakettu, Koolikunnu, Peruvayal, Palliyath, Avala, Pannimukku. Report of the enquiry officer reveals that majority of the trips are focus on Pasukkadavu - Maruthomkara-Kuttiadi sector. The only one single trip is provided to both Peruvayal and Palliyath. Paruval and Palliyath are comparatively ill served area than Pasukkadavu and Maruthomkara. This authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors of Pasukkadavu-Kuttiadi region and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. Hence the application for fresh regular stage carriage permit is rejected.

Item No.11

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Palliyath - Kuttiady (Via) Estate Road, Manjakunipally, Krichyakam School Road, Velam H.S, Valakettu, Neelechukunnu. This authority examined the connected file and verified the enquiry reports of the field officer. The enquiry Officer reported that the proposed route Palliyath- Kuttiadi Via. Manimala, Velam route passes through ill served interior areasof Kozhikode Dist. This route will be highly beneficial to the people living in this ill served area and benefit the tourist travelling to and from the newly started Kids Park Active Planet at Manimala. Presently there is no stage carriage operating on the major portion of the route. The MVI recommended LMV vehicle on the proposed route. There is no serious objections received against this proposal. Hence regular permit as ordinary service is granted with the condition that vehicle should be LMV subject to settlement of timings & production of current records of suitable vehicle within one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Applicant is absent while the matter is considered. Hence decision of the application for fresh regular stage carriage permit is **adjourned**. Secretary, RTA shall place the application in the next meeting of RTA after receiving the due notice to the applicant indicating the date, time and venue of the meeting.

Item No.13

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Vatakara-Payyoli (Via) Panikotty, Thurasserimukku, Maniyoor, Attakundupalam, Keezhur. Perused the connected file and verified the enquiry reports of the field officer. The enquiry report reveals that the proposed route from Vatakara – Panikotti and Kizhur –Payyoli are well served sectors. This authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. Hence the application for fresh regular stage carriage permit is rejected.

Item No.14

Applicant is absent while the matter is considered. Hence decision of the application for fresh regular stage carriage permit is **adjourned**. Secretary, RTA shall place the application in the next meeting of RTA after receiving the due notice to the applicant indicating the date, time and venue of the meeting.

Item No.15

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Kumbalachola- Parakkadavu(Via) Kakkattil, Nadapuram. This authority examined the connected file and verified the enquiry reports of the field officer. The enquiry reveals that the Parakkadavu to Nadapauram and from Kakkattil-Kumbalachola via. Kaiveli are ill-served sectors. There is no serious objections received against this proposal.

Hence regular permit as ordinary service is granted subject to settlement of timings & production of current records of suitable vehicle within one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Payyoli - Vatakara (Via) Keezhur, Thurasserimukku, Palayadnada, Panikkotty, Bank Road, Kurumthodi. This authority examined the connected file and verified the enquiry reports of the field officer. The proposed route from Vatakara - Panikotti and Kizhur -Payyoli are well served sectors. This authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. Hence the application for fresh regular stage carriage permit is reject

Item No.17

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Koyilandy-Korapra (via) Muthambi, Naduvathur, Nidumpoyil and Kurumayilthazha. The Field Officer reported that the proposed route is through interior and ill served areas lying between Koyilandy and Korapra and Koyilandy and Nidumpoyil. Proposed route provides connectivity for the inhabitants of the ill served areas with Koyilandy town. Koyilandy to Muthambiis having buses in 10 to 15 minutes frequency. Considering the nature of the road, only LMV buses can be operated. Hence regular permit as ordinary service is granted with the condition that vehicle should be LMV subject to settlement of timings & production of current records of suitable vehicle within one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Item No.18

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Balussery- Naduvanur(via) Manjapalam, Palolimukku, Koottalida, Balussery HS, Kannadipoyil, Poonath. The Field Officer reported that the proposed route connects so many remote areas which are ill served. There is no overlapping with notified route/approved scheme in this proposal. The introduction of new permit through rural areas enrich the strength of public transport system and highly beneficial to the travelling public and students. Hence regular permit as ordinary service is granted subject to settlement of timings & production of current records of suitable vehicle within one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Koyilandy-Perambra (via) muthambi, Uralloor, Parankulangara, Kurudimukku, Ekkattoor and Chathoththazha as Ordinary service. The Field Officer reported that the proposed route is through interior and ill served areas lying between Koyilandy and Perambra providing connectivity with Muthambi, Uralloor, Paramkulngara, Parambath, Kurudimukku, Tharammal, Ekkattur, Chathoththazhe and Novchad. Inhabitants of the interior areas of the proposed route depend on Perambra and Koyilandy Towns. No overlapping on the notified routes. Considering the nature of the road, only LMV buses can be operated. *Hence regular permit as ordinary service is granted with the condition that vehicle should be LMV subject to settlement of timings & production of current records of suitable vehicle within one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Item No.20

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Koorachundu- Perambra-Payyoli (via) Koderichal, Chembra, Meppayoor. Perused the connected file and verified the enquiry reports of the field officer. The Field officer reported that the route portion Perambra – Payyoli is well served sector. This authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. Hence the application for fresh regular stage carriage permit is rejected.

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Perambra-Koyilandy-Meppayur-Ulloorkadavu (via)Kannoor Bazar, Koyilandy, Arikulam, Anchampeedika, Kollam, Narakode. The Field officer reported that there is an objectionable overlapping as per G.O (P)No.42/2009/Tran dtd 14/7/2009 (Modified as per G.O(P) 13/2023/TRANS dtd 03.05.2023). Hence application for fresh regular stage carriage permit is rejected.

Item No.22

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Kannur Bazar-Meppayur (via)Ulliyeri, Naduvannur, Kavumthara, Kurudimukku, Narakkode. The Field officer reported that the applicants intension is to operate most of the trips from Naduvannur to Meppayur. During the meeting severe objection raised from the enroute operators. This authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. Hence the application for fresh regular stage carriage permit is rejected.

Item No.23

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Villiappally- Vadakara-Perambra (via) Thodannoor, Thiruvalloor, Chaniyamkadavu- Muyipoth. The field officer reported that the proposed route from Villiappally-Vadakara and Vadakara-Perambra are well served sectors. This authority is of the view that granting this permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. Hence the application for fresh regular stage carriage permit is rejected.

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Koyilandy- Puliyanchery LP School- Hill Bazaar (via) Anakkulam, Koyilothumpadi, Ottu Company, Kodakkattumuri and PuliyancheriPalli as Ordinary service. This authority examined the connected file and verified the enquiry reports of the field officer. Portion of the route from Koyilandy to Aanakkulam (2.7km) overlaps notified routes. Permissible overlapping as per route length is 490 meters only. Hence overlapping is objectionable as per G. O(P)No.42/2009/Tran dtd 14/7/2009 (Modified as per G.O.(P) 13/2023/TRANS dtd 03.05.2023. Hence the application for fresh regular stage carriage permit is rejected.

Item No.25

Heard. This is an application for fresh regular stage carriage permit on the intra-district route Estatemukku- Kattippara via. Ekarool, Iyyad, Kariyathankavu, Vattolo Bazar, nanminda, Kurumpoil, Kinaloor, Usha School, Balussery as Ordinary service. The Field Officer reported that the proposed route connects so many remote areas which is ill served. The Introduction of new permit through rural areas enrich the strength of public transport system and highly beneficial to the travelling public and students. Hence regular permit as ordinary service is granted subject to settlement of timings& production of current records of suitable vehicle within one month from the date of receipt of this decision failing which sanction will be revoked without further notice.

Item No.26

Heard. This is an application for fresh regular stage carriage permit in respect of stage carriage KL15 6509 to operate on the intra district route Vadakara-Panikotti-Elambilad-Menmunda-Gugamukku-Ayancherri-Kuttiadi-Perambra-Ulliyerri-Atholli. The permit is **granted** as applied for in respect of KL 15 6509 with the proposed timings.

Item No:27

Heard. This is an application for regular variation of permit in respect of S/C KL-58-B-909 permitted to operate on the inter district route Thottilpalam - Thalassery Via. Kuttiadi, Nadapuram, Perngathur, Chokli, Saidarpally .Down trip from Thalassery to Temple via. Manjodi. Variation applied for all trips (up and down trips) via. Manjodi on the route Thottilpalam- Thalassery. This authority is of the view that granting this variation of permit will lead to unhealthy competition between the en route operators and traffic congestion at Manjodi, which in turn will harmfully affect the travelling public as well as other road users. RTA Kannur held on20.09.2007 vide item No. 75(1)(other item)restricted to allowing variation of permits curtailing Temple Gate and Saidarpally. Hence the application for variation of permit is rejected.

Item No. 28

Heard. This is an application for regular variation of permit in respect of S/C KL-56-R-2996 permitted to operate on the route Mankayam- Meppayur Via. Naduvannur, Ulliyeri, Kinaloor, Vattoli Bazar, Manjapalam, Kottaramukku, Kurudimukk and Vakayad. Variation applied for extension of route from Naduvannur to Kootalida via. Kottur. Perused the connected file and verified the enquiry reports of the field officer. The enquiry report reveals that the working hours of the driver and crew are more than 15 hours, which violates Sec. 91 of MV Act of 1988. Also the extension from Naduvannur to Kootalida will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. *Hence the application for variation of permit is rejected*.

Item No. 29

Heard. This is an application for regular variation of permit in respect of S/C KL-18 R 2457 permitted to operate on the route Thalasserry – Kozhikode as LSOS Via. Saidarpally, Peringathur, Nadapauram, Kayakdei, Thaleekkara, Kuttiadi, Perambra return trip Via. Manjodi. Variation applied for curtailment of two single trips from Kuttiadi to Nadapuram. The enquiry report reveals that the intension of the applicant is to alter the entire time schedule. Hence the application is not to be considered as a variation but to be treated as a new permit U/s 80(3). And the MVI also reported that there is no urgent necessity as per KMVR 145(6) for considering the proposed

variation. This authority is of the view that granting this variation of permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. For the above reasons, application for variation of permit is rejected.

Item No.30

Heard. This is an application for regular variation of permit in respect of S/C KL-76-A-2632 to operate on the route Vakayad- Kozhikode Medical College via Naduvannur, Ulliyeri, Atholi, Pavangad, Kozhikode. Variation applied for reduction of two round trips from Vakayad to Naduvannur. This authority examined the connected file and verified the enquiry reports of the field officer. The Field officer reported that the curtailment of trips between Ulliveri and Vakayad will affect the general travelling public and especially students. Curtailment is on ill served sector. In the existing route Pavangad Kms overlaps notified routes to Kozhikode 7 as per (P) No.42/2009/Trans Dt. 14.07.2009 (Modified as No.13/2013/Trans Dt. 03.05.2023 permit on the Vakayad -Kozhikode Medical College route is a saved permit. As per G.O (P) No.13/2013/Trans Dt. 03.05.2023 variation on saved permit is not permissible. Existing timings and proposal timings on the Kozhikode -Medical College sector is not uniform. The proposed curtailment will be highly disadvantageous to travelling public. For the above reasons, application for variation of permit is rejected.

Item No.31

Heard. This is an application for regular variation of permit in respect of S/C KL-58 K4108 permitted to operate on the route Theekkuni-Kozhikode via. Poomukam, Vadayam, Kuttiadi, Perambra, Ulliyeri, Atholi, Pavangad. Variation applied for extension from Kozhikode to Kozhikode Medical College 2 single trip. The Enquiry Officer reported that the proposed extension of the route Theekkuni-Kuttiadi-Kozhikode to Medical College is beneficial to people living in remote inaccessible and ill-served interior areas of Kozhikode district. Patients accessing Kozhikode Medical College from these remote areas are presently constrained to change buses for reaching Kozhikode Medical College. In order to find a solution to this issue the Hon'ble MLA of Kuttiadi Sri. K P KunhammadkuttyMaster has recommended the extension of the morning trip of this existing

route. Various Medical College staff residing enroute, who have to reach the Medical College in time will find this route extension beneficial. The general reporting time for staff at Kozhikode Medical College is 7.30am. So introduction of this extension will benefit both the patients as well as the Medical College staff. Hence the application for variation of permit is granted.

Item No.32

Heard. This is an application for regular variation of permit in respect of S/C KL-18 K 7475 to operate on the route Pasukadavu- Perambra (via) Kuttiyadi, Thottilpalam, MullanKunnu, Adukath, Maruthonkara Road and Kadiyangad as Ordinary service. Variation applied for 1) Curtailment of route portion from Kuttiyadi to Thottilpalam and Kuttiyadi to Nadapuram.2) One round trip add from Pasukkadavu to Kuttiyadi. The Field officer reported that the proposed route Pasukadavu- Kuttiyadi route passes through ill served interior areas of Kozhikode district. The proposal time shows that early morning two trips from Pasukkadavu are curtailed. From this, it is clear that the applicant hide the curtailment on the ill served sector Pasukkadavu. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. For the above reasons, the application for variation of permit is rejected.

Item No.33

Heard. This is an application for regular variation of permit in respect of S/C KL-10 AE 7206 to operate on the route Ulloorkkadvu -Ezhukudikkal Beach - Meppayur (via) Kannoor Bazar, Koyilandy, Kollam and Nelliyadi as Ordinary service. Variation applied for 1)3Round trip from Koyilandy to Ezhukudikkal(via) Market road, Ice Plant, Ezhukudikkal Bridge-extension 5.5 km.2) Two round trip curtailment from Koyilandy to Eazhukudikkal via Madakkara-curtailment 5.5km. This authority examined the connected file and verified the enquiry reports of the field officer. The Field officer reported that curtailment of all existing trips on the Koyilandy-Eazhukudikkal sector (via) Arangadath, Madakkara and Kavalad which will affect travelling public and students. The existing and proposed timings suggested by the applicant and the details of variation requested in P V A Form are not tallying and the application itself a vague. Since the permit is saved one, as per G.O (P) 14/07/2009 No.42/2009 Trans dtd (Modified (P)No.13/2023/Trans dtd 03.05.2023 variation is not permissible. For the above reasons, the application for variation of permit is rejected.

Item No:34

Heard. This is anapplication for regular variation of permit in respect of S/C KL 12 C 9117 permitted to operate on the route Vatakara-Iringannur(via) Kainatty, Orkkattery, Puthiyangadi as Ordinary Service for

- 1) Change of halting place form Vatakara to Iringannur.
- 2) Reduction of one single trip from Vatakara to Iringannur 6.55 PM, morning trip starting from Iringannur at 6.25 AM. This authority examined the connected file and verified the enquiry reports of the field officer. The Field officer reported that the proposed variation is violation of section 80(3) of MV Act 1988 as the halting place is interchanged and there exist no urgent necessity as per KMVR 145(6). Based on the fact that Vatakara to Edachery is a well served sector and remaining portion is moderately served. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. For the above reasons, the application for variation of permit is rejected.

Item No: 35

Heard. This is anapplication for regular variation of permit in respect of S/C KL 56 L 9797 with permit No 18/57/1997 permitted to operate on the route Chuzhali-Koyilandy (via) Nadapuram, Vatakara as Ordinary Service for

1) Addition of one round trip from Nadapuram-Chuzhali and Chuzhali -Nadapuram. 2) Curtail the portion from Vatakara-Koyilandy. This authority examined the connected file and verified the enquiry reports of the field officer. The Field officer reported that, after the curtailment total length of the route is reduced to 28 Kms. So the permissible overlapping on the nationalized sector is 1.5 Kms. The route after variation is objectionable as modified G.O.(P) No.13/2013 dtd 03.05.2023. The variation result an addition of trip at 12.03 pm from Vatakara to Chuzhali. This route portion from Vatakara to Nadapuaram is a well served saturated route. This authority is of the view that granting this variation of permit will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. For the above reasons, application for variation of permit is rejected.

Heard. This is an application for renewal of regular permit on the intra district route Vatakara –Kozhikode valid up to 29.11.2021 in respect of the stage carriage KL 56 A 4464. The vehicle financed with IKF Finance Ltd, 40-1-444, 3rd Floor, Corporate Centre, Labbipet, Vijayawada 999999. The registered owner informed that the financier is not issued Form 35 without any reason. He had informed that he paid full amount of Loan. In this regard the registered owner sent a letter to the financier requesting NOC. The Secretary, RTA reported that the registered owner produced the details of the above letter. The Secretary, RTA also sent a notice to the financier, calling to file any objection if any within 7 days of receipt of the letter. The financier acknowledged the letter and not responded till date.

Vide letter C!/22837/TC/2015 Dtd 4.12.2015, has issued a direction as follows. As per the Sec.51 of M V Act 1988, the registered owner shall obtain NO Objection Certificate from the financier if the vehicle is subject to hire purchase, lease or hypothecation agreement before applying for renewal of permit, for issue of Duplicate Certificate of Registration etc. But if the company is closed down without intimating the client, he cannot cancel the hypothecation of his vehicle or he cannot obtain any service connected with his vehicle. In such cases registered owner may be directed to send letter to the finance company by registered post with acknowledgement due. If the letter is returned un served, the same may be included alomng with the application for revocation of hire purchase, lease or hypothecation agreement. After this steps shall be taken to close hypothecation after obtaining an undertaking from the registered owner of the vehicle stating that if any liability will arouse with regard to the agreement, it will be undertaken by the applicant. The registering authority/Additional registering authority shall note the details of such letters in the remarks of the hypothecation cancellation data base.

Hence this authority **granted the renewal of permit**, obtaining an undertaking from the registered owner of the vehicle stating that if any liability will arouse with regard to the agreement, it will be undertaken by the applicant and subject to the clearance of government dues if any .

Heard. This is an application for renewal of regular permit on the intra district route Vilangad - Vatakara - Kozhikode (Via) Nadapuram, Kainatty, Koyilandy As LSOS valid up to 14.12.2022 in respect of the stage carriage KL 18 K 1512. Since the State government had published the final notification and modified the scheme of nationalisation of routes, the applicant is not eligible for getting a permit to conduct limited stop ordinary service. Hence request is denied. The applicant is permitted to conduct only ordinary service on the intra district route Vilangad-Kozhikode. **Renewal of permit is granted as Ordinary Service**, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

Item No.38

Heard. This is an application for renewal of regular permit on the intra district route Poozhithode - Kozhikode (VIA)Peruvannamuzhi, Kadiyangad, Perambra, Ulliyeri, Atholi as LSOS valid up to 01.11.2022 in respect of the stage carriage KL 47 F 3699. Since the State government had published the final notification and modified the scheme of nationalisation of routes, the applicant is not eligible for getting a permit to conduct limited stop ordinary service. Hence request is denied. The applicant is permitted to conduct only ordinary service on the intra district route Poozhithode-Kozhikode. **Renewal of permit is granted as Ordinary Service**, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

Item No.39

Heard. This is an application for renewal of regular permit on the intra district route Kozhikode – Vilangad Via. Atholi, Perambra, Kuttiadi, Kallachi, Vanimel as LSOS valid up to 28.06.2023 in respect of the stage carriage KL 18 W 3251. Since the State government had published the final notification and modified the scheme of nationalisation of routes, the applicant is not eligible for getting a permit to conduct limited stop ordinary service. Hence request is denied. The applicant is permitted to conduct only ordinary service on the intra district route Kozhikode- Vilangad. **Renewal of permit is granted as Ordinary Service**, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

Heard. This is an application for renewal of regular permit on the intra district route Kozhikode-Perambra-Kuttiadi (Via) Atholi, Ulliyeri And Balussery as LSOS valid up to 27.01.2023 in respect of the stage carriage KL 56 D 1017. Since the State government had published the final notification and modified the scheme of nationalisation of routes, the applicant is not eligible for getting a permit to conduct limited stop ordinary service. Hence request is denied. The applicant is permitted to conduct only ordinary service on the intra district route Kozhikode-Perambra-Kuttiadi Renewal of permit is granted as Ordinary Service, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

Item No.41

Heard. This is an application for renewal of regular permit on the intra district route Thottilpalam-Kozhikode (Via) Kuttiady Perambra-Ulliyeri-Atholi as LSOS valid up to 07.07.2023 in respect of the stage carriage KL 18 K 9045. Since the State government had published the final notification and modified the scheme of nationalisation of routes, the applicant is not eligible for getting a permit to conduct limited stop ordinary service. Hence request is denied. The applicant is permitted to conduct only ordinary service on the intra district route Thottilpalam -Kozhikode (Via) Kuttiady Perambra-Ulliyeri-Atholi. *Renewal of permit is granted as Ordinary Service*, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any and remittance of application fees, if not paid.

Item No.42

Heard, this is to consider the belated application for renewal of stage carriage permit in respect of S/C KL-58-AH-6031 permitted to operate on the inter district route Kannur- Kozhikode as LSOS. The regular permit valid up to 15.10.2022 and permit renewal application received from the applicant on 29.04.2023 after expiry of the permit. On perusal of records, this authority is convinced that the applicant was prevented by good and sufficient reason from filing the application within the stipulated time as per section 81(2). The delay occurred in submitting the application is condoned. Since the State government had published the final notification and modified the scheme of nationalisation of routes, the applicant is not eligible for getting a permit to conduct limited stop ordinary service. Hence request is denied. The applicant is permitted to conduct only ordinary service on the inter district route Kannur - Kozhikode. Renewal of permit is granted as Ordinary Service, subject to the production of NOC from financier, if applicable, clearance of Govt. dues, if any, remittance of Rs. 7500-/ as a compounding fee or obtaining the service verification report and remittance of application fees, if not paid. Secretary RTA is permitted to endorse renewal from the date of application for renewal.

Heard. This is an applications for renewal of regular permit No.18/381/2003 valid up to 29.10.2018 in respect of S/C KL 18 L 1221 (Leased vehicle) to operate on the route inter district route Mullankunnu – Thalassery (via) Thottilpalam, Kuttiadi as ordinary service for a further period of 5 years from 30.10.2018. This authority examined the connected file. The existing route bus S/c KL 18 L 1221 is a leased vehicle since 26.09.2018. Lease agreement expired on 25.09.2019. The vehicle is not operating since 01.10.2018 onwards. Now this application is considering almost after 5 years of expiry of permit. The applicant fails to submit any valid reason for not operating the vehicle. During the meeting severe objections received against the renewal of regular permit since the existing time of the vehicle is allotted to other vehicle. Hence this authority views that grant of this permit. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. Hence application for renewal of permit is rejected.

Item No.44

Heard. These are applications for renewal, transfer of permit on account of the death of the permit holder, and replacement of permit in respect of S/C KL 18 2101 permitted to operate on the intra district route Vatakara – Kuttiadi, Thanneerpanthal, Katameri, Kainatty, Orkkatteri, Nadapuram Road, Villiappally - Mahepalam as OS with permit No.18/116/2001. This authority examined the connected file. The validity of permit is seen expired on 17.12.2021. Application for renewal of permit is filed almost after 1 ½ years of expiry. This is contrary to Sec. 81(2) of MV Act 1988. The legal heir is not submitted any valid reason to substantiate the inordinate delay on his part in submitting renewal application within the stipulated time as per MV Act. The applied route Vatakara – Mahepalam is a nationalized sector. The Age of the vehicle attained 20 years on 31.12.2022. For the above reason,

- A) Renewal of permit is rejected.
- B) In view of the decision (A) above, the subsequent transfer of permit on account of the death of the permit holder, and replacement of permit applications are all dismissed as in fructuous.

Heard.Perused. From these curtailments the permit holder limits the route length below 140 Kms (130 Kms).

This authority considered this matter earlier and adjourned for the finalization of scheme. On perusing the application, enquiry report and objections the authority is of the view that the curtailment is on the ill served sector Chombala Harbour (2) trips badly affect the travelling public especially students of that area. The introduction of new trips on the well served notified sector will unsettle the present state of equilibrium of timings prevailing among the stage carriage operators in the well served sectors and may lead to unhealthy competition between the en route operators and cause traffic congestion, which in turn will harmfully affect the travelling public as well as other road users. Also settling timings amicably, avoiding time clashes with existing operators will be and extremely difficult task. The observation of the MVI (the proposed variation violates the Sec 80(3) of the MV Act 1988, as the halting place is being inter changed without any urgent necessity as per KMVR 145(6) also to be considered. The report of the enquiry officer reveals that 1) curtailment of Valayam to Kokkri via. Thanimukku, Chuzhali and from Valayam to Vatakara, an ill served sectors and remote areas, will affect adversely on the travelling public on these sectors. 2) The interchange of halting place a violation of Sec 80(3) of M.V Act 1988. 3) There is no urgent necessity as per KMV R 145(6). During the meeting severe objection received against the variation since the curtailment are on ill served remote areas. Moreover the intension of the applicant is to alter the entire time schedule and the application not to be considered as a variation but to be treated as a fresh permit under Sec 80 (3). Also the proposed variation of additional trip on the notified route from Vatakara to Kainatti is violates clause 19 of G.O. (P) No.42/2009/Trans dated 14.07.2009. (Modified as per G.O (P) No.13/2013/Trans Dt. 03.05.2023). In view of the above application for variation of permit is rejected
