ITEM NO.1 Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O.D.Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that distance of overlaping is within the permissible limit of 5% of the total route length which is 4.43%. Hence it is not objectionable. KSRTC and others objected only the proposed timings and concurrence received from RTA Kolam. Considering the above facts the fresh regular permit on the inter-district route Varkala Temple - Kadakkal is here by **granted** Subject to settlement of timings.

ITEM NO.2 Decision of the Regional Transport Authority, Attingal[Rural] Dated 10.10.2023

Heard, Adv. O.D.Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that there is no objectionable overlapping on the nationalised route. KSRTC and others objected only the proposed timings. Considering the above facts the fresh regular permit on the intra-district route Thoppil junction - Kilimanoor private bus stand is hereby **granted** subject to settlement of timings.

ITEM NO.3 Decision of the Regional Transport Authority, Attingal[Rural] Dated 10.10.2023

Heard, Adv. O.D Sivadas, the learned counsel represented the applicant. The secretary of RTA has reported that no objectionable overlapping on the nationalized routes. KSRTC, and others objected only the proposed timings and concurrence received from RTA Kolam. Considering the above facts the fresh regular permit on the inter - district route Kilimanoor- Paripally ESI is hereby **granted** subject to settlement of timings.

ITEM NO.4 Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O.D. Sivadas, the learned counsel represented the applicant. The secretary RTA has reported that total overlapping on the nationalized route is 500 meter which is less than 5% of the total route length which is 3.84% of the total route length. Hence it is not objectionable. But the place vakkom private bus stand is not approved by the secretary RTA Board due to the violation of rule 334(2) (a) of KMV Act. Hence the fresh permit application on the intra-district Akathumuri- Attingal is here by submit the application with the proposed timings with Vakkam as passing time.

ITEM NO.5 Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O.D. Sivadas, the learned counsel represented the applicant. The secretary RTA has reported that the total overlapping on the nationalized routes is only 500 meter which is 4.67% of the total route length. KSRTC objected only the proposed timings. Considering the above facts the fresh regular permit on the intra district Thennoor - Kallara is granted subject to settlement of timings.

ITEM NO.6 Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O.D. Sivadas, the learned counsel represented the applicant. The secretary RTA has reported that the total overlapping on the nationalized route is 1.4 Kms which is 4.46% of the total route length. But KSRTC strongly objected that the Pazhakutty Temple junction to Vengavila 1.4 Kms overlaps Trivandrum City and Moffussil scheme (Modified) vide Notification GO(P)No.107/94/PW/T dated 24/11/1994 with complete exclusion scheme cantonment - Nedumangad via Ulloor area scheme. Hence the fresh regular permit on the route Pangode L P S junction - Pazhakutty Temple junction is here by Rejected.

ITEM NO.7 Decision of the Regional Transport Authority, Attingal[Rural] Dated 10.10.2023

Heard, Adv. O.D. Sivadas, the learned counsel represented the applicant. The secretary RTA has reported that the total overlapping on the nationalized route is 400 meter which is 3.78% of the total route length. Hence the fresh regular permit on the intra- district route Koranikadakkavoor (Chakkalavilakam junction) is hereby granted subject to settlement of timings.

ITEM NO.8

Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O.D. Sivadas, the learned counsel represented the applicant. The secretary RTA has reported that objectionable overlapping on nationalized routes are 500 meter from Attingal to Kacherynada and another distance of 2.1 Kms from Puthenchanda to Varkala objectionably overlaps the which Trivandrum - Plakkadu and Trivandrum - Varkala notified routes. Total overlapping on the nationalized route is 2.6 Kms which is 8.99% of the total route length. This is clear violation of G.O(P) No 8/2017/Trans dated 23/03/2017. Hence the fresh regular permit on intra-

ITEM NO.11 Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O.D.Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that there is no objectionable overlapping on the nationalized route. KSRTC and Others objected only the proposed timings. Hence the fresh regular permit on the intra district route Kallingumugham-Kusavoor is here by **granted** subject to settlement of timings.

ITEM NO.12 Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that this is a fresh permit application. The route has a virgin portion from Palode PHC junction to Kappippara link road, Chellanchi Junction to Parappil Junction and Thengumcode to Muthuvila Link Road Junction. There is a newly constructed bridge at Chellanchipalam, where fitness certificate obtained from PWD authorities only for bridge. But no fitness certificate produced for the approach road. Hence the fresh permit application on the intra - district from concerned authorities.

Considering the above facts the fresh regular permit on the intra-district route Kallambalam- Kochupalam Private bus stand(Kilimanoor) is hereby **granted** subject to settlement of timings.

Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O D Sivadas,, the learned counsel represented the applicant. The Secretary RTA has reported that there is no objectionable overlapping on the nationalized route. KSRTC objected only the proposed timings. Hence the fresh regular permit application on the intra-district route Kusavoor- kallingumukku is hereby **granted** subject to settlement of timings.

ITEM NO.16

Decision of the Regional Transport Authority, Attingal[Rural] Dated 10.10.2023

Heard, Adv. O D Sivadas the learned counsel represented the applicant. The Secretary RTA has reported that this is an inter - district route permit where 2 Kms lies in kollam district. The route overlaps a distance of 800 meter from mukkada to parippally on the notified routes Trivandrum - Palakkadu which is 2.5% of the total route length which is in the permissible limit. But concurrence from RTA, Kollam is not received so far. Hence the fresh permit application on the inter-district route is adjourned for want of concurrence from Secretary RTA Kollam and place the matter next RTA.

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that a distance of 200 meter from Attingal private Bus stand to Nalumukku overlaps Trivandrum - Palakkad, Trivandrum-Kannur notified routes vide notification No.42/Trans/2009 dated 14/07/2009 which is 1.53% of the route length which is in the permissible limit. Hence the fresh permit application on the intra-district route Vamanapuram- Attingal is hereby **granted** subject to settlement of timings.

ITEM NO.18

Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that any extention, curtailment or deviation of existing permit will adversely affect the travelling public and moreover, permit variation on the existing route shall be considered as a fresh permit application. A distance of 500 meter from Chirayinkeezh to Valiayakada and another distance of 4.5 Kms from Attingal to Chathampara overlaps many notified routes. So this is a violation of GO (P) No.42/Trans/2009 dated 14/07/2009. The total overlapping is 5 Kms which is 12% of the total route length. Hence the variation of permit application is hereby **rejected**.

ITEM NO.19 Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that curtailment of last trip will adversely affect the existing travelling public and adding one full trip starts at 12.08 PM will affect other operators of the enroute and it will create unhealthy competition and time clash. Hence the variation of permit application is hereby **rejected**.

ITEM NO.20 Decision of the Regional Transport Authority, Attingal[Rural] Dated 10.10.2023

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that variation of permit shall be considered as a fresh permit application and it will adversely affect the existing travelling public. Moreover in this case termini also changed, which is violation of section 80(3) of the MV Act -1988. A distance of 500 meter from Kusavoor to Forest range office junction and another distance of 600 overlaps the Trivandrum - Kottarakkara notified scheme which is violation of GO(P) No 42/Trans/2009 dated 14/07/2009. Hence the variation of permit application on the route Kusavoor-Kallara is hereby **rejected**.

Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that curtailment of the route portion (8 Kms) from Attingal to Chirayinkeezh will adversely affect the existing travelling public. Several objections received from residence of Manamboor village, kalluvathukkal gramapanchayath and from Paravoor municipality against the trip curtailment. Variation on the existing route shall be considered as fresh permit application. Moreover a distance of 500 meter from Attingal private bus stand to Kacherinada , 1 Km from Varkala railway station to Varkala, 3.7 Kms from Palachira to Varkala, and 800 meter from Mukkada to Parippally overlaps Trivandrum -Varkala, Trivandrum-Palakkadu, notified routes. Total overlapping is 6 Kms which is 13% of total route length. So it is violation of GO(P)No.42/Trans/2009 dated 14/07/2009. Hence the variation of permit application on the inter-district route is hereby **rejected**.

ITEM NO.22

Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that curtailment of 10 Kms from Puthanchanda to Kadakkavoor on the second trip will adversely affect the travelling public. Moreover any extention, curtailment or deviation of permit shall be considered as fresh permit application. A distance of 2.8 Kms from Puthanchantha to Varkala and another distance of of 800 meter from Mukkada to Parippally objectionably overlaps Trivandrum – Varkala and Trivandrum – Palakkadu notified routes. Total overlapping 3.6 Kms which is 6.2% of the total route length. Hence the variation of permit application on the inter-district route is hereby **rejected**.

ITEM NO.23 Decision of the Regional Transport Authority, Attingal [Rural] Dated 10.10.2023

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that this renewal of permit application was adjourned by the RTA dated 05/04/2022 in item No 14 for want of route modification to curtail the route portion from Puthenpalam to Bankmukku to avoid the overlapping on notified scheme vide GO(P)No.107/94/PW and T dated 24/11/1994 of KSRTC (Area scheme). But the permit holder yet not applied the modified route. This is **not a saved permit** which was issued after 14/07/2009. Hence the renewal of permit application is **rejected** and direct the applicant to apply for Fresh permit with new a set of proposed timings and to remit the prescribed fee.

<u>Decision of the Regional Transport Authority, Attingal[Rural] Dated</u> 10.10.2023

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that this renewal of permit application was adjourned by the RTA dated 27/03/2023 in item No 08 since a clerical mistake occured in typing the route. This **permit is not in the saved category** which was issued after 14/07/2009. A distance of 500 meter from Kacherinada to Attingal Private Bus Stand and another distance of 2.1 Kms from Puthenchanta to Varkala overlaps Trivandrum- Palakkad, Trivandrum- Kannur and Trivandrum - Varkala notified routes. Total overlapping is 2.6 Kms which is 9.05 % of the total route length. So grant of this permit is the violation of clause 5(C) of notification vide GO(P)No.42/Trans/2009 dated 14/07/2009. Hence the application for renewal of permit on the intra-district route Palachira- Attingal is hereby **rejected**.

ITEM NO.25

<u>Decision of the Regional Transport Authority, Attingal[Rural] Dated</u> 10.10.2023

Heard, the applicant. The Secretary RTA has reported that this is renewal of permit application. This permit was issued after 14/07/2009, which is **not in the saved permit category**. This route has no objectionable overlapping on notified routes. No application from STU is pending. Hence the renewal of permit application is **granted** subject to the production of current records.

ITEM NO.26

Decision of the Regional Transport Authority, Attingal[Rural] Dated 10.10.2023

Heard, the authorized signatory Sri.Santhoshkumar represented by the applicant. Peruse the judgement in MVAA No.34/2010 of honorable STAT Eranakulam dated 31/05/2014. The Hon'ble State Transport Appellate Tribunal set aside the decision of RTA dated 21/10/2009 and remanded the matter for fresh consideration. The secretary RTA has reported that this is a multiple agenda for renewal of permit, transfer of permit (death) and for replacement of the vehicle. KSRTC only objected the renewal of permit application. But this **is a saved permit**, primarily issued prior to 14/07/2009 (28/06/1997) and it is inter-district route permit and concurrence received from RTA Kollam. STU yet not applied for fresh permit on this route. But on detailed examination the applications for renewal since 27/06/2002 is not clear. Secreatary RTA should examine the file whether applications for renewal were timely submitted since 27/06/2002 and should place the matter in the very next RTA. Hence **adjourned**. Issue temporary permit four months to the applicant for conducting service on the route.

ITEM NO.27

Heard, Adv. O D Sivadas, the learned counsel represented the applicant. The Secretary RTA has reported that the renewal of permit application rejected by the RTA on 24/01/2017 vide item No 30 as scheme violation. Now the route operates with four month temporary permit u/s 214(2) of MV Act. Several letters were sent to Hon. STAT, Eranakulam to obtain the present status of the case (MVAA No.80/2017), but no reply yet not received. Moreover the route portion of 500 meters from Attingal to Kacherinada and scheme. This **permit is not in the saved category**, which issued after 14/07/2009. Total overlapping is 1 Km which is 14.92% of the total route length. Considering all the above facts the four month temporary permit application u/s 214(2) of MV Act is hereby **rejected**.
