Item No. : 01

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of suitable stage carriage on the route **Puthanambalam – Ambalapuzha Temple Jn** via Muhamma, Mangalapuram, Ambalamukk, Asramam, Alappuzha Railway Station, Thriveni, Kuthirappanthu, Punnapra Harbor, Vandanam and Vyasa Jn for 5 years. Regular permit **granted** for a period of 5 years subject to settlement of timings and fare stages suggested by Secretary, RTA. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

Item No. : 02

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of stage carriage KL 34/6859 on the route **MCH Vandanam – Chellanam** Via NSS Karayogam, Kuthirappanthu Alappuzha Railway Station, General Hospital Jn, Alappuzha Private Bus Stand, Mararikulam, Kanichukulangara, Arthunkal, Thaickal Beach, Ottamassery, Arattuvazhy, Andhakaranazhi, Pallithode for 5 years. Which was adjourned by this authority on 24.01.2024 for specific report about the route length of the notified route. Further enquiry report from MVI, Alappuzha 1.9 kms overlaps on the notified route, which is permissible as per GO(P) No.13/2023/Trans dtd. 03.05.2023. Hence Regular permit **granted** for a period of 5 years subject to settlement of timings and fare stages suggested by Secretary, RTA. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

Item No. : 03

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of suitable stage carriage on the route **MCH Vandanam – Thaickal Beach** via NSS Karayogam, Kuthirappanthu, Alappuzha Railway Station, General Hospital Jn, Alappuzha

Private Bus Stand, Mararikulam, Kanichukulangara, Arthunkal for 5 years. Which was adjourned by this authority on 24.01.2024 for specific report about the route length of the notified route. Further enquiry report from MVI, Alappuzha 1.6 kms overlaps on the notified route, which is permissible as per GO(P) No.13/2023/Trans dtd. 03.05.2023. Hence Regular permit **granted** for a period of 5 years subject to settlement of timings and fare stages suggested by Secretary, RTA. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

Item No. : 04

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of suitable stage carriage on the route **Ochira DB - Chengannur** Via Choonad, Thamarakkulam, Charummood, Mamkamkuzhy, Kollakadavu, Puliyoor for 5 years. This is an inter district route. On 28.06.2024 RTA Kollam granted concurrence for the route portion from Ochira to Premier Junction for a distance of 0.5 Km. Hence Regular permit **granted** for a period of 5 years subject to settlement of timings and fare stages suggested by Secretary, RTA. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

Item No. : 05

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Sasthamkotta - Chengannur** Via Bharanikkavu, Chakkuvally, Thamarakkulam, Charummood, Mankamkuzhi, Kollakadavu and Puliyoor for 5 years. This is an inter district route. On 28.06.2024 RTA Kollam granted concurrence for the route portion from Sasthamkotta to Vayyamkara for a distance of 12.2 Kms. Hence Regular permit **granted** for a period of 5 years subject to settlement of timings and fare stages suggested by Secretary, RTA. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

Item No. : 06

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Cherthala - Tripunithura** Via Chenganda, Pallichanda, Makkekavala, Poochakkal, Thaliyaparambu, Veeramangalam, Perumbalam, Kattupuram, Vaduthala, Aroor Temple, Kumbalam, Kundannoor, Maradu, Mini bypass, Vadakkekotta and Petta for 5 years. This is an inter district route. Total distance of the route is 53 Kms, in which 13 Kms lies in Eranakulam district. Secretary RTA is directed to seek concurrence from RTA Eranakulam. Hence **adjourned**.

Item No. : 07

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Thykkattussery – Alappuzha Railway Station** Via Pallichanda, Thavanakkadavu, Cherthala Pvt Stand, Manaveli, Puthenambalam, Muhamma, Puthenkavala, Asramam, Out Post for 5 years. As per the report, total route length is 50.5 kms and total overlapping is 3.11 kms. As per GO(P) No.13/2023/Trans dtd. 03.05.2023 the maximum permissible overlapping is 5% of the route length or 5 kms whichever is less. In this case the overlapping is more than 5% of the total route length. Hence **rejected**.

Heard the learned counsel represented the applicant. This is an inter district route. Total distance of the route is 31.1 Kms, in which 0.37 Kms lies in Eranakulam district. Secretary RTA is directed to seek concurrence from RTA Eranakulam. Hence **adjourned**.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of stage carriage KL 61 G 4060 or a suitable stage carriage on the route **Chengannur Pvt Bus Stand - Bharanicavu Pvt Bus Stand** via Puliyoor, Cheriyanad, Kollakadavu, Kochalummoodu, Mankamkuzhy, Chunakkara, Charummoodu, Thamarakkulam, Anayadi, Chakkuvalli for 5 years. This is an inter district route. Total distance of the route is 34.5 Kms, in which 9.8 Kms from Vayyankara Kalungu to Bharanikkavu Pvt Bus Stand lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Kollam. Hence **adjourned**.

Item No. : 10

This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Cherthala – Kalavur** Via Kuruppankulangara, Areeparambu, Kanichukulangara, Mararikulam, Perumana, Korthussery for 5 years. The applicant or learned counsel not appeared before this authority. Hence **adjourned**.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Chengannur Govt. Hospital Jn - Veeyapuram** Via Perissery Kurussummoodu, Puthentheruvu, Marthoma Church, Pandanad

Illimala Jn, Parumala Church, Parumala Kadavu Mannar, Koratty Temple, Pavookkara, Vallakali for 5 years. This is an inter district route. Total distance of the route is 22.9 Kms, in which 2.8 Kms from Illimala Bridge to Parumala Church Bridge lies in Pathanamthitta district. Secretary RTA is directed to seek concurrence from RTA Pathanamthitta. Hence **adjourned**.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **South Chellanam - MCH Vandanam** Via Pallithode, Andhakaranazhi, Ottamassery, Thyckal Beach, Arthunkal, Kattoor, Malikamukku, Mattanchery Bridge, Vazhichery Bridge, Alappuzha Private Bus stand, PH Bridge South Jn., Civil Station, Valiyakulam, Kuthirapanthi, Panachuvadu, Punnapra Beach, Poomeen Pozhi, Madhavan Mukku for 5 years. This is an inter district route. Total distance of the route is 57.92 Kms, in which 22.2 Kms from South Chellanam to Vathuruthy lies in Eranakulam district. Secretary RTA is directed to seek concurrence from RTA Eranakulam. Hence **adjourned**.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Vandanam MCH - Mithrakari Thandassery Kadavu (Jeemangalam)** Via Neerkunnam, SN Jn, Kanjipadam, Champakulam, Kandankary, Odakkal, Kalangara, Mithrakari for 5 years. As per the report of MVI, Edathua Police Station to Vettuthode Bridge overlaps partial exclusion scheme of Thiruvalla - Thakazhy notified route Notification No.G.O.5117/TB3/74/PW dtd.08.07.1976. The report is not specific. Secretary RTA is directed to specify whether permit can be issued to private operators on the portions of above route. Hence **adjourned**.

This is an inter district route. Total distance of the route is 32 Kms, in which 10 Kms from Vayyankara Bridge DB to Bharanikavu lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Kollam. Hence **adjourned**.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Thottappally - Karunagappally** Via Thrikkunnappuzha, Arattupuzha, Valiyazheekal, Azheekal, Cheriyaazheekal, Panickerkadavu, Lalaji for 5 years. This is an inter district route. Total distance of the route is 41.2 Kms, in which 16.4 Kms lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Kollam. Hence **adjourned**.

This is an inter district route. Total distance of the route is 41.2 Kms, in which 16.4 Kms lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Kollam. Heard the learned counsel represented the applicant. This is an inter district route. Total distance of the route is 32.8 Kms, in which 8 Kms lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Kollam. Hence **adjourned**.

This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Charummoodu - Adoor Pvt Bus Stand** via Holy Cross, HS Junction, Lifeline, Pazhakulam, Adikkatukulangara, Pathamkutti, Pallimukku, Nooranad, Para, ITBP, KCM, Parayankulam for 5 years. This is an inter district route. Total distance of the route is 16.4 Kms, in which 8 Kms from Adoor Pvt Bus Bay to Bhavadasan Mukku lies in Pathanamthitta district. Secretary RTA is directed to seek concurrence from RTA Pathanamthitta. Hence **adjourned**.

Item No. : 27

Heard the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Adoor Pvt Bus Stand - Kayamkulam Pvt Bus Stand** via Holy Cross, HS Junction, Lifeline, Pazhakulam, Adikkatukulangara, Nooranad, Para, Charummoodu, Vetticode, Kattanam, Moonnamkutty, Kuttitheruvu, Kayamkulam Railway Station for 5 years. This is an inter district route. Total distance of the route is 29.8 Kms, in which 8 Kms from Adoor Pvt Bus Bay to Bhavadasan Mukku lies in

Pathanamthitta district. Secretary RTA is directed to seek concurrence from RTA Pathanamthitta. Hence **adjourned**.

Regular permit **granted** for a period of 5 years subject to settlement of timings and fare stages suggested by Secretary, RTA. The grantee is directed to produce the current records of the vehicle within one month from the date of communication, otherwise the sanction will be revoked.

Secretary RTA is directed to seek concurrence from RTA Pathanamthitta. Hence **adjourned**.

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Adoor Pvt Bus Stand - Ochira Temple** Via Holy Cross, HS Junction, Chennampalli, Lifeline, Asankalungu, Pathamkutti, Pallimukku, Nooranad, Para, ITBP, KCM, Parayankulam, Charummoodu, Thamarakkulam, Kanjirathummoodu, Padayanivattom, Puthenchanda, Choonad, Kairalimukku, Ochira for 5 years. This is an inter district route. Total distance of the route is 34.5 Kms, in which 6 Kms lies in Pathanamthitta district and 0.5 Km lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Pathanamthitta and RTA, Kollam. Hence **adjourned**.

Item No. : 31

Heard the learned counsel represented the applicant. This is an application for the grant of fresh regular permit in respect of a suitable stage carriage on the route **Adoor Pvt Bus Stand - Bharanikavu** via Adoor Central, Holy Cross, HS Junction, Lifeline, Pazhakulam, Adikkatukulangara, Nooranad, Para, Charummoodu, Thamarakkulam, Anayadi, Sooranad, Chakkuvally for 5 years. This is an inter district route. Total distance of the route is 35.5 Kms, in which 11.3 Kms lies in Pathanamthitta district and 10 Kms lies in Kollam district. Secretary RTA is directed to seek concurrence from RTA Pathanamthitta and RTA, Kollam. Hence **adjourned**.

Item No. 32

Heard the learned counsel represented the applicant. Perused the judgment of Hon'ble High Court in WP(C) No. 21574/2024 dated 25.06.2024. This is an application for reconsideration of variation of regular permit in respect of stage carriage KL-38-E-8661 conducting service on the route **Kanichukulangara – Ernakulam – Kaloor (LSOS)** by curtailing two trips from Kanichukulangara to Cherthala and for the continued service of this stage carriage to Kaloor bus stand. This authority earlier granted the renewal of this permit limiting the service up to Vytilla mobility hub as per the decision of RTA Ernakulam on 07.09.2011. This decision was challenged before Hon'ble STAT in MVAA No 28/2022. The Hon'ble tribunal in MVAA No. 2655/2024 dated 02.11.2024 allowed the operation of this stage carriage up to Kaloor bus stand for two months from 02.11.2024.

The report of enquiry officer favours the curtailment application. Hence curtailment **granted** subject to settlement of timings as ordinary service.

The appellate tribunal allowed the operation of this stage carriage up to Kaloor bus stand in its interim order and the case is posted on 02.01.2025. Secretary RTA is directed to watch the final Judgment of Hon'ble Tribunal.

Item No. 33

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL 04 U 2244 on the route Parumala Church - Chengannur via Budhanoor, Puliyoore by an additional trip between Parumala Church - Chengannur. Additional trip **granted** subject to settlement of timings.

Item No. 34

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL 09 T 2430 on the route Pullukulangara - Thiruvalla via Pipe Jn, Koottamvathukkal Bridge, Vadakke Anjilimode, Kamalalayam Jn, Kayamkulam KSRTC Jn, Chettikulangara, Thattarambalam Mavelikara, Mannar, Parumala, Podiyadi and Kavumbhagam by curtailing two trips from Mavelikara to Pullukulangara. Variation of regular permit **granted** subject to settlement of timings.

Item No. 35

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL 24 C 6465 on the route Kayamkulam - Changanassery, via Chettikulangara, Mavelikara, Mannar, Azhiyidathchira, Idinjillam As Mallapally – Kayamkulam,

Changanassery, Kunnanathanam, Paippad, Paipad Kizhakken Muthoor, Marthoma College Jn, Thiruvalla and return (via) Marthoma College Jn, Muthoor, Kavumbhagam, Mannar and Mavelikara one round trip, Paippad - Kayamkulam via Kizhakkan Muthoor, Marthoma College Jn, Thiruvalla and return(via) Marthoma College Jn, Muthoor Kavumbhagam Mannar and Mavelikara one cut trip and Changanassery Kayamkulam, (via) Idinjilam, Azhiyidathchira, Kavumbhagam Mannar and Mavelikara one round trip.

The report of the enquiry officer is not specific with respect to 80(3). Hence Secretary RTA is directed to submit a specific report in this regard.

The variation sought for lies both in Kottayam and Pathanamthitta district. Hence Secretary RTA is directed to seek concurrence from RTA Kottayam and RTA Pathanamthitta. Hence **adjourned**.

Item No. 36

Heard the learned counsel represented the applicant. Pursued the judgement of Hon'ble High Court in WP(C) No.16616 of 2024 dtd 30.04.2024 This is an application for variation of regular permit in respect of stage carriage KL 29 K 5573 on the route Parakkode - KV Jetty, Ezhamkulam, Anandapally, Thumpamon, Pandalam, Edappon, Mankamkuzhy, Mavelikara, Muttam, Nangiarkulangara, Harippad by curtailing the portion of the route from Anandapally to Parakkode and for the deviation of the route from Anandapally to Adoor New PBS via MG Road, RD office Jn, Parthasarathy Temple Jn, Vattatharapady. The enquiry officer reported that the curtailment will not affect the travelling passengers. These stretches have enough private stage carriages and the deviation is beneficial to the travelling public and students since the route is not served by enough state carriages. The enquiry officer reported that 100 mtrs overlaps from one way end to Parthassarathy Junction on Kayamkulam - Punaloor and Kayamkulam - Kulathupuzha partial exclusion scheme. The authority is of the view that this is an inevitable overlapping to reach a private stage carriage to it's stand. Hence curtailment from Anandapally to Parakkode and deviation of the route from Anandapally to Adoor New PBS is **granted** subject to settlement of timings and subject to counter signature of RTA, Pathanamthitta.

Item No. 37

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL 29 M 5962 on the route Thrikkunnappuzha - Ayaparamb Pandu via Pulikkezhu, Alumukku, Manikandanchira, kumarapuram, Danapady, Block Office

Mannarassala, Harippad, Kuttimukku by adding extra two trips in the existing route. Additional trip **granted** subject to settlement of timings.

Item No. 38

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL 32 G 8199 on the route Erathode - Pathanamthitta via Harippad, Mavelikara, Mankamkuzhy, Pandalam and Kaippattoor by extending the route to Mannarasala Temple. Extension of service up to Mannarasala Temple **granted** subject to settlement of timings.

Item No. 39

Heard the learned counsel represented the applicant. This is an application for variation of regular permit in respect of stage carriage KL 33 C 4417 on the route Bharanikav - Pathanamthitta, Chakkuvally, Thamarakulam, Charumode, Mankamkuzhy, Kollakadav, Puliyoor, Chengannur, Aranmula, Thekkemala, Kozhanchery and Elanthur by 5 minute halt at Charumode on a single trip starting from Pathanamthitta at 11.00 am towards Bharanikav. Heard the learned counsel represented the applicant. As per Kerala Motor Vehicles Rules 174(2)(C) Regional Transport Authority may in its discretion reject the application if the new vehicle proposed is older than the one sought to be replaced.

Hon'ble Supreme Court in Civil Appeal Nos.1453-1454 of 2022 arising out of SLP (Civil) Nos.13834-13835 of 2018 examined the above Rule petitions in detail and observed that Rule 174(2)(C) of Kerala Motor Vehicles Rules is intra vires the provisions of the Act and also Section 83 of Motor Vehicles Act.

In this application the vehicle proposed or the incoming vehicle is a 2004 model vehicle and the vehicle proposed to be replaced or the outgoing vehicle is a 2006 model vehicle. So this authority is of the view that such a replacement if allowed, will be against the provisions of Kerala Motor Vehicles Rules 174(2)(C) read with Section 83 of Motor Vehicles Act and the observations of

Hon'ble Supreme Court in Civil Appeal Nos.1453-1454 of 2022. Hence the application for replacement of stage carriage KL 11 Y 2424 by KL 23 1314 is **rejected**.

Heard the learned counsel represented the applicant. This is an application for renewal of regular permit in respect of stage carriage KL 32 A 2232 conducting service on the route Pallithode - Vyttila (Via) Thuravoor - Vayalar Cherthala - Chenganda - Thavanakkadavu - Poochakkal - Perumbalam and Arookkutty for a further period of 5 years w.e.f. 29.06.2021. This permit was issued prior to 14.07.2009 and is a long standing permit. Perused the file, HP exists and NOC from financier produced. This is an inter district permit and concurrence is not needed. This is a belated application and request for delay condonation accepted. KSRTC has raised no objection regarding the renewal. STU has not filed any application on this route. Hence the renewal of regular permit in respect of stage carriage KL 32 A 2232 conducting service on the route Pallithode - Vyttila (Via) Thuravoor - Vayalar Cherthala - Chenganda - Thavanakkadavu - Poochakkal - Perumbalam and Arookkutty is **granted** for a further period of 5 years w.e.f. 29.06.2021 subject to the clearance of all government dues if any.

This permit was issued on 03.11.2012 ie, after the date of publication of the notification GO(P) No. 42/2009/Trans dtd. 14.07.2009 and GO(P) No. 08/2017/Trans dtd. 23.03.2017. Perused the file, HP exists and NOC from financier not produced. Hence **adjourned** for want of NOC from financier.

A distance of 7.20 Km from Kayamkulam to Kattanam overlaps these schemes, a distance of 0.70 Km from ONK junction to Kayamkulam overlaps on Thiruvananthapuram - Palakkad scheme vide notification No. 25275/B/66/PW dtd.26.08.1966 and a distance of 12.8 Km from Mavelikara to Kochalumode overlaps on the scheme Alleppey-Thiruvalla and Alleppey-Chengannur vide notification No. TB-2/20781/57/PW dtd 22.05.1958 and Kaipattoor to Pathanamthitta on the scheme Quilon-Pampa GO(MS) 144/67/PW dtd 20.07.1967. A distance of 900 mts from Kayamkulam KSRTC Jn to Police Station Jn overlaps these schemes, a distance of 700 mts from ONK Junction to Kayamkulam KSRTC Jn overlaps on Trivandrum - Palghat route objectionably in Notification No. GO (p) 42/2009/Trans dtd. 14.07.2009, a distance of 9.5 Km from Kayamkulam to Thattarambalam overlaps on Kayamkulam - Harippad via Thattarambalam route in complete exclusion with exception clause Notification No 62408/60/TA4 dtd 23.11.1960 since the route directly connects three intermediate points Bhagavathipadi, Chettikulangara and Thattarambalam, a distance of 2 km from Thattarambalam to Mavelikara overlaps on Alleppey - Thiruvalla via Mannar Notification No. GO(P) 42/2009/Trans dtd. 14.07.2009 and a distance of 1.1 KM from Kochalumoodu to Kollakkadav under Notification No. GO(p) No 42/2009/Trans dtd 14.07.2009. This is the request of Secretary, RTA Kottayam for prior concurrence of this authority for the grant of fresh regular permit in respect of stage carriage KL 35 F 4290 or a suitable stage carriage to operate on the route Cherthala – Kuruppanthara via Varanad – Thanneermukkam - Bund Road – Edayazham - Kallara and Manvettom as ordinary service for the portion lying under the jurisdiction of RTA Alappuzha. Hence concurrence is **granted** subject to the effect of Clause 5(c) of Notification No. 42/2009/Trans dtd. 14.07.2009 and 08/2017/Trans dtd. 23.03.2017 without prejudice to the right of the primary authority.

A distance of 1.2 kms from Aroor Temple to Aroor Church (Alappuzha Dist.) overlaps Trivandrum – Palakkad Partial Exclusion Scheme vide GO(P) No.42/2009 Trans dtd. 14/07/2009 and GO(P) No. 13/2023/Trans dtd. 03/05/2023. Hence concurrence is **granted** subject to the effect of Clause 5(c) of Notification No. 42/2009/Trans dtd. 14.07.2009 and 08/2017/Trans dtd. 23.03.2017 without prejudice to the right of the primary authority.

This is the request of Secretary, RTA Ernakulam for prior concurrence of this authority for the grant of fresh regular permit in respect of suitable stage carriage having seating capacity not less than 33 to operate on the route Thuravoor Temple – Aster Medicity Via Makkekadavu, Poochakkal, Aroor Temple, Vyttila, Edappally, Kunnumpuram, Manjummel Kavala, Edayakunnam as mofussil service for the portion lying under the jurisdiction of RTA Alappuzha. Secretary RTA reported that the portion from Thuravoor Temple to Kumbalam Bridge via Makkekadavu, Poochakkal 22.7 Kms lying under the jurisdiction of RTA Alappuzha. A distance of 1.2 kms from Aroor Temple to Aroor Church (Alappuzha Dist.) overlaps Trivandrum – Palakkad Partial Exclusion Scheme vide GO(P) No.42/2009 Trans dtd. 14/07/2009 and GO(P) No. 13/2023/Trans dtd. 03/05/2023. Hence concurrence is **granted** subject to the effect of Clause 5(c) of Notification No. 42/2009/Trans dtd. 14.07.2009 and 08/2017/Trans dtd. 23.03.2017 without prejudice to the right of the primary authority.

This is the request of Secretary, RTA Kollam for prior concurrence of this authority for the grant of fresh regular permit in respect of a suitable stage carriage to operate on the route Charumoode - Karunagapally HS Jn Via Thamarkulam, Pavumba Chanda, Manapally and Arathumadam for the portion lying under the jurisdiction of RTA Alappuzha. Secretary RTA reported that the portion from Charummoodu to Palamkuzhy 5.6 Kms lying under the jurisdiction of RTA Alappuzha and no any overlapping on this portion. Hence concurrence is **granted** subject to the effect of Clause 5(c) of Notification No. 42/2009/Trans dtd. 14.07.2009 and 08/2017/Trans dtd. 23.03.2017 without prejudice to the right of the primary authority.

This is the request of Secretary, RTA Kollam for prior concurrence of this authority for the grant of fresh regular permit in respect of a suitable stage carriage to operate on the route Charumoode – Karunagapally (Padanayarkulangara) via Thamarakulam, Erappanpara, Tharayil Mukku, Manapally, Arathumadam, AVHS Jn, Veluthamanal, Edakulangara, Railway Jn and Alummude for the portion lying under the jurisdiction of RTA Alappuzha. Secretary RTA reported that the portion from Charummoodu to Palamkuzhy 5.6 Kms lying under the jurisdiction of RTA Alappuzha and no any overlapping on this portion. Hence concurrence is **granted** subject to the effect of Clause 5(c) of Notification No. 42/2009/Trans dtd. 14.07.2009 and 08/2017/Trans dtd. 23.03.2017 without prejudice to the right of the primary authority.

This is an application to revoke the decision of the RTA which held on 17.11.2022 vide item No.95 regarding the application for transfer of permit in respect of the stage carriage KL 16 D 0171. Sri. Krishnan Kutty Nair, Vrindavanam, Kidangayam, Padanilam P O, Mavelikara, owner of the stage carriage KL 16 D 0171 applied for transfer of permit to Sri.Shaiju S, Shaiju Bhavanam, Karimulakkal North, Komalloor P.O., Mavelikara and the matter placed before RTA held on 17.11.2022 as item No.95. RTA board decided as “Heard the learned counsel represented the applicants. This is an application for transfer of permit in respect of stage carriage KL-16 D 171 on the route Bharanikav - Chengannur via Chakkuvally, Thamarakulam, Charumoode, Chunakara, Mankamkuzhy, Puliyoor. Secretary RTA reported that the joint application is genuine and complies with the provisions of KMV Rule 178. Hence this authority allowed the transfer of permit from the name of Sri. Krishnan Kutty Nair, Vrindavanam, Kidangayam, Padanilam P.O., Mavelikara to the name of Sri.

Shaiju S, Shaiju Bhavanam, Karimulakkal North, Komaloor P.O., Mavelikara subject to the remittance of all government dues if any.”

On 03.10.2023 the permit holder and transferor of the stage carriage KL 16 D 0171 Sri. Krishnan Kutty Nair submitted a request in this office for cancelling the transfer of permit which was allowed by RTA on 17.11.2022 vide item No. 95. On 15.11.2023 the transferee Sri. Shaiju S submitted an application in this office for endorsing transfer of permit which was allowed by RTA which held on 17.11.2022 vide item No. 95. And he also offered an another stage carriage KL 18 D 4878 owned by his name since the stage carriage KL 16 D 0171 is not fit to use on road. On 14.02.2024 Sri. Shaiju S Submitted a Judgment from the Hon'ble High Court of Kerala in WP(C) No. 38922/2023 dtd. 08.02.2024 and which reads that “.....directing the petitioner to make available RC book and regular permit issued in respect of the vehicle bearing registration No. KL 16 D 0171 before the respondent-Secretary to Regional Transport Authority. On production of these documents, the respondent-Secretary to Regional Transport Authority shall consider Ext P3 representation submitted by the petitioner and take necessary steps to endorse the transfer. A decision in this regard shall be taken within a period of two weeks”. In light of the above judgment the request of the transferee Sri. Shaiju S was considered by this office and directed the transferor and transferee to produce the current records of the stage carriage KL 16 D 0171 and also directed to clear all the dues including e-chellan pending in vahan site. On 04.04.2024 the permit holder Sri. KrishnanKutty Nair submitted another judgment from the Hon'ble High Court of Kerala in WP(C) No. 10869/2024 dtd 27.03.2024 and which reads that ‘taking to consideration the nature of the objections raised in Ext P5 I am the view that it should be considered by the competent authority while finalizing the matter. The writ petition is therefore disposed of directing the respondent to consider Ext. P5 objection while finalizing Ext. P6 proceedings”. In light of the above judgments both the parties were appeared before this authority and agreed to revoke the decision of the RTA which held on 17.11.2022 vide item No.95 for retaining the ownership of the stage carriage permit in respect of the KL 16 D 0171 in the name of existing owner Sri. Krishnan Kutty Nair. And in that hearing they were stated that not intend to proceed with the transfer of permit which was allowed by RTA which held on 17.11.2022 vide item No. 95.

This Authority heard the counsel and considered the above specified judgments and it is decided to revoke the decision taken by the RTA board dated.17.11.2022 vide item No. 95.
