# DECISIONS OF REGIONAL TRANSPORT AUTHORITY, PALAKKAD DATED 11.03.2025

## Item No.01

Heard, this is a request for allowing a new bus stop near Nemmara Vettakkorumakan Temple on the PWD Road connecting Ayalur and Nemmara. The request is re-considered as per Rule 206 of KMV Rules, 1989. The enquiry report of Motor Vehicles Inspector dated 31.10.2023 reveals that the proposed bus stop is in violation of Regulation 22 of Motor Vehicles(Driving) Regulations 2017 and detrimental to the safety of road users. The report of the Executive Engineer, PWD Roads Division Palakkad also reveals that the proposal will cause traffic block and may increase accident chances. In view of the above, this authority is not in a position to allow the request. Hence, request for the new bus stop is rejected.

#### Item No.02

Heard, this is a request of RTA, Malappuram (Ref: Decision of RTA, Malappuram dated 24.10.2024 in item No. 60) seeking prior concurrence for considering fresh stage carriage permit application on the inter-district route Kulathoor Station Padi-Changuvetti-Melattur (touching EMS Medical College Hospital). As per the enquiry report, the portion of the above route falls for a distance of 3.2 Km in Palakkad district from Kulaparambu Junction to Kanjirampara. This portion is not overlapping with any notified route/approved scheme and not a virgin portion. Hence, the **request for concurrence for fresh stage carriage permit is granted**, subject to stipulations in the Notification G.O(P) No. 13/2023/Tran dated 03.05.2023 of Government of Kerala without prejudice to the right of the primary authority to take decision on the application for fresh regular permit as per any other prevailing Rules and Regulations.

#### Item No.03

Heard, this is a request of RTA, Malappuram ( Ref: Decision of RTA, Malappuram dated 07.01.2020 in item No. 06) seeking prior concurrence for considering fresh stage carriage permit application on the inter-district route Pandikkad-Wandoor-Manjeri-Mannarkkad-Karuvarakundu-Pandallur. As per the enquiry report, the portion of the above route falls for a distance of 21 Km in Palakkad district from Kanjirampara to Mannarkkad Private Bus Stand. Out of this a distance of 3.4 Km from Kumaramputhur Chungam Junction to Mannarkkad Private Bus Stand via Kalladi College, Kunthipuzha Bridge is



overlapping with notified route Palakkad-Kannur Scheme and no virgin portion in this district. Hence, the request for concurrence for fresh stage carriage permit is granted, subject to stipulations in the Notification G.O(P) No. 13/2023/Tran dated 03.05.2023 of Government of Kerala without prejudice to the right of the primary authority to take decision on the application for fresh regular permit as per any other prevailing Rules and Regulations.

# Item No.04

Heard, this is a request of RTA, Malappuram( Ref: Decision of RTA, Malappuram dated 24.10.2024 in item No. 90) seeking prior concurrence for considering fresh stage carriage permit application on the inter-district route Nallurpulli-Perinthalmanna-Melattur-Keezhattur. As per the enquiry report, the portion of the above route falls for a distance of 3.5 Km in Palakkad district from Kanjirampara DB to Kulaparambu(DB) via Aalungal & from Alaungal to Nallurpulli. This portion is not overlapping with any notified route/approved scheme and not a virgin portion. Hence, the request for concurrence for fresh stage carriage permit is granted, subject to stipulations in the Notification G.O(P) No. 13/2023/Tran dated 03.05.2023 of Government of Kerala without prejudice to the right of the primary authority to take decision on the application for fresh regular permit as per any other prevailing Rules and Regulations.

# Item No.05

Heard, this is a request for allowing a new bus stop on National Highway 544 in front of Azeezia Hospital in between Alathur and Vadakkenchery. The proposed stop is on the National Highway and NHAI is the road authority. Hence, as per the stipulations in Rule 206 of KMV Rules 1989, Secretary is directed to obtain report from NHAI and concerned Police Authority in this regard and place the request before this authority for re-consideration. Hence, decision on the request for a new bus stop is adjourned.



Heard, this is a request to specify the list of bus stops between Palakkad and Mannarkkad on NH 966. On perusal of submitted notes and records, no such list of stops in particular route/sector is available in the maintained records. Hence, Secretary shall take necessary steps to list out the approved stops on the above stretch of road between Palakkad and Mannarkkad and provide to the applicant.

# Item No.07

Heard all the concerned, including the stake holders. In compliance with the directions of Hon'ble High Court of Kerala dated 29.01.2019 in WP(C) No. 31293 of 2018, the renovation work of the Palakkad Municipal Bus Stand has to be completed by the Palakkad Municipality within a short span of time causing only least in-convenience to the public. The report of the enquiry officer reveals that the renovation work is not completed till date. On receipt of the work completion certificate from the Municipal Authorities, Secretary shall conduct a joint inspection with Police and PWD Authorities to ensure the requirements mentioned in Rule 207 of KMV Rules, 1989 are complied with. The combined inspection report shall be placed before this authority for consideration and for according permission for further functioning of the bus Hence, decision is adjourned. On receipt of sanction for the functioning of bus stand from this authority, taking in to consideration of scenario. Traffic Regulatory Committee present traffic shall decide entry/parking/volume of stage carriages in the Munidipal bus stand.

- 1. Perused the judgment of Hon'ble High Court of Kerala dated 15.03.2024 in WP(C) No. 8804 of 2024.
- 2. Heard, this is to re-consider the application for variation of permit in respect of stage carriage KL 52 J 419 on the route Arangottukara-Kumbidi. The applied variation is for extension of route from Padinjarangadi to Arikkad via Gokhale HS School and Parakulam NSS College instead of Kokkad and Othalur by curtailing the portion between Kokkad to Padinjarangadi. The proposed extension is reported as beneficial to the students of Gokhale HS, NSS College and other travelling public. While the matter is heard, public representations are against proposed curtailment between Kokkad Padinjarangadi. The judgment of Hon'ble High Court of Kerala directs to take final decision on the application for variation of permit within a



stipulated time. Hence, this authority is of the view that beneficial extension cannot be allowed without considering the difficulty caused to the existing travelling public of the proposed curtailment portion between Kokkad and Padinjarangadi. Hence, this application for variation of permit is rejected. Secretary is directed to realise application fee for variation of permit, if not already paid

 Based on the report of the JRTO, Pattambi dated 14.08.2024, Secretary shall ascertain the present possession of the above vehicle and initiate further action, if found necessary.

# Item No.9

Heard, this is an application for variation of permit in respect of stage carriage KL 10 AV 0633 authorised to operate on the route Vecramangalam-Pattambi. The proposed variation is for curtailing existing two single trips between Cherplassery and Pattambi via Vallapuzha(19 Km) (trip at 11.56 am from Cherplassery to Pattambi and return trips at 1.12 pm from Pattambi to Cherplassery). This curtailment will adversely affect the existing travelling facility of the public. There is no changed circumstances specifically reported by the enquiry officer as prescribed in Rule 145(6) & (7) of KMV Rules, 1989 supporting variation. Hence, application for variation of permit is rejected. Secretary is directed to realise fee for variation of permit, if not already paid

#### Item No.10

Heard, this is an application for variation of permit in respect of stage carriage KL 55 Z 706 authorised to operate on the route Poonchola-Kacheripparambu. The proposed variation is for extensions of route: (1) from Kanjiram to Poonchola ST Colony via Pangode.(2) From Ambazhakkode to Kanjiram via Mundakunnu( instead of Pottasseri). The report of the enquiry officer reveals that there is no overlapping with notified route. Road fitness certificate for the virgin portion between Kanjiram and Poonchala ST Colony via Pangode(3 Km) is received from the Assistant Engineer, Kanjirapuzha Grama panchayath which reports that this road is suitable for stage carriage operation. The above proposed variation (especially from Kanjiram to Poonchala ST Colony) is beneficial to the public since most of families were shifted from Poonchola Top hill to lower camp ST Colony during the land slide. Also the other extension sought between Ambazhakkode and Pallippadi via Mundakunnu is beneficial to travelling public, where frequency of stage carriage services on this sector is



more than one hour. Hence, <u>variation of permit is granted</u>, <u>subject to</u> settlement of timings and remittance of application fee, if not paid.

## Item No.11

Heard, this is an application for variation of permit in respect of stage carriage KL 10 AD 788 authorised to operate on the route Parakulam-Karingallathani. The applied variation is for deviation of route from Anakkara to Parakulam via Nayyur and Varattippalliyal instead of via Chekkode and extension of tips from Anakkara to Kumbidi( 4 single trips). This application was earlier considered by this authority in the meeting held on 14.11.2023 vide item No. 33 and adjourned for want of some specific details and detailed report is received. The reports reveal: When the Anakkara-Parakulam sector via Chekkode and via Nayyur are compared, Anakkara Parakulam sector via Nayyur is more illserved and interior area, also the proposed trips between Anakkara and Kumbidi will be more beneficial to the travelling public and students. There is no violation of clause 19 of G.O(P) No. 13/2023/Tran dated 03.05.2023. There is no virgin portion. This authority is of the view that the applied variation is beneficial to the travelling public. Hence, variation of permit is granted, subject to settlement of timings and remittance of application fee, if not paid.

#### Item No.12

Heard, this is an application for variation of permit in respect of stage carriage KL 09 Y 2182 authorised to operate on the route Koottanad-Edappal. The applied variation is for extension of route portion between Mala Road and Kottappadam via Kakkattiri (4 Km). The report of the enquiry officer reveals that the trips to the extension sought portion are provided by utilising the existing stay time at Koottanad. There is no virgin portion. No overlapping with notified route. No curtailment. The proposed variation is reported as beneficial to the travelling public. Hence, variation of permit is granted, without change in the existing timings and subject to settlement of timings in the varied portion and remittance of application fee, if not paid



Heard, this is an application for variation of permit in respect of stage carriage KL 52 Q 5078 authorised to operate on the route Valanchery-Pallippuram. The decision on the application for variation of permit was earlier considered and adjourned for want of specific report. Even while the application was re-submitted, the detailed report required by this authority in the meeting held on 19.07.2024 in item No. 68 is not seen submitted. Secretary shall re-submit the application only after compliance of the earlier direction of this authority. Secretary is also instructed to realise application fee.

## Item No.14

Heard, this is an application for variation of permit in respect of stage carriage KL 08 BG 6035 authorised to operate on the inter-district route Palakkad-Thrissur. Applied variation is for extension of route from Thrissur to Koorkkenchery via Akasapatha and Ernrkulam Road Jn. The extension sought portion falls within the jurisdiction of RTA, Thrissur. Hence, Secretary is directed to obtain prior concurrence from RTA, Thrissur with specific mention about the intermediate points on the route and exact distance of overlapping with notified route in the jurisdiction of RTA, Thrissur. For compliance of the above, decision on the application for variation of permit adjourned. Secretary is instructed to collect application fee, if not collected.

#### Item No.15

Heard, this is an application for variation of permit in respect of stage carriage KL 09 V 6555 authorised to operate on the route Palakkad-NSS Engineering College. The applied variation is for extension of route from Malampuzha to Kunuppulli via KTDC Jn, S N Nagar, Manakkalkadavu with direct extension from Malampuzha to Kunupully. The report of the enquiry officer reveals that the above extension sought portion is virgin. The portion of the route from Malampuzha to Kunupully via Manakkalkadavu (virgin)is a narrow canal bund road having no protective barriers for a length of 1 Km. Hence, Secretary is directed to obtain fresh road fitness certificate from the concerned road authority for ascertaining the safety and suitability of the road for normal stage carriage operation. For compliance of the above direction, decision on the application for variation of permit is adjourned. Secretary is also directed to realise application fee, if not paid



Heard, this is an application for variation of permit in respect of stage carriage KL 58 A 6901 on the route Muthuthala-Ottapplam. The proposed variation is for extension of route from Koppam to Thekkumala via Viyatnampadi(8 Km). As per the route enquiry report, there is no virgin portion or overlapping with notified route in above extension sought portion. There is no curtailment. The enquiry reveals that the trips to extension sought portion will be highly beneficial to the travelling public and students. Hence <u>variation of permit is granted</u>, subject to settlement of timings and not by permitting any additional trip on the notified route. Secretary shall collect the application fee, if not paid.

# Item No.17

Heard, this is an application for variation of permit in respect of stage carriage KL 51 F 7097 authorised to operate on the route Velliyad Puthur-Akalur. The decision on the application for variation of permit was earlier considered and adjourned for want of modified time schedule to be submitted by the applicant. Even while the application was re-submitted, the directions given to the applicant were not seen complied. Secretary shall re-submit the application only after compliance of the earlier direction of this authority in the decision dated 19.07.2024 in item No.67. Hence, decision on the application for variation of permit is adjourned. Secretary is also instructed to realise application fee.

#### Item No.18

Heard, this is an application for variation of permit in respect of stage carriage KL 52 N 7285 authorised to operate on the route Pattambi-Pallippuram. The proposed variation is deviation of route from Pallipuram to Pattambi via Kolamukku & Naripattamana. The report of the enquiry officer reveals that the sought for variation is advantageous to travelling public. There is no overlapping with the notified route. No virgin portion. There is no violation of clause 19 of G.O(P) No. 13/2023/Tran dated 03.05.2023. Hence, *variation of permit is granted*, subject settlement of timings and remittance of application fee.

#### Item No.19

Heard, this is an application for variation of permit in respect of stage carriage KL 48 H 7475 authorised to operate on the route Kumbidi-Palakkad. The proposed variation is for extension of route from Kumbidi to Kangapuzha for a

distance of 2.5 Km, by providing 4 single trips on the extended portion with some changes in the existing time-slots. The enquiry report reveals that in the extension sought portion, there is no overlapping with notified route, no virgin portion. There is no violation of clause 19 of G.O(P)No. 13/2023/Tran dated 03.05.2023 and also there is no curtailment. It is also reported that the proposed variation is beneficial to the travelling public and students. Hence, variation of permit is granted, subject settlement of timings and remittance of application fee.

# Item No.20

Heard, this is an application for variation of permit in respect of stage carriage KL 09 W 9556 authorised to operate on the route Palakkad-Railway Colony. The proposed variation is extension of route from Railway Colony to N S S Engineering College via Ummini. The report of the enquiry officer reveals that the extension sought portion is 2.2 Km, there is no overlapping with notified route in this portion. There is no virgin portion. There is no violation of clause 19 of G.O(P)No. 13/2023/Tran dated 03.05.2023. No curtailment. The trips are proposed on the extension portion without changing the existing time schedule and by utilising the stay time at Railway Colony. The proposed 4 single trips between Railway Colony and N S S Engineering College are reported as beneficial to the students and staff of N S S Engineering College, which is situated at a remote place. Hence, *variation of permit is granted*, subject to settlement of timings and remittance of application fee, if not paid.

#### Item No.21

Heard, this is an application for variation of permit in respect of stage carriage KL-53-N-9584 authorised to operate on the route Kulathur-Cherplassery. The route enquiry report submitted by the Secretary before this authority is not seen duly signed and authenticated by the enquiry officer. Hence for submitting authenticated route enquiry report, decision on **the application** for variation of permit is adjourned

- Perused the judgment of Hon'ble High Court of Kerala dated 17.02.2025 in WP(C)No. 5522 of 2025.
- Heard. These are applications for renewal of permit[Permit No. 9/415/2002 authorised to operate on the inter-district route Walayar-Ayyanthole which was expired on 14.05.2015] and replacement of stage carriage KL 09 V 0003[which was detached from permit and permit kept



under suspended animation and issued with clearance certificate on 15.12.2012 on request of the permit holder and as per the Order of Hon'ble STAT, Ernakulam dated 09.11.2012 in MP No. 1239/2012 in MVARP No. 439/2012 by KL 49 6500.

On perusal of records, the stage carriage KL 09 V 0003 covered by the permit is seen detached from the permit since 15.12.2012 and permit was non-operational for the last 12 years without substituting with suitable vehicle by the permit holder. On16.04.2015, an application for renewal of permit was filed by the applicant wrongly mentioning the vehicle covered by the permit as KL 09 V 3, which was already detached from the permit wef. 15.12.2012, ie. in brief, application for renewal of permit was filed in vacuum. On 03.01.2025, an application for replacement by proposing a stage KL 49 6500 was also filed by wrongly mentioning the registration mark of the vehicle covered by the existing permit as KL 09 V 3, which already detached from the permit wef. 15.12.2012. In the above judgment dated 17.02.2025 in WP(C) No. 5522 of 2025, Hon'ble High Court of Kerala has directed to take decisions on Ext.P2(application for renewal of permit filed on 16.04.2015), Exhibit P3( application for renewal of permit filed on 12.10.2020) & Ext P4(application for replacement dated 03.01.2025) within a stipulated period. On perusal of records, it is seen that the applicant has not filed Exhibit P3 application before this authority for further renewal of permit as submitted before the Hon'ble High Court.

It is evident from the records that no vehicle was attached to the permit since 15.12.2012, ie., for long period of 12 years. Further, application mentioned above were filed on 16.04.2015( for renewal) and on 03.01.2025( for replacement) during when no vehicle was attached to the permit, ie. in vacuum. The dictum laid down by Hon'ble High Court of Kerala in WA No. 2175 of 2015[against the order/judgment in WP(C)No.24250/2015] there cannot be a renewal of permit in vacuum without the vehicle. Also KSRTC vehemently objected the applications on renewal and replacement highlighting the dictum laid down in Usman Vs RTA, Malappuram. Hence, above application for renewal of permit is not maintainable. No application for replacement is filed during the currency of permit. Moreover, as per the above dictum both the applications for renewal of permit and replacement of vehicle cannot be considered in one breath. For the above reasons, *Exhibit P2 application for renewal of permit is not maintainable and rejected*. Since Ext.P3 application

for further renewal is not filed by the petitioner, no orders can be passed on it. In the application for replacement of vehicle (Ext P4), no decision can be taken as per the above dictum and in the absence of valid permit. Hence, it is decided to dispose the replacement application (Ext.P4) as in-fructuous.

- Perused the judgment of Hon'ble High Court of Kerala dated 03.12.2024 in WP(C)No.42675 of 2024.
- Perused the judgment of Hon'ble High Court of Kerala dated 13.02.2025 in WP(C)No: 4266 of 2025.
- 3. Heard the counsel representing the applicant and other affected parties. This is to re-consider the applications in respect of stage carriage KL 49 66 dated 23.08.2018 & 25.09.2023 for renewal of permit and temporary permit application dated Nil( received on 11.12.2024) in respect of stage carriage KL 49 66 authorised to operate on the intra-district route Mudapallur-Palakakad as ordinary service which was valid up to 10.09.2018. These applications were placed before RTA, Palakkad dated 14.11.2023 vide item No. 62 and permit was cancelled as per Rule 152 of KMV Rules, 1989 and applications for renewal of permit were rejected since the applicant failed to offer any valid explanation for not conducting service for the last many years. The above decision of this authority was quashed by the Hon'ble High Court of Kerala as per judgment dated 03.12.2024 in WP(C)No. 42675 of 2024 by accepting the version of the petitioner that the intimation regarding the above meeting of RTA was not received by her in-time. The judgment also restores the applications for renewal of permit and remands back for re-consideration by this authority in accordance with law and after affording an opportunity of hearing to the petitioner and any other affected parties. Applicant submitted reasons for not conducting service for the last many years before this authority with documentary evidences. This authority is satisfied that the permit holder was prevented by sufficient causes from running the service continuously as required under Rule 152 of KMV Rules, 1989. Hence, renewal of permit for the period from 11.09.2018 to 10.09.2023 is granted, subject to the conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if



any and remittance of application fee, if not paid. For the above accepted valid reasons, secretary is permitted to entertain application [under Section 81(3) of Motor Vehicles Act, 1988] dated 25.09.2023 filed for renewal of permit for the further period. The delay is condoned, being it is an intra-district permit, Secretary shall grant renewal of permit for further period from 25.09.2023 to 24.09.2028 after endorsing previous renewal on the permit and after realisation of application fee, subject to the above conditions.

4. The judgment of Hon'ble High Court of Kerala dated 13.02.2025 in WP(C)No. 4266 of 2025 directs to consider and pass orders on the temporary permit application received on 11.12.2024. In view of the above decision (No.03) granting renewal of permit, by fining that there is no need for temporary permit, the application for <u>temporary permit is rejected</u>.

# Item No. 24

Heard, this is an application for renewal of permit KL99/109/2000 valid up to 10.10.2024 in respect of stage carriage KL 50 D 342 for a further period of five years to operate on the inter-district route Palakkad-Manjeri as ordinary service. *Renewal of permit is granted* as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee if not paid.

#### Item No. 25

Heard the counsel representing the claimed successor (Sri.Palanivel Ramaswamy, the father of the deceased permit holder Sri.S.P.Sakthivel) and the applicant Sri.A.Dhanapal. This is an application dated 16.10.2024 for renewal of permit in respect of stage carriage KL 14 S 0977 authorised to operate on route Malampuzha-Palakkad Kava on the strength of regular permit KL 99/323/1999 valid up to 18.11.2024. As per this office records, the permit holder Sri.S.P.Sakthivel is expired on 10.04.2023 and on 03.05.2023, Sri.Palanivel Ramaswamy, the father of the deceased has filed death intimation and requested more time to complete further procedures with regard to transfer of permit. Sri.Palanivel Ramaswamy, the claimed successor, has filed strong objection before this authority stating that one Mr.Dhanapal is illegally trying to obtain the above permit without knowledge/consent of him



and also requested to stop the service of this stage carriage immediately. The above application for renewal of permit submitted in Form PRA is submitted and signed by one Mr.Dhanapal. As per Section 82(3) of MV Act,1988, on death of the holder of the permit, allows this authority to transfer the permit to the person succeeding to the possession of the vehicle covered by the permit. Also Rule 56(2) of Central Motor Vehicle Rules, 1989 permits to file the application for transfer by the nominee or the person succeeding to the possession of the vehicle, in the case of the death of the registered owner. In this case, the applicant is not at all a nominee/successor/legal heir. Hence, the application filed by Sri.Dhanapal after the death of the permit holder for renewal of permit is not maintainable and hence Rejected.

# Item No.26

Heard, this is a belated application dated 07.02.2025 for renewal of permit KL99/347/1998 valid up to 23.01.2025 in respect of stage carriage KL 51 Q 1213 for a further period of five years to operate on the intra-district route Cherplssery-Palakkad as ordinary service. This application is filed not in conformity with Section 81(2) of M V Act, 1988. The applicant requested to condone delay with supporting documents. As per the provisions contained in Section 81(3) of the M V Act, 1988, this authority is satisfied that the applicant was prevented by good and sufficient causes from making the application within the prescribed time. Hence, delay condoned. **Renewal of permit is granted from the date of application** as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee if not paid. Secretary shall verify the service of the vehicle after expiry of permit and realise compounding fee, if permit-less operation is detected.

# Item No. 27

Heard, this is an application for renewal of permit KL99/1002/2004 valid up to 02.01.2024 in respect of stage carriage KL53P 2063 for a further period of five years to operate on the inter-district route Valanchery-Perinthalmanna as ordinary service. **Renewal of permit is granted** as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.

Heard, this is a belated application dated 05.12.2023 for renewal of permit KL99/40009/2008 valid up to 02.10.2023 in respect of stage carriage KL 09 O 2518 for a further period of five years to operate on the intra-district route Adiperanda Thara-Kachamkurisi Temple as ordinary service. This application is filed not in conformity with Section 81(2) of M V Act, 1988. The applicant requested to condone delay citing reasons. As per the provisions contained in Section 81(3) of the MV Act, 1988, this authority is satisfied that the applicant was prevented by good and sufficient causes from making the application for renewal of permit within the prescribed time. Hence, delay condoned. Renewal of permit is granted from the date of application as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee if not paid. Secretary shall verify the service of the vehicle after expiry of permit and realise compounding fee, if permit-less operation is detected.

- Perused the judgment of Hon'ble High Court of Kerala dated 28.10.2024 in WP(C)No. 37919 of 2024.
- 2. Perused the judgment of Hon'ble High Court of Kerala dated 04.12.2024 in WP(C)No. 40526 of 2024.
- 3. Heard the counsels representing Smt.Suhara Aboobacker(the petitioner in WP(C)No. 37919 of 2024) and Sri.Renjith Kumar.C(petitioner in WP(C) No. 40526 of 2024) who are respectively the applicants for temporary permits in respect of stage carriage KL 08 AF 6652 & KL 54 0399 to operate on the intra-district route Sholayur-Panamaravayal in place of route bus KL 11 Q 3222 regular permit of which was expired on 01.12.2023. In the absence of valid permit, both the applications for temporary permit are not maintainable and hence rejected.
- 4. This is to re-consider the application dated 28.11.2023 for renewal of permit in respect of the route bus KL 11 Q 3222. While this application was considered in the meeting of RTA, Palakkad held on 19.07.2024 in item No. 85 and decision on the application was adjourned for ascertaining the existence of the vehicle based on an objection raised before this authority. On perusal of the reports of the competent officer and from the statement given in person by the permit holder before the Secretary, RTA, and after hearing all the concerned, this authority



arrived at the conclusion that the above vehicle KL 11 Q 3222 covered by the permit is not in existence. As per the dictum laid down by Hon'ble High Court of Kerala in Jaffer Vs.Usman and Others – 2015 KHC 947:2015(4) KLT 590: AIR 2016 NOC-293(DB) , an application for renewal of permit without there being a vehicle with the application is not contemplated by Rule 172 of KMV Rules, 1989. Hence, the application for renewal of permit is found not maintainable and hence rejected.

 In view of the above decision(4), the decision of this authority dated 18.03.2023 in item No. 69 which allowed replacement of stage carriage KL 11 Q 3222 by KL 54 399 is hereby revoked.

# Item No.30


Heard, this is an application for renewal of permit KL99/108/2000 valid up to 20.03.2025 in respect of stage carriage KL 51 A 4000 for a further period of five years to operate on the inter-district route Palakkad-Guuvayur as LSOS. **Renewal of permit is granted** as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.

# Item No.31

Heard, this is an application for renewal of permit KL99/431/2001 valid up to 15.06.2025 in respect of stage carriage KL 08 BZ 4052 for a further period of five years to operate on the inter-district route Thrissur-Ozhalapathy. *Renewal of permit is granted* as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.

# Item.No.32

Heard, this is an application for renewal of permit KL99/6110/1994 valid up to 24.11.2024 in respect of stage carriage KL 53 P 4104 for a further period of five years to operate on the inter-district route Agali-Kozhikode. **Renewal of permit is granted** as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.



Heard, this is a belated application dated 30.01.2025 for renewal of permit KL99/1048/2004 valid up to 17.01.2025 in respect of stage carriage KL10 Z 4113 for a further period of five years to operate on the intra-district route Aloor-Pattambi as ordinary service. This application is filed not in conformity with Section 81(2) of M V Act, 1988. The applicant requested to condone delay citing reasons. As per the provisions contained in Section 81(3) of the M V Act, 1988, this authority is satisfied that the applicant was prevented by good and sufficient causes from making the application for renewal of permit within the prescribed time. Hence, delay condoned. **Renewal of permit is granted from the date of application** as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee if not paid. Secretary shall verify the service of the vehicle after expiry of permit and realise compounding fee, if permit-less operation is detected.

# Item.No.34

Heard, this is an application for renewal of permit KL99/670/1997 valid up to 11.01.2025 in respect of stage carriage KL 08 AQ 4271 for a further period of five years to operate on the inter-district route Govindapuram-Thrissur as ordinary service. *Renewal of permit is granted* as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.

#### Item.No.35

Heard, this is a belated application dated 30.06.2017 for renewal of permit in respect of stage carriage KL 09 M 4446 authorised to operate on the inter-district route Muthukurissi-Perinthalmanna which was valid up to 30.06.2017 filed along with request to condone delay in submitting renewal application in-time. Applicant failed to submit neither the NOC from the financier as required under Section 51(8) of Motor Vehicles Act, 1988 nor the declaration that she has not received any communication from the financier. By withdrawing the above vehicle from operation for the last eight years without obtaining prior sanction, the permit holder failed to make the permit operational on the above route as required under Rule 152 of KMV Rules, 1989. No valid reasons are submitted for non-operation of the vehicle on permit. Hence, permit is cancelled,



# application for renewal of permit has become non-maintainable and disposed as in-fructuous.

# Item.No.36

Heard. The regular permit in respect of stage KL 04 L 4834 on the intra district route Ambalappara-Thivuvahiyode was valid up to 15.12.2023. The above vehicle attained 22 years as on 15.09.2024, and has become un-suitable for stage carriage carriage operation as per the prevailing age restrictions for stage carriages. No application for replacement by suitable vehicle is filed. Renewal of permit was granted as per the decision of this authority dated 19.07.2024 in item No. 92. The decision granting renewal of permit was communicated on 28.11.2024 vide Endt. No. R13/615688/2023/P dated 21.10.2024. withdrawing the above vehicle from operation for the last five years without obtaining prior sanction, the permit holder failed to make the permit operational on the above route. The explanations were given by the permit holder in reply to the notice issued under Rule 152 of KMV Rules, 1989, both before the Secretary, RTA, Palakkad and before this authority. This authority is not satisfied that the permit holder was prevented by sufficient cause from running the service for the last five years. Hence, permit is cancelled under Rule 152 of KMV Rules, 1989 and sanction accorded for renewal of permit as per the decision dated 19.07.2024 in item No. 92 is revoked.

## Item No.37

Heard, this is an application dated 23.12.2016 for renewal of permit[Permit No. 9/633/2003] in respect of stage carriage KL 09 M 5779 authorised to operate on the intra-district route Mannarkkad-Palakkad on the strength of regular permit valid up to 16.01.2017 and applications dated 29.01.2025 for further renewal of permit and application for replacement of stage carriage KL 09 M 5779 by KL 08 AS 7414. On perusal of records, tax in respect of this vehicle is paid only up to 30.06.2013. The vehicle was not operational on the permit for the last 12 years, without obtaining prior sanction from this authority. Permit holder not seen timely responded to the notice issued on 08.02.2023 by Secretary, RTA,Palakkad under Rule 152 of KMV Rules, 1989. The application dated 23.12.2016 for renewal of permit was placed before RTA in the meeting held on 18.03.2023 vide item No. 54 after issuing due notice the permit holder. Since permit holder was absent before this authority in the above meeting, the decision on renewal application was adjourned. On 14.10.2024, the permit holder filed a request to re-consider her application for



renewal of permit. On 28.01.2025 the permit holder submitted applications for further renewal of permit and replacement of stage carriage by another stage carriage KL 08 AS 7414, along with NOC from the financier of stage carriage in respect KL 09 M 5779. The explanations/reasons submitted by the permit holder both before the Secretary, RTA, Palakkad and before this authority for not conducting service for the long 12 years are perused. This authority is not satisfied that the permit holder was prevented by sufficient cause from running the service as required under Rule 152 of KMV Rules, 1989. Hence, permit is cancelled under Rule 152 of KMV Rules, 1989.

In view of the above decision, <u>applications field for renewal of permit and</u> replacement of vehicle are not maintainable and hence disposed as infructuous.

# Item No.38

Heard, this is an application for renewal of permit KL99/628/1995 valid up to 22.05.2025 in respect of stage carriage KL 08 BG 6183 for a further period of five years to operate on the inter-district route Gopalpuram-Thrissur. *Renewal of permit is granted* as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.

#### Item No.39

Heard, this is an application for renewal of permit KL/9/SC/2019/19 valid up to 17.01.2025 in respect of stage carriage KL 51 B 6700 for a further period of five years to operate on the inter-district route Palakkad-Ayyanthole **Renewal of permit is granted** as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.

#### Item No.40

Heard, this is an application for renewal of permit in respect of stage carriage KL 10 Y 7333 authorised to operate on the inter-district route Shoranur-Melattur. Secretary shall obtain route enquiry report for the portion of the route lying in Palakkad district from the concerned officer and re-submit the application in the next meeting. Hence, decision on the <u>application for renewal of permit is adjourned.</u>



- Heard, this is an application for renewal of permit KL99/664/1999 valid up to 30.11.2024 in respect of stage carriage KL 52 C 7494 for a further period of five years to operate on the inter-district route Koyapadi-Perinthalmanna. Renewal of permit is granted as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.
- 2. It is reported that this vehicle is operating by curtailing trips after 7.16 pm. This is a violation of permit condition. Section 86(1)(a) of Motor Vehicles Act, 1988 empowers this authority to suspend/cancel the permit in such situations. If permit holder agrees to pay compounding fee for the reported violation of permit conditions, in lieu of suspension of permit, Secretary can recover the sum of money, otherwise place the matter before this authority for further orders. Secretary shall also watch and ensure that the vehicle is operating entire permitted trips as per the approved time schedule.

# Item No.42

Heard, this is an application for renewal of permit KL99/1058/2000 valid up to 09.07.2025 in respect of stage carriage KL 47 C 8055 for a further period of five years to operate on the inter-district route Pattambi-Palakkad. *Renewal of permit is granted* as ordinary service, subject to conditions laid down in G.O(P)No. 13/2023/Tran dated 03.05.2023, production of NOC form the financier, if applicable, clearance of Mvs.tax and Govt. dues, if any and remittance of application fee, if not paid.

- Perused the Common judgment of Hon'ble High Court of Kerala dated 05.09.2024 in WA No. 146 & 153 of 2021
- Perused the Common judgment of Hon'ble High Court of Kerala dated 04.01.2021 in WP(C)No. 14847 & 15810 of 2020
- Perused the judgment of Hon'ble High Court of Kerala dated 25.10.2019 in WP(C)No. 28037 of 2019(D)



- 4. Perused the judgment of Hon'ble State Transport Appellate Tribunal, Ernakulam dated 05.06.2020 in MVAA No.39/2020.
- 5. Perused the judgment of Hon'ble High Court of Kerala dated 29.09.2015 in WP(C)No. 33910 of 2014(K)
- Perused the judgment of Hon'ble State Transport Appellate Tribunal, Ernakulam dated 24.07.2014 in MVAA No. 315 of 2011.
- 7. This is to re-consider the request dated 02.06.2015 for renewal of permit on the modified route Palakkad-Pattambi. Perused records, the regular permit in respect of stage carriage KL 08 AJ 9550[Permit No. C6/10/2006/pl was valid up to 19.06.2011 on the inter-district route Guruvayur-Palakkad. This permit was issued subject to counter-Permit holder failed to obtain countersignature of sister RTA. signature from sister, RTA(RTA, Thrissur). On 17.06.2011, permit holder filed an application for renewal of permit along with request to condone delay in filing renewal application mentioning description of permit/route as Guruvayur-Palakkad. In the absence of counter signature U/S 88 (1) of Motor Vehicles Act, 1988], since the permit cannot be considered as validity existed permit for renewal U/S 81(1) of Motor Vehicles Act, 1988 on the above route, as per decision of this authority dated 29.07.2011 in item No.23, application for renewal of permit was rejected.

The above decision was impugned before the Hon'be STAT, Ernakulam. Hon'ble STAT, as per judgment dated 24.07.2014 in MVAA No.315 of 2011 directed to reconsider the application submitted for renewal of permit by the petitioner, and also the application for temporary permit filed by her on the route Palakkad-Pattambi after affording opportunity of being heard to the appellant as well as to the KSRTC.

During then, as per the interim order of Hon'ble STAT, Ernakulam dated 24.07.2012 in MP No. 668/2012 in MVAA No. 315 of 2011, on request of the permit holder Smt. Sudha Sasikumar, a clearance certificate was issued on 12.10.2012 without insisting surrendering the permit (by keeping the permit under suspended animation) in respect of stage carriage KL 08 AJ 9550. The possession and ownership of this vehicle was changed to the name of Smt. Ponnamma wef. 15.10.2012 and the vehicle attached to another permit held by the latter wef. 06.11.2012 to 02.11.2019 (seven years) and wef. 09.12.2019 again the ownership of the vehicle is seen transferred to the name of Smt.Sudha Sasikumar and now operated on different routes by obtaining substitute temporary




permits. In brief, no vehicle was attached to this permit wef 12.10.2012 to till date. (ie. for the last 12 years)

The above judgment of Hon'ble STAT in MVAA No. 315/2011 was considered by RTA on 24.10.2014 and insisted for submission of application for renewal of permit on the modified route Palakkad-Pattambi and place the matter before this authority in the open forum.

Instead of submitting application for renewal of permit in the prescribed form( Form PRA, as prescribed in Rule 172(2) of KMV Rules, 1989) as directed/insisted by RTA, on 02.06.2015, the permit holder filed a mere request mentioned in this agenda( No.7) and later submitted before the Hon'ble High Court in WP(C)No. 33910 that she had filed an application dated 02.06.2015 for renewal of permit on the modified curtailed route(Palakkad-Pattambi). It was also further submitted before the Hon'ble Court that the same is in consonance with the decision of this authority dated 24.10.2014 & judgment of Hon'ble STAT in MVAA No. 315/2011. Actually no formal application was submitted in Form PRA. as prescribed under Rule 172(2) of KMV Rules, 1989. consideration of the above statement of the permit holder, in the judgment of Hon'ble High Court of Kerala dated 29.09.2015 in WP(C)No. 33910 of 2014 there was a direction to this authority to consider the application dated 02.06.2015 treating the same as one for renewal of existing permit on modified route.

The permit holder produced another judgment of Hon'ble High Court of Kerala dated 25.10.2019 in WP(C) No.28037 of 2019(D) on 04.11.2019, in which Hon'ble Court directs this authority to take a decision on the application for renewal of permit(request) within a stipulated time. This request dated 02.06.2015 was considered by this authority in the meeting held on 24.12.2019 vide item No. 32 by perusing the above judgment and rejected the request by finding that the renewal of permit can be considered only on the original route. (ie., Guruvayur-Palakkad) and also cancelled the permit (No.C6/10/2006) as per Section 86(1) of Motor Vehicles Act, 1988, since no vehicle was attached to the permit from 12.10.2012 which is a sufficient reason for cancellation of this permit in view of the observations of the Division Bench of Hon'ble High Court of Kerala in the judgment dated 06.04.2016 in WA No. 2486, 2455 & 2769 of 2015.



The above decision was challenged by the permit holder before the Hon'ble STAT, Ernakulam in MVAA No. 39/2020. The judgment dated 05.06.2020 in MVAA No. 39/2020 set aside the above decision by finding that the reasoning of this authority that the renewal of permit application can be considered only with respect of the original route is not sustainable also by finding that the stage carriage KL 08 AJ 9550 is still owned and possessed by the appellant and hence directed this authority to reconsider the application for renewal submitted by the permit holder on the modified route Palakkad-Pattambi on merits and pass orders in accordance with law within a stipulated period after hearing all the concerned.

Two en-route operators (who are the additional respondents in the above MVAA No. 39/2020) and another filed respectively two writ petitions in WP(C)No. 14847/2020 & 15810/2020 before Hon'ble High Court of Kerala praying to quash the above judgment of Hon'ble STAT in MVAA No. 39/2020 dated 05.06.2020 and declare that the application for renewal of permit submitted by the permit holder to operate on the modified route is not maintainable as per the provisions of Motor Vehicles Act & Rules made there under. Hon'ble High Court of Kerala by considering the above writ petitions together and rendered a common judgment dated 04.01.2021 in WP(C) No. 14847/2000 & 15810/2020. In this judgment, it is observed by the Hon'ble High Court that non submission of an application in procedural form for curtailment alone cannot be considered as a proper and justifiable reason to reject an application.

By perusing the above judgment, this authority in the meeting held on 17.02.2021 in Supplementary item No. 01 considered the request dated 02.06.2015 for renewal of permit on the modified route Palakkad-Pattambi and adjourned the decision awaiting the final verdict of Hon'ble High Court of Kerala in WA No. 146/2021[ filed against the judgment of Hon'ble High Court of Kerala dated 04.01.2021 in WP(C)No. 14847/2020]

An another en-route operator had also filed a WA No.153/2021 before the Hon'ble High Court of Kerala against the judgment dated 04.01.2021 in WP(C) No. 15180 of 2020. The appellants contented that the learned Single Judge in the common judgment dated 04.01.2021 in WP(C) No. 14847/2000 & 15810/2020 negatived the question of maintainability of the application for renewal of permit on the modified route made before



the Regional Transport Authority, Palakkad. The Hon'ble High Court of Kerala considered the above two Writ Appeals together and rendered a common judgment dated 05.09.2024 in WA No. 146 of 2021 and 153 of 2021. This judgment permits the appellants- writ petitioners to raise the question as to maintainability of the application made by the permit holder for renewal of permit on the modified route Palakkad-Pattambi before the Regional Transport Authority and also permits this authority to consider the legal and factual contentions raised by both sides, including the question of maintainability raised by the appellants and to take an appropriate decision within a time frame.

In this context, the applicant, appellants, writ petitioners and the concerned are heard through their respective learned legal counsels. After hearing various contentions, by perusing the connected records, considering various provisions of Motor Vehicles Act and Rules and as per the directions of Hon'ble High Court of Kerala and Hon'ble State Transport Appellate Tribunal, Ernakulam by re-considering the matter, the following decision is arrived at:

For varying the conditions of a stage carriage permit( including curtailment of route) under Section 80(3) of Motor Vehicles Act, 1988, it is mandatory to file application in the form "PVA" as stipulated in Rule 179 of Kerala Motor Vehicles Rules, 1989 by remitting requisite application fee prescribed in Rule 164 of KMV Rules, 1989. In this case, the permit holder never filed such an application for variation of permit. Only if the variation of permit is allowed, permit holder will be entitled to apply for renewal of permit (on the modified/varied/curtailed route) under Section 81(2) of Motor Vehicles Act, 1988 in the form "PRA" as stipulated in Rule 172(2) of Kerala Motor Vehicles Rules, 1989 by remitting requisite application fee prescribed in Rule 164 of KMV Rules, 1989. In short, the permit holder neither filed application for variation of permit as above/obtained varied permit, nor applied in form PRA as above for renewal of permit on the modified( curtailed route). A mere request submitted on 02.06.2015 by the permit holder which requests this authority to consider his earlier application for renewal of permit (submitted 17.06.2011) on the route Palakkad as the one for the modified route Palakkad-Pattambi, will not suffice the procedural formalities stipulated in Motor Vehicles Act and Rules framed there under.



Moreover, there was no vehicle attached to this permit since 12.10.2012 to till date, ie., for the long 12 years, and in this duration, the ownership and possession of the vehicle KL 08 AJ 9550 is seen transferred and vehicle was operated by attaching to another permit on a different route by an another person. Though now the possession of the vehicle is taken back by reverse transfer of ownership wef. 19.12.2019, it is still not attached to the above permit. Hence, as per the dictum laid down by Hon'ble High Court of Kerala in the judgment dated 06.04.2016 in WA No. 2486, 2455 & 2769 of 2015, no permit can exist in vacuum without a vehicle attached to it. Hence, in exercise of the powers conferred upon under Section 86(1) of Motor Vehicles Act 1988 read with Rule 185 of Kerala Motor Vehicles Rules, 1989, this authority hereby cancel the regular stage carriage permit C6/10/2006/P. The permit holder shall surrender the original permit before the Secretary, RTA who is directed to record in the permit the order of cancellation. Hence, for the above reasons, absence of any formal application for renewal of permit on the modified route, the request dated 02.06.2015 is found not maintainable and hence rejected.

- 1. Perused the judgment of Hon'ble High Court of Kerala dated 04.12.2024 in WP(C)No. 41459/2024.
- 2. Heard, this is an application dated 11.05.2023 for renewal of permit in respect of stage carriage KL 03 L 2440 which is authorised to operate on the intra-district route Kulakattukurissi-Palakkad on the strength of regular permit No. KL99/631/2003 valid up to 08.06.2023. The vehicle is non-operational for the last 05 years without obtaining any prior sanction from this authority. Rule 152 of KMV Rules, 1989 reads "its shall be a condition of the permit of every transport vehicle( other than a private service vehicle permit) that the vehicle shall be so maintained as to be available for the service for which the permit was granted, for the entire period of currency of the permit and that the permit is liable to be suspended or cancelled after due to notice to the permit holder, if the vehicle has not been used for the purpose for which the permit was granted" While the applicant was heard through his counsel by this authority, he failed to submit any valid reasons substantiating for non-operation of the vehicle for the long 05 years.



The judgment of Hon'ble High Court of Kerala dated 04.12.2024 in WP(C)No. 41459 of 2024 directs this authority to consider and pass orders on applications for renewal of permit and replacement of vehicle in accordance with law. The judgment allows consideration of application for replacement only after considering the application for renewal of permit. Hence, Secretary is directed to issue notice to the applicant/ permit holder under Rule 152 of KMV Rules, 1989, obtain explanation and place the application for renewal of permit along with the explanation in the next meeting of this authority with due notice to the applicant. No application for temporary permit is filed by the permit holder. Hence, decision on the application for renewal of permit adjourned for compliance of the above directions. It is decided to consider replacement application only after renewal of permit.

# Item No.45

- Perused the judgment of Hon'ble High Court of Kerala dated 14.01.2025 in WP(C) No.94/2025.
- 2. Permit holder of stage carriage KL 13 T 3339 Sri.Wilson K.V is absent. The petitioner in the above writ petition Sri. Unnikrishnan. K.K was heard through his counsel. This is an application for replacement of stage carriage KL 13 T 3339( covered by regular permit KL99/680/1995 valid up to 09.09.2025) by another stage carriage KL 08 CA 9500. Transfer of this permit was allowed by this authority from the name of Sri. Wilson K.V to the name of Sri.Unnikrishnan.K.K. The decision allowing the above transfer of permit was communicated to the applicants vide Endt. R13/834953/P dated 30.11.2024. But applicants failed to obtain the granted transfer of permit as stipulated in Rule 178(5)(b) of KMV Rules, While the matter stands so, on 13.12.2024, the proposed transferee files an application for replacement of stage carriage KL 13 T 3339 by another stage carriage KL 08 CA 9500. Both the above vehicles are not owned/possessed by the petitioner(who is only the proposed transferee). In the judgment above, Hon'ble High Court of Kerala directs this authority to consider the application for replacement in the next meeting of RTA.

This authority has given only permission to transfer the permit, that doesn't mean that transferee can proceed to obtain permit and get it replaced without the proper sale/consent of the transferor, who is not at all a party in this case and is which is against the natural justice.



Hence, this authority finds that the application for replacement is not maintainable and hence rejected.

# Item No.46

- Perused the judgment of Hon'ble High Court of Kerala dated 30.05.2024 in WP(C)No.18644 of 2024.
- 2. Heard. The regular permit in respect of stage carriage KL 06 B 8717( Permit No. 9/1007/2006) was valid up to 20.03.2021 on the intradistrict route Narangapaparambu-Kuzhalmannam). On 21.06.2024, an application for replacement of stage carriage KL 06 B 8717 by another stage KL 49 P 9505 was filed. The permit holder approached Hon'ble High Court of Kerala alleging that this authority is not allowing replacement of vehicle by insisting records of the out-going vehicle. It is also submitted by the permit holder before the Hon'ble High Court that his application for renewal of permit and replacement of vehicle are pending consideration of this authority. In the judgment dated 30.05.2024 in WP(C)No.18644 of 2024 Hon'ble High Court of Kerala has directed to consider the application for renewal of permit submitted by the petitioner without insisting for production of current records and take appropriate decision thereon within stipulated period. judgment further permits to consider the application for replacement after taking decision on the permit renewal application.

On perusal of records, no application for renewal of permit is seen filed by the petitioner before this authority till date after expiry of regular permit on 20.03.2021, which is contrary to the submissions made by the permit holder before the Hon'ble High Court of Kerala. In the absence of valid permit/proper application for renewal of permit, this authority is not in a position to consider the application for replacement of vehicle. Hence, application for replacement is found not-maintainable and hence rejected.
