
Any revision in existing timings of stage carriages is not only involved this single service but also the total plan of all stage carriage services operating on that sector with their suitable spacing in time. Therefore if the time of departure or arrival of one stage carriage revised, the relative spacing in time of other stage carriages are also varied resulting in clash and competition between services.

Additional service to Civil Station is beneficial to public as the civil station is the administrative center. Hence the request by applicant may consider only by treating the facts into consideration and after conducting a timing conference. This route is well served route with KSRTC and Private stage carriages. Hence the Secretary RTA is directed to analyze the proposed timings and report whether sufficient time gap is available or not. Hence **adjourned** and place the matter next RTA.
