# DECISION OF THE REGIONAL TRANSPORT AUTHORITY THRISSUR HELD ON 15.05.2025 AT EXECUTIVE CONFERENCE HALL, CIVIL STATION, AYYANTHOLE, THRISSUR

Heard the learned counsel appeared on behalf of the applicant. This is an application for the grant of a regular stage carriage permit on the route **Palattumuri - Medical College**(via) Chirakkal, Mangad, Vettikkadavu, Vysseri, Kunnamkulam, Chovannur, Pannithadam, Eyyal, Chiranallor, Kechery, Thalakkottukara, Veloor and Mundathikkode.While considering the application, existing en-route operators raised objections, stating that the proposed route overlaps with notified route at Kunnamkulam. Hence the decision on this application is **Adjourned** with directions to the Secretary RTA, to submit a detailed route enquiry report regarding overlapping with various schemes/notifications on the proposed route.

#### ITEM NO: 2

Heard the learned counsel appeared on behalf of the applicant. Ths is an application for the grant of a regular stage carriage permit on the route Munakkal Beach - Kodungallur (via) Marapalam, Kottikal, Manjalipalli Jn, Chaithanya Nagar, OKAY Hospital, and Chandapura. The total route length of the proposed route is 11.9 km and out of which 1.2 km overlaps on the notified route, which is 10.08% of the total route length of 11.9 km. As per clause 5(c) of G.O.(P) No. 8/2017/Trans dated 23/03/2017, the maximum permissible overlapping on notified routes will be 5 kilometers or 5% of the length of their own routes, whichever is less on the notified routes for the purpose of intersection. In this case, the overlapping distance on the notified route exceeds the permissible limit stipulated under the said G O (P) No. 8/2017/Trans dated 23/03/2017. Since no fresh stage carriage permit can be granted in violation of existing Govt orders, the application for the grant of fresh regular permit on the route Munakkal Beach - Kodungallur is hereby Rejected.

## ITEM NO: 3

Heard the learned counsel appeared on behalf of the applicant. This is an application for the grant of a regular stage carriage permit on the route **Kodungallur – Vellangallur** (via) Eriyad, Ayyappankavu, Asmabi College, Poklai, Mathilakam. The total route length of the proposed route is 25.9 km and out of which 1.7 km overlaps on the notified route, which is 6.56% of the total route length of 25.9 km. As per clause 5(c) of G.O(P) No. 8/2017/Trans dated 23/03/2017, the maximum permissible

overlapping on notified routes will be 5 kilometers or 5% of the length of their own routes, whichever is less on the notified routes for the purpose of intersection. In this case, the overlapping distance on the notified route exceeds the permissible limit stipulated under the said G O (P) No. 8/2017/Trans dated 23/03/2017. Since no fresh stage carriage permit can be granted in violation of existing Govt orders, the application for the grant of fresh regular permit on the route **Kodungallur - Vellangallur** is hereby **Rejected.** 

#### ITEM NO: 4

Heard the learned counsel appeared on behalf of the applicant. This is an application for the grant of a regular stage carriage permit on the route Kodungallur - Azhikode - Moonupeedika (via) OKAY Hospital, Cheraman, Eriyad, Anchangadi, Asmabi Poklai, College, Koolimuttam, Sujith, Moonupeedika, Perinjanam, Onaparambu, Thattungal School, Emmad, Asmabi College, Ayyappankavu, Kattan Bazar, Pathiyassery, Kunjaini, KVHS Jn., Abdulla Road and Modern Hospital. considering the application, existing en-route operators raised objections, stating that the actual overlapping distance on the notified route from Perinjanam to Moonupeedika exceeds the overlapping distance mentioned in the enquiry report. Hence, the decision on this application is Adjourned with directions to the Secretary RTA, to submit a detailed route enquiry report regarding overlapping with various schemes/notifications on the proposed route.

#### ITEM NO: 5

Heard the learned counsel appeared on behalf of the applicant. This is an application for grant of a fresh regular stage carriage permit on the route **Munakkal Beach - Mathilakam - Kodungallur** (via) Munakkal Beach, Puthanpally, Eriyad, Kara, Vazhoor temple, Pappinivattom, Mathilakam, Marapalam, Kottikkal temple, Padakulam, Manjalipally, Kodungallur Abdulla Road, Amandoor, and Ullasavalavu. While considering the application, existing en-route operators raised objections, stating that the proposed route overlaps with notified route at Mathilakam. Hence the decision on this application is **Adjourned** with directions to the Secretary RTA, to submit a detailed route enquiry report regarding overlapping with various schemes/notifications on the proposed route.

Heard the learned counsel appeared on behalf of the applicant.

- 1. Perused the judgment of Hon'ble High Court of Kerala in WP(C) No. 1342/2025 dated 23/01/2025.
- 2. This is an application for grant of a fresh regular stage carriage permit on the route **Medical College Mundur (**via) Avanoor, Manithara and Velappaya. Regular stage carriage permit **Granted** on the route **Medical College Mundur,** subject to settlement of timings.

# ITEM NO: 7

Heard the learned counsel appeared on behalf of the applicant. This is an application for the grant of a regular stage carriage permit on the route Malayan Colony Poovanchira - Medical College - Thrissur (via) Karakuzhy, Thekkinkadu, Ayode, Thanipadam, Kallidukku, Pattikkad, Mudikode, Chirakkode, Madakkathara, Vivvur Power House, Thirur, Mulamkunnathkavu, Mannuthy, East Fort and Mission Hospital. The total route length of the proposed route is 40.1 km and out of which 21.5 km overlaps on the notified route, which is 53.61% of the total route length of 40.1 km. As per clause 5(c) of G.O.(P) NO 8/2017/Trans dated 23/03/2017, the maximum permissible overlapping on notified routes will be 5 kilometers or 5% of the length of their own routes, whichever is less on the notified routes for the purpose of intersection. In this case, the overlapping distance on the notified route exceeds the permissible limit stipulated under the said G O (P) No. 8/2017/Trans dated 23/03/2017. Since no fresh stage carriage permit can be granted in violation of existing Govt orders, the application for the grant of fresh regular permit on the route Malayan Colony Poovanchira - Medical College - Thrissur is hereby Rejected.

### ITEM NO: 8

Heard the learned counsel appeared on behalf of the applicant. This is an application for grant of a fresh regular stage carriage permit on the route **Azhikode - Thriprayar** (via) Eriyad, Kara, Anchangadi, Asmabi College, Poklai, Koolimuttam, Kaipamangalam School, Chamakkala School, Kazhimbram School and Nattika School. Regular stage carriage permit **Granted** on the route **Azhikode - Thriprayar** subject to settlement of timings.

Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of the regular stage carriage permit in respect of the stage carriage **KL 46 B 0369** on the route **Thrissur-Kuttippuram** (Via) Poonkunnam, Amala, Kechery Kunnamkulam, Perumbilavu, Changaramkulam, Edappal. Since the applicant has submitted the application for the renewal of regular permit within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage **KL 46 B 0369** on the route **Thrissur-Kuttippuram** is **Granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable.

#### ITEM NO: 10

Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of the regular stage carriage permit in respect of the stage carriage KL 08 AR 9372 on the route Mundur - Panamanna (Via) Thrissur, Athani, Vazhakodu, Mullurkara, Wadakkanchery, Cheruthuruthy, Shornur, Kulapully, Ottapalam. Since the applicant has submitted the application for the renewal of regular permit within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage KL 08 AR 9372 on the route Mundur -Panamanna is Granted as ordinary service, subject to the clearance of Government dues and pending e-challans, if applicable.

## **ITEM NO: 11**

1. Heard the learned counsel appeared on behalf of the applicant. This is an application to condone the delay in submitting the application for the renewal of the regular permit in respect of stage carriage **KL 08 BH 0986**, which expired on 12.10.2024. The permit holder submitted the application for renewal only on 02.11.2024, which was less than one month after the expiry of the permit.

The permit holder submitted an application for condonation of delay, stating that the delay in submitting the renewal application for the regular permit occurred because he was looking after his father, who was a cancer patient and passed away on 07.10.2024. The request for condonation of delay is considered sympathetically. Assuming that the reasons stated in the application are true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time, as prescribed under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the

delay in submitting the renewal application for the regular permit in respect of stage carriage **KL 08 BH 0986** is hereby **condoned**.

2. This is a belated application for the renewal of the regular permit in respect of stage carriage KL 08 BH 0986 on the route Pullazhi - Chottupara for a further period of five years. Since the application was submitted after the stipulated time limit, the Secretary RTA, is directed to verify whether the vehicle continued to operate on the route, after the expiry of the regular permit. As the delay in filing the renewal application within the time frame stipulated under Section 81(2) of the Motor Vehicles Act, 1988 has been condoned, the application for renewal of the regular permit for stage carriage KL 08 BH 0986 on the route Pullazhi - Chottupara is granted as ordinary service, subject to the clearance of Government dues and pending e-challans, if applicable.

# **ITEM NO: 12**

Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of the regular stage carriage permit in respect of the stage carriage **KL 08 BY 1056** on the route **Govindapuram - Guruvayur**. Since the applicant has submitted the application for the renewal of regular permit within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage **KL 08 BY 1056** on the route **Govindapuram - Guruvayur** is **Granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable.

#### **ITEM NO: 13**

Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of the regular stage carriage permit in respect of the stage carriage **KL 08 BC 8621** on the route **Guruvayoor – Thrissur - Kuttippuram**. Since the applicant has submitted the application for the renewal of regular permit within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage **KL 08 BC 8621** on the route **Guruvayoor – Thrissur - Kuttippuram** is **Granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable.

Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of the regular stage carriage permit in respect of the stage carriage **KL 46 F 5879** on the route **Chimmini Dam - Kodungallur**. Since the applicant has submitted the application for the renewal of regular permit within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage **KL 46 F 5879** on the route **Chimmini Dam - Kodungallur** is **Granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable.

#### **ITEM NO: 15**

Heard the applicant. This is an application for the renewal of the regular stage carriage permit in respect of the stage carriage **KL 48 H 4880** on the route **Thiruvilwamala - Thanikudam**. Since the applicant has submitted the application for the renewal of regular permit within the timeframe as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage **KL 48 H 4880** on the route **Thiruvilwamala - Thanikudam** is **Granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable.

#### **ITEM NO: 16**

1. Heard the learned counsel appeared on behalf of the applicant. This is an application to condone the delay in submitting the application for the renewal of the regular permit in respect of stage carriage **KL 45 D 4575**, which expired on 19.12.2024. The permit holder submitted the application for renewal only on 30.12.2024, which was less than one month after the expiry of the permit.

The permit holder submitted an application for condonation of delay, accompanied by a medical certificate issued by Dr. C.M. Davis, Consultant Physician, T.C.M.C. Reg. No. 13866, Parappukkara, stating that the delay in submitting the renewal application for the regular permit occurred because he was undergoing medical treatment. The request for condonation of delay is considered sympathetically. Assuming that the reasons stated in the application are true and genuine, it is found that the applicant was prevented by good and sufficient cause from

submitting the application within the time prescribed under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the renewal application for the regular permit in respect of stage carriage **KL 45 D 4575** is **condoned**.

2. This is a belated application for the renewal of the regular permit in respect of stage carriage **KL 45 D 4575** for a further period of five years. Since the application was submitted after the stipulated time limit, the Secretary RTA, is directed to verify whether the vehicle continued to operate on the route after the expiry of the regular permit. As the delay in filing the renewal application within the timeframe stipulated under Section 81(2) of the Motor Vehicles Act, 1988 has been condoned, the application for renewal of the regular permit for stage carriage **KL 45 D 4575** on the route **Moozhikkakadavu** - **Irinjalakuda** is **granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable.

## **ITEM NO: 17**

Heard the applicant. This is an application for the renewal of the regular stage carriage permit in respect of the stage carriage **KL 59 L 9779** on the route **Pampady - Pullazhy.** Since the applicant has submitted the application for the renewal of regular permit within the timeframe as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage **KL 59 L 9779** on the route **Pampady - Pullazhy** is **Granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable.

#### **ITEM NO: 18**

Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of the regular stage carriage permit in respect of the stage carriage **KL 08 BA 4242** on the route **Thriprayar - Thrissur.** Since the applicant has submitted the application for the renewal of regular permit within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage **KL 08 BA 4242** on the route **Thriprayar -Thrissur** is **Granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable.

1. Heard the learned counsel appeared on behalf of the applicant. This is an application to condone the delay in submitting the application for the renewal of the regular permit in respect of stage carriage **KL 48 J 1717**, which expired on 27.04.2024. The permit holder submitted the application for renewal only on 30.05.2024, which was more than one month after the expiry of the permit.

The permit holder submitted an application for condonation of delay, accompanied by a medical certificate issued by Dr. K S Rajithan Reg No.5829, Superintendent, Oushadhi Panchakarma Hospital & Research Institute, Thrissur, stating that the delay in submitting the renewal application for the regular permit occurred because he was undergoing medical treatment. The request for condonation of delay is considered sympathetically. Assuming that the reasons stated in the application are true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time prescribed under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the renewal application for the regular permit in respect of stage carriage **KL 48 J 1717** is **condoned**.

3. This is a belated application for the renewal of the regular permit in respect of stage carriage **KL 48 J 1717** for a further period of five years. Since the application was submitted after the stipulated time limit, the Secretary RTA, is directed to verify whether the vehicle continued to operate on the route after the expiry of the regular permit. As the delay in filing the renewal application within the time frame stipulated under Section 81(2) of the Motor Vehicles Act, 1988 has been condoned, the application for renewal of the regular permit for stage carriage **KL 48 J 1717** on the route **Shornur - Wadakkanchery** is **granted** as **ordinary service**, subject to the clearance of Government dues and pending e-challans, if applicable

# ITEM NO: 20

1. Heard the learned counsel appeared on behalf of the applicant. This is an application to condone the delay in submitting the application for the renewal of the regular permit in respect of stage carriage **KL-08-AT-8315**, which expired on 11.02.2025. The permit holder submitted the application for renewal only on 11.02.2025, which was on the date of the expiry of the permit.

The legal heiress of permit holder submitted an application for condonation of delay, accompanied by a medical certificate issued by Dr. P.K.Moideen, Rtd. Civil Surgeon, Reg no.3059,

Ayyanthole P O Thrissur, stating that the delay in submitting the renewal application for the regular permit occurred because she was undergoing medical treatment. The request for condonation of delay is considered sympathetically. Assuming that the reasons stated in the application are true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time prescribed under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the renewal application for the regular permit in respect of stage carriage **KL-08-AT-8315** is **condoned**.

- 2. This is a belated application for the renewal of the regular permit in respect of stage carriage KL-08-AT-8315 submitted by the legal heiress for a further period of five years. Since the application was submitted after the prescribed time limit, the Secretary RTA, is directed to verify whether the vehicle continued to operate on the route after the expiry of the regular permit. As the delay in filing the renewal application within the time frame stipulated under Section 81(2) of the Motor Vehicles Act, 1988 has been condoned, the application for renewal of the regular permit for stage carriage KL-08-AT-8315 on the route Chakkyarkadavu Thrissur is granted as ordinary service, subject to the clearance of Government dues and pending e-challans, if applicable.
  - 3. This is an application for the transfer of a regular permit (due to the death of the permit holder) in respect of the stage carriage **KL-08-AT-8315** on the route **Chakkyarkadavu Thrissur**. Transfer of the regular permit (due to the death of the permit holder) is **Granted** to the name of the legal heiress, Smt Jayanthi from the name of the deceased permit holder, Sri Sasidharan, subject to the clearance of Government dues and pending e-challans, if applicable.

#### **ITEM NO: 21**

1. Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of the regular permit in respect of the stage carriage KL 17 D 7611 submitted by the legal heir on the route Varakkara - Irinjalakuda. Since the applicant has submitted the application for the renewal of regular permit within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage KL 17 D 7611 on the route Varakkara - Irinjalakuda is Granted as ordinary service, subject to the clearance of Government dues and pending e-challans, if applicable.

2. This is an application for the transfer of a regular permit (due to the death of the permit holder) in respect of the stage carriage **KL 17 D 7611** on the route **Varakkara - Irinjalakuda**. Transfer of the regular permit (due to the death of the permit holder) is **Granted** to the name of the legal heir, Sri. Detty T D from the name of the deceased permit holder, Sri Devassy T A, subject to the clearance of Government dues and pending e-challans if applicable.

## **ITEM NO: 22**

- 1. Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of the regular permit in respect of the stage carriage KL 08 CB 3651 submitted by the legal heir on the route Kallampara Panamanna. Since the applicant has submitted the application for the renewal of regular permit within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of the stage carriage KL 08 CB 3651 on the route Kallampara-Panamanna is Granted as ordinary service, subject to the clearance of Government dues and pending e-challans, if applicable.
- 2. This is an application for the transfer of a regular permit (due to the death of the permit holder) in respect of the stage carriage **KL 08 CB 3651** on the route **Kallampara Panamanna**. The transfer of the regular permit (due to the death of the permit holder) is **Granted** to the name of the legal heir, Sri Vibin Varghese from the name of the deceased permit holder, Smt. Annamma Varghese, subject to the clearance of Government dues and pending e-challans if applicable.

#### **ITEM NO: 23**

- **1.** Perused the Judgment of Hon. STAT in MVAA 17/2016 dated 29/04/2023
- 2. Heard the learned counsel appeared on behalf of the applicant. This is an application for the renewal of regular stage carriage permit in respect of the stage carriage KL 08 N 9394 (Leased Vehicle) on the route Thrissur Azhikode. The validity of regular permit expired on 25.12.2008 and the application for renewal of permit was submitted within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988. This vehicle is under hire-purchase/hypothecation agreement with Thrissur District Motor Transport Owner's Co-Operative Society Ltd. No 856, Thrissur. The applicant submitted the application for Renewal of permit in form PRA without accompanying the NOC from the financier.

As per Kerala Motor Vehicles Rules 172(2) "Application for renewal of permit shall be in form 'PRA' and shall be accompanied by the permit where the Motor vehicle is subject to a hire-purchase, lease or hypothecation agreement, the certificate or communication, or as the case may be, the declaration referred to in sub section (8) of Section 51 of the Act".

The financier, Thrissur District Motor Transport Owners' Co-operative Society Ltd. No. 856, Thrissur, raised a strong objection before this Authority against renewing the regular permit for this stage carriage, stating that the applicant is in default under the provisions of the hypothecation agreement.

As per Section 51(9) of Motor Vehicle Act, 1988 "On receipt of an application for the renewal of any permit or for the issue of duplicate certificate of registration or for assignment of a new registration mark in respect of a vehicle which is held under the said agreement, the appropriate authority may, subject to the other provisions of this Act-

- (a) In a case where the financier has refused to issue the certificate applied for, after giving the applicant an opportunity of being heard, either –
- (i) Renew or refuse to renew the permit."

Since the applicant has failed to submit the NOC from the financier, the application for the renewal of the regular permit for the stage carriage **KL 08 N 9394** on the route **Thrissur - Azhikode** is hereby **Rejected** by invoking the provisions of Section 51(9)(a)(i) of the Motor Vehicles Act, 1988, and Rule 172(2) of the Kerala Motor Vehicles Rules, 1989

3. This is an application for replacement of stage carriage KL 08 N 9394 (Leased Vehicle) with a later model vehicle KL 17 E 4266 on the route Thrissur - Azhikode. The lease agreement in respect of KL 08 N 9394 ceased to be effective from 13.09.2011.

As per section 83 of Motor Vehicle Act 1988 "The holder of the permit may, with the permission of the authority by which the permit was granted, replace any vehicle covered by the permit by any other vehicle of the same nature."

As per Rule 174 (2) of Kerala Motor Vehicles Rules 1989 "Upon receipt of the application, the Transport Authority may in his discretion, reject the application."

(d) "if the holder of permit has contravened the provisions thereof or has been deprived of possession of the old vehicle under the provisions of any agreement of hire purchase, hypothecation or lease"

Since the renewal of the regular permit for stage carriage KL-08-N-9394 on the Thrissur – Azhikode route has

been rejected, the applicant is no longer a permit holder, and the lease agreement ceased to be effective from 13.09.2011. In view of these facts, the application for replacement of stage carriage KL-08-N-9394 with another stage carriage, KL-17-E-4266, is hereby **Rejected** under the provisions of Section 83 of the Motor Vehicles Act, 1988, and Rule 174(2) of the Kerala Motor Vehicles Rules, 1989.

**4.** These are applications for the renewal of the regular permit for the subsequent periods from 26.12.2013 to 25.12.2018, 26.12.2018 to 25.12.2023, and 26.12.2023 to 25.12.2028. Since no valid regular permit is currently in existence, the applications for renewal of the regular permit in respect of stage carriage KL-08-N-9394 on the Thrissur – Azhikode route for these periods are hereby **Rejected**.

# **ITEM NO: 24**

Heard the learned counsel appeared on behalf of the applicant. This is an application for variation of regular permit in respect of stage carriage **KL 44 A 1649** operating on the route **Azhikode - Puthenvelikkara** (Via) Eriyad, Chandappura, Kodungallur, Undekkadavu, Kottappuram, Kottakkadavu Bridge Kottikkal, Padakulam as Ordinary Service. Since the proposed variation is beneficial to commuters, the following variation of trips is **Granted**, subject to the settlement of timings for the various trips.

The permit holder submitted the application for the renewal of regular permit on 01.02.2024. This Authority in its meeting held on 13.08.2024 vide item no:9 granted the renewal of regular permit subject to the following conditions:

- 1. Production of NOC from the financier, if applicable.
- 2. Remittance of Motor Vehicle Tax and clearance of any dues, if any.
- 3. Remittance of the required fees.

The decision of this Authority was communicated to the grantee on 25.10.2024, requiring the production of the current records of the stage carriage KL-07-AM-1020. However, instead of submitting the current records of KL-07-AM-1020, the grantee submitted the documents of another vehicle, KL-45-A-3360, along with a request to endorse the renewal of the regular permit granted by this Authority to that vehicle.

Since the grantee failed to produce the current records of KL-07-AM-1020, a further communication was issued, directing the grantee to produce the same for endorsing the renewal of the permit already granted. As the grantee did not submit the current records within the time stipulated under Rule 172(3) of

the Kerala Motor Vehicles Rules, 1989, the renewal of the regular permit in respect of KL-07-AM-1020, operating on the Kodungallur – Maniyankav route, was not endorsed. Consequently, the grantee is not considered a holder of a valid permit.

As per section 83 of Motor Vehicle Act 1988,

"The holder of a permit may, with the permission of the authority by which the permit was granted, replace any vehicle covered by the permit by any other vehicle of the same nature."

In the above circumstances, it is evident that the applicant is not a holder of a valid permit. Hence, the application for replacement of the vehicle KL-45-A-3360, on the renewal of the regular permit granted by this Authority on 13.08.2024 in respect of stage carriage KL-07-AM-1020 on the route Kodungallur – Maniyankav, is hereby **Rejected**.

**3.** This is an application to endorse the renewal of regular permit, granted by the RTA on 13.08.2024, to the stage carriage KL 45 A 3360, which is proposed for replacement with KL 07 AM 1020

As per Rule 172(3)(a) of Kerala Motor Vehicles Rules 1989, Production of permit. -

"The Transport Authority sanctioning an application for renewal of a permit shall call upon the permit and holder to produce the Registration Certificate of the vehicle and endorse the renewal in the permit and return them to the holder. The Transport Authority may revoke its sanction of the application for renewal if the permit holder fails to produce the documents aforesaid within one month from the date of despatch of the order requiring the production of the records"

Since the grantee failed to produce the current records within the stipulated period of one month or the aggregate period of four months, from the date of despatch of the decision of this Authority as specified under Rule 172(3) of Kerala Motor Vehicles Rule 1989, the decision of this authority dated 13.08.2024, granting the renewal of regular permit in respect of the stage carriage **KL 07 AM 1020** on the route **Kodungallur – Maniyankav** is hereby **Revoked** by invoking the provisions in Rule 172(3) of Kerala Motor Vehicles Rule 1989. Consequently, the application to endorse the renewal of regular permit, granted by this Authority on 13.08.2024, to the stage carriage KL 45 A 3360, which is proposed for replacement with KL 07 AM 1020is hereby **Rejected.** 

- **1.** Perused the judgment of Hon'ble High Court in WP(C)No.5908/2025 dated 18.02.2025
- 2. This is an application for replacement of vehicle **KL 46 U 5395** (under lease agreement) on the renewal of the regular permit granted by this Authority in the meeting held on 13.08.2024 for the stage carriage **KL 10 X 568** on the route **Wadakanchery Pavaratty.**

The stage carriage KL 10 X 568 was having regular permit on the route Wadakanchery - Pavaratty, valid until 15.11.2021. The permit holder submitted the application for the renewal of regular permit on 13.10.2021. This Authority in its meeting held on 13.08.2024 vide item no:11 granted the renewal of regular permit subject to the following conditions:

- 1. Production of NOC from the financier, if applicable.
- 2. Remittance of Motor Vehicle Tax and clearance of any dues, if any.
- 3. Remittance of the required fees.

The decision of this Authority was communicated to the grantee on 11.11.2024, requiring the production of the current records of the stage carriage KL 10 X 568. However, instead of submitting the current records of KL 10 X 568, the grantee submitted the documents of another vehicle, KL 46 U 5395, along with the application for replacement of the vehicle and request to endorse the renewal of the regular permit granted by this Authority to that vehicle.

Since the grantee failed to produce the current records of KL 10 X 568, a further communication was issued, directing the grantee to produce the same for endorsing the renewal of the permit already granted. As the grantee did not submit the current records within the time stipulated under Rule 172(3) of the Kerala Motor Vehicles Rules, 1989, the renewal of the regular permit in respect of KL10X568, operating on the route Wadakanchery - Pavaratty, was not endorsed. Consequently, the grantee is not considered a holder of a valid permit.

As per section 83 of Motor Vehicle Act 1988,

"The holder of a permit may, with the permission of the authority by which the permit was granted, replace any vehicle covered by the permit by any other vehicle of the same nature."

In the above circumstances, it is evident that the applicant is not a holder of a valid permit. Hence, the application for replacement of the vehicle KL 46 U 5395, on the renewal of the regular permit granted by this Authority on 13.08.2024 in

respect of stage carriage KL 10 X 568 on the route Wadakanchery - Pavaratty, is hereby **Rejected**.

**3.** This is an application to endorse the renewal of regular permit, granted by the RTA on 13.08.2024, to the stage carriage KL 46 U 5395, which is proposed for replacement with KL 10 X 568.

As per Rule 172(3)(a) of Kerala Motor Vehicles Rules 1989, Production of permit. -

"The Transport Authority sanctioning an application for renewal of a permit shall call upon the permit and holder to produce the Registration Certificate of the vehicle and endorse the renewal in the permit and return them to the holder. The Transport Authority may revoke its sanction of the application for renewal if the permit holder fails to produce the documents aforesaid within one month from the date of despatch of the order requiring the production of the records"

Since the grantee failed to produce the current records within the stipulated period of one month or the aggregate period of four months, from the date of despatch of the decision of this Authority as specified under Rule 172(3) of Kerala Motor Vehicles Rule 1989, the decision of this authority dated 13.08.2024, granting the renewal of regular permit in respect of the stage carriage **KL 10 X 568** on the route **Wadakanchery - Pavaratty** is hereby **Revoked** by invoking the provisions in Rule 172(3) of Kerala Motor Vehicles Rule 1989. Consequently, the application to endorse the renewal of regular permit, granted by this Authority on 13.08.2024, to the stage carriage KL 46 U 5395 (under lease agreement), which is proposed for replacement with KL 10 X 568 is hereby **Rejected.** 

#### **ITEM NO: 55**

1. Heard the applicant. This is an application to condone the delay in submitting the application for the renewal of the contract carriage permit in respect of auto rickshaw **KL 08 X 2640**, which expired on 14.10.2021. The permit holder submitted the application for renewal only on 08.11.2024, which was more than three years after the expiry of the permit.

Along with the renewal application, he has submitted a medical certificate from Dr Geevar Zachariah A, MD, DM (Cardiology) Reg.No.7433, Mother Hospital, Pullazhi, Thrissur - 680002, stating that the delay in submitting the renewal application for the regular permit occurred because he was

undergoing medical treatment. The request for condonation of delay in submitting the renewal application is considered sympathetically.

Assuming the reasons stated in the application and the medical certificate to be true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time specified under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the application for the renewal of the contract carriage permit in respect of auto rickshaw KL 08 X 2640 is **condoned**.

2. This is a belated application for the renewal of the contract carriage city permit in respect of auto rickshaw KL 08 X 2640 for a further period of five years. Since the delay for filing the application for renewal of permit, within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988 is condoned, the application for the renewal of the contract carriage permit in respect of auto rickshaw KL 08 X 2640 is Granted, subject to the remittance of a compounding fee of rupees three thousand and clearance of Government dues and pending e-challans, if applicable.

#### **ITEM NO: 56**

1. Heard the applicant. This is an application to condone the delay in submitting the application for the renewal of the contract carriage permit in respect of auto rickshaw **KL 46 E 1764**, which expired on 29.05.2021. The permit holder submitted the application for renewal only on 30.10.2024, which was more than three years after the expiry of the permit.

Along with the renewal application, he has submitted a medical certificate from Dr. Rageena, Assistant Surgeon, Community Health Centre, Mullassery, Thrissur - 680509 stating that the delay in submitting the renewal application for the regular permit occurred because he was undergoing medical treatment. The request for condonation of delay in submitting the renewal application is considered sympathetically.

Assuming the reasons stated in the application and the medical certificate to be true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time specified under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the application for the renewal of the contract carriage permit in respect of auto rickshaw KL 46 E 1764 is **condoned**.

2. This is a belated application for the renewal of the contract carriage city permit in respect of auto rickshaw KL 46 E 1764 for a further period of five years. Since the delay for filing the application for renewal of permit, within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988 is condoned, the application for the renewal of the contract carriage permit in respect of auto rickshaw **KL 46 E 1764** is **Granted**, subject to the remittance of a compounding fee of rupees three thousand and clearance of Government dues and pending e-challans, if applicable.

#### **ITEM NO: 57**

1. Heard the learned counsel appeared on behalf of the applicant. This is an application to condone the delay in submitting the application for the renewal of the contract carriage permit in respect of auto rickshaw **KL 46 F 7839**, which expired on 21.01.2024. The permit holder submitted the application for renewal only on 13.03.2025, which was more than one year after the expiry of the permit.

Along with the renewal application, he has submitted a medical certificate from Dr. Prajeesh, BAMS, Reg No.14340, Susrutha Ayurveda Chikilsalayam, Mullurkara stating that the delay in submitting the renewal application for the regular permit occurred because he was undergoing medical treatment. The request for condonation of delay in submitting the renewal application is considered sympathetically.

Assuming the reasons stated in the application and the medical certificate to be true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time specified under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the application for the renewal of the contract carriage permit in respect of auto rickshaw KL 46 F 7839 is **condoned**.

2. This is a belated application for the renewal of the contract carriage city permit in respect of auto rickshaw KL 46 F 7839 for a further period of five years. Since the delay for filing the application for renewal of permit, within the time frame as stipulated under Section 81(2) of Motor Vehicles Act 1988 is condoned, the application for the renewal of the contract carriage permit in respect of auto rickshaw KL 46 F 7839 is Granted, subject to the remittance of a compounding fee of rupees three thousand and clearance of Government dues and pending e-challans, if applicable.

Considering the request of the grantee, the decision of this authority dated 07.03.2023,

granting the variation of regular permit in respect of the stage carriage KL 57 H 1017 on the route Irinjalakuda – Kombathukadavu – Kodungallur – Chirakkal is hereby Revoked.

## <u>ITEM NO: 75</u>

- 1. Heard the learned counsel appeared on behalf of the applicants. The transfer of regular permit in respect of the stage carriage KL 59 C 5335 (Replaced by KL 08 BH 3830) operating on the route Thrissur -Ottapalam was granted by the RTA in its meeting held on 17.09.2022 from the name of Sri.
