
Heard the learned counsel appeared for the applicant. This is an application for the grant of renewal of regular permit in respect of Stage Carriage KL-02-AD-5677 for conducting service on the route Mevaram-Kallumthazham. Since the applicant has submitted the application for the renewal of regular permit within the time stipulated in section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of this stage carriage KL-02-AD-5677 on the route Mevaram-Kallumthazham is Granted subject to clearance of Mvs.tax , Govt.dues and pending e-challans if any

ITEM NO : 02

Heard the learned counsel appeared for the applicant. This is an application for the grant of renewal of regular permit in respect of Stage Carriage KL-02-AN-5477 for conducting service on the route Mevaram-Kallumthazham. Since the applicant has submitted the application for the renewal of regular permit within the time stipulated in section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of this stage carriage KL-02-AN-5477 on the route Mevaram-Kallumthazham is Granted subject to clearance of Mvs.tax , Govt.dues and pending e-challans if any



This is an application to condone the delay in submitting the application for the renewal of the regular permit in respect of stage carriage KL-05-T-6399, which expired on 15/08/2024. The permit holder submitted the application for renewal only on 14/08/2024, which was one days before the expiry of the permit.

The permit holder submitted an application for condonation of delay, accompanied by a medical certificate issued by Dr. Dushanthan V, Madathil Hospital, Ayirakuzhi, Reg No 6327, stating that the delay in submitting the renewal application for the regular permit occurred because he was undergoing medical treatment. The request for condonation of delay is considered sympathetically. Assuming that the reasons stated in the application are true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time prescribed under Section 81(2) of the Motor Vehicles Act, 1988. 
ITEM NO : 09

ITEM NO : 10

1, Heard the learned counsel appeared on behalf of the applicant. This is an application to condone the delay in submitting the application for the renewal of the regular permit in respect of stage carriage KL-02-AD-8930 which expired on 19/08/2024. The permit holder submitted the application for renewal only on 24/09/2024, which was 35 days after the expiry of the permit.



Assuming that the reasons stated in the application are true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time prescribed under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the renewal application for the regular permit in respect of stage carriage KL-02-AD-8930 is condoned.

This vehicle is hypothecated to Hinduja Leyland Finance Company, Cochin. As per Rule 172(2) of Kerala Motor Vehicles Rules 1989, an application for renewal of permit shall comply with the provision of sub section (8) of section 51 of Motor Vehicles Act.

On 18/03/2025 the permit holder has filed a request to issue the renewal of regular permit. Along with the application he has submitted the communication letter sent to the financier Hinduja Leyland Finance Company Ltd and they have not respond to the letter to till the date. The financier has not responded to the letter even after fifteen days. Within seven days of the receipt of an application under sub-section (6) of section 51 of Motor Vehicles Act, the financier may issue, or refuse, for reasons which shall be recorded in writing and communicated to the applicant, to issue, the certificate applied for, and where the financier fails to issue the certificate and also fails to communicate the reasons for refusal to issue the certificate to the applicant within the said period of seven days, the certificate applied for shall be deemed



to have been issued by the financier. In this circumstances this authority viewed that the renewal of permit in respect of the stage carriage KL-02-AU-9688 conducting service on the route Puthayam – Kollam is inevitable, since the application for renewal of the regular permit for stage carriage KL-02-AU-9688 on the route Puthayam – Kollam is granted as ordinary service subject to clearance of Mvs.tax, Govt.dues and pending e-challans if any

ITEM NO : 12

Heard the learned counsel appeared for the applicant. This is an application for the grant of renewal of regular permit in respect of Stage Carriage KL-02-BK-8677 for conducting service on the route Mevaram - Kavanad. Since the applicant has submitted the application for the renewal of regular permit within the time stipulated in section 81(2) of Motor Vehicles Act 1988, the renewal of regular permit in respect of this stage carriage KL-02-BK-8677 on the route Mevaram - Kavanad is Granted subject to clearance of Mvs.tax, Govt.dues and pending e-challans if any.

ITEM NO : 13

Heard the learned counsel appeared for the applicant. This is an application for the grant of renewal of regular permit in respect of the Stage Carriage KL-05-T-9023 on the route Orunada – Vilakkupara for a period of five years as ordinary service. This is an intra district route having a distance of 20.6 Kms, out of which the route portion from Anchal RO Junction to Yeroor for a distance 3.9 Kms overlaps on the partial exclusion scheme Kayamkulam-Kulathupuzha and Kayamkulam – Punalur vide G.O.MS 156/67/PW dated 27/07/1967. The regular permit is issued on 01/11/2018 which is valid up to 31/10/2023, and since the application for renewal of permit is pending for decision, this stage carriage is continuing service on this route under section87(1)(d) of MV Act 1988. As a part of the route lies on the partial exclusion scheme Kayamkulam-Kulathupuzha and Kayamkulam – Punalur for a distance of 3.9 Kms, KSRTC strongly objected the grant of renewal of regular permit stating that, as per the clause 4, 5 and 7 of the Notification No. G.O.MS156/67/PW dated.27/07/1967, only 24 private operators are described in the Appendix B list attached to the notification is allowed to operate on the scheme routes, and also stated that since the stage carriage KL-05-T-9023 is not an existing stage carriage as per the Appendix B list attached to the above notification, the granting of renewal of regular permit is a clear violation of Kayamkulam-Punalur and Kayamkulam -Kulathupuzha partial exclusion scheme vide



Notification No. G.O.MS 156/67/PW dated.27/07/1967. In the above circumstances Adjourned with the direction to the Secretary RTA to bring the matter before the Government for seeking clarification regarding to the grant of renewal of the regular permits existing on this route, in order to ensure efficient and adequate public transportation facilities. Hence Secretary RTA is authorised to issue temporary permit under section 87(1)(d) on the route Orunada – Vilakkupara till the disposal of the renewal of permit application.


ITEM NO : 14



Upasana Clinic, Chakkavarakkal , Kollam, stating that the delay in submitting the renewal application for the regular permit occurred because he was undergoing medical treatment. The request for con donation of delay is considered sympathetically. Assuming that the reasons stated in the application are true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time prescribed under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the renewal application for the regular permit in respect of stage carriage KL-29-1222 is condoned

2, Heard the learned counsel appeared for the applicant. This is an application for the grant of renewal of regular permit in respect of the KL-29-1222 on the route Manalippacha-Edamon Railway Station for a period of five years as ordinary service. This is an intra district route having a distance of 31 Kms, out of which the route portion from Punalur to Anchal for a distance 12.5 Kms overlaps on the partial exclusion scheme Kayamkulam-Kulathupuzha and Kayamkulam – Punalur vide G.O.MS 156/67/PW dated 27/07/1967. The regular permit is issued on 10/02/2000 which is valid up to 09/02/2025, and since the application for renewal of permit is pending for decision, this stage carriage is continuing service on this route under section87(1)(d) of MV Act 1988. As a part of the route lies on the partial exclusionscheme Kayamkulam- Kulathupuzha and Kayamkulam – Punalur for a distance of 3.9 Kms, KSRTC strongly objected the grant of renewal of regular permit stating that, as per the clause 4, 5 and 7 of the Notification No. G.O.MS 156/67/PW dated.27/07/1967, only 24 private operators are described in the Appendix B list attached to the notification is allowed to operate on the scheme routes, and also stated that since the stage carriage KL-29-1222 is not an existing stage carriage as per the Appendix B list attached to the above notification, the granting of renewal of regular permit is a clear violation of Kayamkulam-



Punalur and Kayamkulam -Kulathupuzha partial exclusion scheme vide Notification No. G.O.MS 156/67/PW dated.27/07/1967.In the above circumstances Adjourned with the direction to the Secretary RTA to bring the matter before the Government for seeking clarification regarding to the grant of renewal of the regular permits existing on this route, in order to ensure efficient and adequate public transportation facilities. Hence Secretary RTA is authorised to issue temporary permit under section 87(1)(d) on the route Manalippacha-Edamon Railway Station till the disposal of the renewal of permit application.

The request for con donation of delay is considered sympathetically. Assuming that the reasons stated in the application are true and genuine, it is found that the applicant was prevented by good and sufficient cause from submitting the application within the time prescribed under Section 81(2) of the Motor Vehicles Act, 1988. Therefore, the delay in submitting the renewal application for the regular permit in respect of stage carriage KL-11-Z-1535 is condoned

This vehicle is hypothecated to Stae Bank of India, Main Brach, Kollam. As per Rule 172(2) of Kerala Motor Vehicles Rules 1989, an application for renewal of permit shall comply with the provision of sub section (8) of section 51 of Motor Vehicles Act.


On 14.07.2023 the registered owner submitted a request before the secretary, RTA stating that the stage carriage KL-02-R-2925 is hypothecated



with State Bank of India, Main branch, Kollam. But the bank authorities are not issuing Non Objection Certificate for his vehicle; reason that he is not a customer of the bank and as per bank records the bank has no connection with his vehicle. The bank authorities also informed that they cannot issue written documents regarding this. Hence the Registered owner requested secretary, RTA to remove the hypothecation endorsed in the Registration Certificate in respect of the stage carriage KL-02-R-2925. Since the permit holder failed to produce the NOC from the financier, on 23.09.2024 communication was sent to the financier State Bank of India, Main branch, Kollam through RPAD by seeking objection if any regard to the termination of hypothecation in respect of the stage carriage KL-02-R-2925. Eventhough acknowledgement card received on 28.09.2024 and no reply has been received till date in this regard. The financier has not responded to the letter even after fifteen days. Within seven days of the receipt of an application under sub-section (6) of section 51 of Motor Vehicles Act, the financier may issue, or refuse, for reasons which shall be recorded in writing and communicated to the applicant, to issue, the certificate applied for, and where the financier fails to issue the certificate and also fails to communicate the reasons for refusal to issue the certificate to the applicant within the said period of seven days, the certificate applied for shall be deemed to have been issued by the financier. In this circumstances this authority viewed that the renewal of permit application is inevitable since the renewal of regular permit in respect of this stage carriage KL-02-R-2925 on the route Ayoor-Kadakkal is Granted subject to clearance of Mvs.tax, Govt.dues and pending e-challans if any.

ITEM NO :23

1, Heard the learned counsel appeared for the applicant, This is an application dated 30/09/2022 for renewal of permit in respect of stage carriage KL-03-J-3233 authorized to operate on the intra-district route Ashtamudi-Nedumankavu on the strength of regular permit valid up to 16/10/2022. The vehicle is non-operational on the above route for almost 3 years. The explanation submitted by the permit holder for non-operation is acceptable. On 18/11/2024 the permit holder requesting sanction to remit the arrear tax from 01/04/2020 through one time settlement scheme and permitted to remit the arrear tax through one time settlement scheme and the arrear tax up to 31/03/2025 has been cleared by the permit holder and the fee for renewal of permit remitted on 09/01/2025. The mechanical condition and possession of the vehicle is enquired through the circle officer. As per the report dated 03/01/2025 of the circle officer, the mechanical condition of the vehicle is



efficient and the vehicle is under the possession of the permit holder. Since the applicant has submitted the application for the renewal of regular permit within the time stipulated in section 81(2) of Motor Vehicles Act 1988. Under the circumstances the application for renewal of permit is granted subject to the production of current records in respect of the stage carriage KL-03-J-3233 and to clearance of Mvs.tax, Govt.dues and pending e-challans if any.

2, Heard the learned counsel appeared for the applicant .This authority viewed that the permit in respect of vehicle No KL-03-J-3233 had expired way back on 16/10/2022. The route bus KL-03-J-3233 having attained the age of 22 years had become out modelled on 03/07/2025 Replacement application was filed on 05/07/2025 by which time the incoming vehicle had attained the age of 20 years and 4 months. The said vehicle is an old junk, condemned and replaced one being unfit for further use. The suitability of vehicle has to be ensured by a team of inspectors to ensure the minimum standards of safety and comforts of passengers. This Authority directing secretary to ascertain the above mentioned vehicle is fit for public transport purpose. Replacement will be considered in the next meeting of this authority on receipt of the inspection report as suggested above.



Since the grantee has failed to produce the current records within the time specified, the grant of renewal of regular permit in respect of the stage carriage KL-17-C-3651 on the route Odanavattam-Kundara Elampalloor is revoked invoking the provisions in Rule 159(2) of Kerala Motor Vehicles Rule 1989.

Moreover as per the enquiry report of the field officer, by considering the frequency of other services on the overall route length, there is no urgent necessity exists to meet a particular temporary need under section 87(1) (c) of MV Act 1988 on the route Varkala Temple - Punalur.



Hon'ble High Court of Kerala in Mohanan vs RTA -2000- KHC 390: 2000 (2) KLT 485: 2000 (1) KL 819 observed that temporary need is a sine qua non for granting temporary permit.

In MPSRTC, Bhopal vs RTA Sagar AIR 1974 MP 22 it was observed that each time the authority in granting temporary permit must determine itself about the existence of a particular temporary need objectively.

Moreover as per the enquiry report of the field officer, by considering the frequency of other services on the overall route length, there is no urgent necessity exists to meet a particular temporary need under section 87(1) (c) of MV Act 1988 on the route Umannoor-Purambil.



Considering the total length of 17 Kms overlapping comes to 11% of the total length. Hence violation of clause 5(c) of G.O(P)No.08/2017 trans dated 23/03/2017.

As per the enquiry report it is found that the route portion from Chinnakkada to Vellimon Jn is well served by other private stage carriages and KSRTC and the frequency of services is less than 10 minutes. Moreover as per the enquiry report of the field officer, by considering the frequency of other services on the overall route length, there is no urgent necessity exists to meet a particular temporary need from the portion from Chinnakkada to Vellimon Jn but necessity exists for the portion from vellimon Jn to Vellimon under section 87(1) (c) of MV Act 1988 on the route Varkala Temple - Punalur.



Hon'ble High Court of Kerala in Mohanan vs RTA -2000- KHC 390: 2000 (2) KLT 485: 2000 (1) KL 819 observed that temporary need is a sine qua non for granting temporary permit.



Perused the the request for granting fresh city permits to autorickshaws within the corporation limit without enhancing the existing number of 5000. Corporation secretary was intimated to furnish a request to enhance the limit of city permits from 5000 to 6000. Minutes of the traffic regulatory committee held on 01/02/2025 has been received in this office wide letter No. TP6 132904-2025 DTD 28/03/2025 and 25/04/2025. As per the minutes the traffic regulatory committee, it has decided to grant 937 city permits without exceeding the existing limit of 5000 numbers. In this circumstances , this authority closely examined the matter and granted 937 city permits without exceeding the existing limit of 5000 numbers subject to the condition that the new permits will be granted to vehicles operating with Electrical, CNG, LNG

ITEM NO :184

DEPARTMENTAL ITEM-01

The representative of KSRTC, various associations of the bus operators, members of the public and counsel participated in the deliberations on the subject dealt with in agenda No.1 of this meeting some of the participants put in writing their representations for and against the subject matter , a few of which are stated below in brief.

- ❖ Letter No B1/87/2025 dated 25/06/2025 of the special secretary, Transport is not a notification required under the provisions of section 67(1) of the M V Act capable of directing the STA/RTA to revise the time schedules to achieve road safety. Voluntary installation of GPS and Geo fencing system and preferential allotment of timings by auction procedure are not favoured by most of the bus operators.



- ❖ No circumstances have emerged demanding the re-scheduling of timings of buses in the state without there being a scientific study as to its feasibility as well as propriety and legality.
- ❖ In the absence of necessary infrastructure such as bus bays, bus stops, time punching stations etc... implementation of the proposed exercise may not be possible according to some stake holders..
- ❖ Allotment of five minutes or ten minutes of time space as the case may be, for each bus in Kollam city limit is a welcome suggestion and said proposal is supported by most of the participants but with little hope.
- ❖ Entry of mofussil services in to the city roads/urban area, if prohibited, would achieve advancement of public safety and ease of operation , according to city bus operators.
- ❖ Issue of new permits both in urban and panchayath areas shall be suspended until the proposal in question is approved and given effect to
- ❖ All the 503 bus routes formulated by the government shall be fastened with specific time schedules in terms of 5 or 10 minutes time gap and shall be allotted to the prospective operators, if necessary by auction proceedings.
- ❖ Yet another demand is that morethan 200 old junks, without valid registration or certificate of fitness owned by the KSRTC in violation of the Central Government. Mandate shall be withdrawn from the roads to achieve public safety and convenience.

On a conspectus of the statutory provisions of section 67(1),68(3), Rule 212 and the recommendations of the amicus curiae this authority is pleased to resolve,

- a) Not to entertain applications for fresh stage carriage permits or variation of permit conditions both in urban and panchayath areas until general schedules of timings for stage carriages other than those of the STU running on specified routes under the provisions of rule 212(1)(a) is formulated, approved and implemented with or without the assistance of Geo-Fencing and Monetary system or AI based time scheduling and management syatem for stage carriages followed by prompt time revision conferences in a phased manner.



Phase -1

To begin with this authority identifies the following routes where revision of time schedules shall be formulated and given effect to on 1/04/2026.

- (1) Kollam – Kottarakkara Via Kannanalloor
- (2) Kollam –Anchal Via Ayoor
- (3) Kollam –Paravoor Via Thirumukku


The secretary RTA shall call upon the permit holders on the respective routes to furnish true copies of their permits and the approved time schedule ,on receipt of which he shall prepare a route war register sfresh with a view to pursue the revision of schedules of time. this process would help identify the valid permits. The secretary shall commence the time revision conferences as may prefixed by him. This excercise shall be completed on or before 01/04/2026.

2, to abstain from revising the time schedules of mofussil services operating on inter regional or inter district routes until after the STA co-ordinates the decision of the respective RTAs under the provisions of section 68(3)(a) without which no uniform procedure can be devised and implemented in the state.

3, where voluntary installation of GPS based Geo Fencing and monitoring system desired by the Govt. doesnot work, the secretary RTA shall immediately take up the matter with the Transport Commissioner to provide all facility as are necessary at the expense of the Government.

4, this Authority is of the view that the entire traffic enforcement machinery shall be developed at various strategic points in Kollam City in place of the traffic wardens and Home Guards for the purpose of effective traffic managaement.

5, to invite detailed proposal from KSBL nad other interested stake holders for examination and approval for immediate implementation of rescheduling of bus timings and management system after affording fair opportunity of hearing to the concerned bus operators or their assosications.



ITEM NO :185**DEPARTMENTAL ITEM-02**

In view of the long pending demand of the general public for adopting measures for safety and comforts of passengers in stage carriages plying in the district of Kollam on permission by this authority and in view of judgment in W.A No. 454 of 2023 (Joint RTO v/s Thomas Joseph) of the Hon'ble High Court of Kerala this matter has been brought up for deliberation in the meeting today. The following proposals have been deliberated.


- A. Implementation of AIS-052 (Code of practice for bus body design and approval) under Rule 125 (C) of the CMV Rules 1989 by this authority while exercising the powers under the Motor Vehicle Act.
- B. Implementation of BS VI exhaust emission standards under Rule 115 of CMV Rules 1989 with a view to achieve environmental protection while exercising the powers under the Motor Vehicle Act.

The matter was deliberated at this meeting of the authority. The objections and suggestions for and against the above said proposals were considered. In view of provisions of section 72(2) of the M V Act enabling this authority to specify the description of the vehicle for grant of permit and in view of judgment in W.A No. 454 of 2023 (Joint RTO v/s Thomas Joseph) of the Hon'ble High Court of Kerala it is resolved to implement the said proposals in a phased manner.

- ❖ No fresh permit will be granted and issued in respect of a stage carriage by this authority unless such stage carriage is of Type I for urban and sub urban/city transport and Type II for inter urban/intercity operations so as to provide the maximum safety and comforts of passengers in compliance with AIS-0052.
- ❖ Every stage carriage seeking grant and issue of permit under Item No. 1 above shall comply with BSVI emission standards.
