#### NOTIFICATION

G. O. (P) No. 5/2012/Tran. Dated, Thiruvananthapuram, 2nd February, 2012.

S. R. O. No. 77/2012.—In exercise of the powers conferred by section 111 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government of Kerala hereby make the following rules further to amend the Kerala Motor Vehicles Rules, 1989, the same having been previously published as notification No. 8360/ B1/2010/Tran, dated the 1st December, 2011 in the Kerala Gazette Extraordinary No. 2336 dated the 12th December, 2011, as required by sub-section (1) of section 212 of the said Act, namely:-

#### RULES

- 1. Short title and commencement.—(1) These Rules may be called the Kerala Motor Vechicles (Amendment) Rules, 2012.
  - (2) They shall come into force at once.
- 2. Amendment of the Rules.— In the Kerala Motor Vehicles Rules, 1989, in rule 269, after sub-rule (9) the following sub-rule shall be inserted, namely:—
- "(10) In all stage carriages five per cent of the seats, excluding those provided for the driver and the conductor, shall be set apart for physically disabled persons:

Provided that one of the seats shall be earmarked in front of the conductor's seat and other seat shall be earmarked adjacent to entrance in the part where ladies seats are provided",

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

On the basis of the decision taken by the State Transport Authority on 12-11-1999 and the representation received from the State Commissioner and Government Secretary (Ex-officio), State Commissionerate for handicapped persons, Government have decided to reserve five per cent of the seats, excluding those provided for the driver and the conductor, to be set apart for physically disabled persons and to provide that one of the seats shall be earmarked in front of the conductor's seat and other seat shall be earmarked adjacent to entrance in the part where ladies seats are provided. For the implementation of the above decision, the Kerala Motor Vechiles Rules, 1989 have to be amended. Government have decided to amend the said Rules accordingly.

The notification is intended to achieve the above object.
