NOTIFICATION

G.O.(P) No. 1/2011/Tran. Dated, Thiruvananthapuram, 6<sup>th</sup> January, 2011.

**S.R.O. No. /2011.-** WHEREAS, as per notification issued under G.O. (P)No.42/2010/Tran. dated 24<sup>th</sup> April, 2010 and published as S.R.O. No. 406/2010 in the Kerala Gazette Extraordinary No.1004 dated 24<sup>th</sup> April, 2010, a scheme for one time settlement of tax arrears was implemented for Motor Cars, Autorickshaws and Motor Cycles, which are in tax arrears for more than five years or more as on 31<sup>st</sup> March, 2010 and the time limit to remit the tax arrears at the rates specified in the said notification expired on 30<sup>th</sup> September, 2010;

AND WHEREAS, Government have received several representations requesting to extend the period of the said Scheme for a further period up to 31<sup>st</sup> December, 2010;

AND WHEREAS, Government are satisfied that it is necessary, in public interest, to extend the time limit fixed for the said Scheme for a further period of six months from 1<sup>st</sup> October, 2010 to 31<sup>st</sup> March, 2011;

NOW THEREFORE, in exercise of the powers conferred by section 22 of the Kerala Motor Vehicles Taxation Act, 1976 (Act 19 of 1976) read with rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, the Government of Kerala hereby extend the time limit for remitting tax specified in the notification issued under G.O.(P) No.42/2010/Tran. dated 24<sup>th</sup> April, 2010 and published as S.R.O. No. 406/2010 in the Kerala Gazette Extraordinary No.1004 dated 24<sup>th</sup> April, 2010, for a further period of six months from 1<sup>st</sup> October, 2010 to 31<sup>st</sup> March, 2011 and make the following amendment to the said notification, namely:-

## **AMENDMENT**

In the said notification, in the fifth paragraph, for the words and figures "up to 30<sup>th</sup> September, 2010" the words and figures "up to 31<sup>st</sup> March, 2011" shall be substituted.

## **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The scheme for one time settlement of motor vehicle tax arrears for motor cars, autorickshaws and motor cycles which are in tax arrears for five years or more as on 31<sup>st</sup> March, 2010 was implemented as per notification issued in G.O. (P)No.42/2010 dated 24<sup>th</sup> April, 2010 published as S.R.O. No. 406/2010 in the Kerala Gazette Extraordinary No.1004 dated 24<sup>th</sup> April, 2010 and the time limit of the said scheme ended on 30<sup>th</sup> September, 2010. Taking into account of the representations for extension of the period of the scheme, Government have decided to extend the period of the scheme up to 31<sup>st</sup> March, 2011.

This notification is intended to achieve the above object.
