G.O (P) No. 23 /2020/Trans.

WHEREAS as per notification issued under G.O (P) No.19/2020/Trans. dated 31st March, 2020 and published as S.R.O No. 259/2020 in the Kerala Gazette Extraordinary No. 1019 dated 31st March, 2020, the Government had extended the period of remittance of quarterly tax for the quarter commencing from the 1st day of April, 2020 in respect of the non-transport vehicles and contract



carriages ordinarily kept in the State upto the 30th day of April, 2020 and in respect of transport vehicles other than contract carriages and stage carriages ordinarily kept in the State upto the 15th day of May, 2020, since the operators of such vehicles could not operate their vehicles due to the wide spread out break of novel corona virus epidemic and hence they were facing acute financial crisis;

AND WHEREAS the Government are satisfied that the above situation is continuing without any change and the period of remittance of quarterly tax in respect of such vehicles and that of the stage carriages for the said quarter shall be extended further;

NOW, THEREFORE, in exercise of the powers conferred by the proviso to rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, the Government of Kerala, being satisfied that it is necessary in the public interest so to do, hereby further extend the period of remittance of quarterly tax for the quarter commencing from the 1st day of April, 2020 in respect of the category of vehicles specified in serial numbers 1 and 2 in the Table under the said rule, namely,-

- (a) non-transport vehicles and contract carriages ordinarily kept in the State;
- (b) transport vehicles other than contract carriages and stage carriages ordinarily kept in the State; and
- (c) stage carriages,

up to the 15th day of June ,2020

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

For the reasons explained in the notification, the Government have decided to extend the period of remittance of quarterly tax for the quarter commencing from the 1st April, 2020 in respect of the non-transport vehicles, contract carriages, stage carriages and the transport vehicles other than contract carriages and stage carriages ordinarily kept in the State, up to the 15th day of June, 2020.

The notification is intended to achieve the above object.
