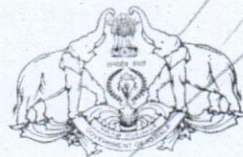



**S.R.O. No...../2018.** - In exercise of the powers conferred by sub-item (ii) of item 2 of rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, the Government of Kerala hereby specify a further period of thirty days with effect from 15<sup>th</sup> November, 2018 for remittance of quarterly tax due without fine in respect of stage carriages for the quarter commencing from 1<sup>st</sup> October, 2018.

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

The Private Bus Operators of the State have requested the Government to extend the period of remittance of quarterly motor vehicles tax in respect of the stage carriages for the quarter commencing from 1<sup>st</sup> October, 2018, for a further period of one month. As per sub-item (ii) of item 2 of rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, the Government have decided to permit the owners of stage carriages to remit quarterly motor vehicles tax due for the quarter commencing from 1<sup>st</sup> October, 2018 without fine in respect of the stage carriages for a further period of 30 days with effect from 15<sup>th</sup> November, 2018.

The notification is intended to achieve the above object.
