NOTIFICATION

G. O. (P) No. 46/2008/Tran. Dated, Thiruvananthapuram, 3rd November, 2008.

S. R. O. No. 1119/2008.—WHEREAS, representations have been received by Government that the existing rates of hire charges of Autorickshaws and Taxis should be revised;

AND WHEREAS, the Government are satisfied that the conditions have changed since the issuance of directions in Notification issued under G. O. (P) No. 18/2006/Tran. dated the 1st March, 2006 published as S. R. O. No. 215/2006 in the Kerala Gazette Extraordinary No. 522 dated the 4th March, 2006 and that it is necessary to modify the directions issued to the State Transport Authority and the Regional Transport Authorities in respect of the hire charges of Autorickshaws and Taxis in the said notification;

Now, THEREFORE, in exercise of the powers conferred by clause (i) of sub-section (1) of section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) and in supersession of the direction in notification issued under G. O. (P) No. 18/2006/Tran. dated the 1st March, 2006, published as S. R. O. No. 215/2006 in the Kerala Gazette Extraordinary No. 522 dated the 4th March, 2006, the Government of Kerala hereby issue the following directions to the State Transport Authority and the Regional Transport Authorities in the State as follows:—

DIRECTIONS

The State Transport Authority or the Regional Transport Authorities, as the case may be, shall fix the fares of contract carriages specified in column (1) of the Schedule below, at the rates shown in the corresponding entries under column (2) thereof, namely:—

| 1. Autorickshaws | Minimum hire charges will be Rs. 10 for a distance upto 1.25 Kilometre. Beyond the minimum the rate will be Rs. 6 per Kilometre and 50 paise for every 1/12 Kilometre or part thereof. |
| 2. Motor Cabs (including tourist Motor Cabs and ordinary Motor Cabs) with a seating capacity of not more than seven persons including driver. | <ol style="list-style-type: none"> 1. Rs. 7.50 per Kilometre for motor cabs (both petrol and diesel) subject to a minimum of Rs. 50 for a distance upto 3 Kilometres. 2. In the case of Air conditioned Motor Cabs, 10% of the hire charges may be charged additionally. |

In the case of Autorickshaws, an additional charge at the rate of 50% of the above rate of hire charges may be charged for journeys performed between 10 P. M. and 5 A. M. in Corporation areas of Thiruvananthapuram, Kollam, Kochi, Thrissur and Kozhikode and in the major towns of Kannur, Palakkad and Kottayam. In other places, an additional charge at the rate of 50% of the charges shown in the meter, less the minimum hire charges of Rs. 10 may be charged when onward journey alone is performed and the metered charges only when return journey is also performed.

1. Autorickshaws	Rs. 5 for every 15 minutes or part thereof, subject to a maximum of Rs. 200 per day.

This notification shall come into force at once.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Representations were received by Government from the leaders of Trade Union connected with Autorickshaws and Motor Cabs, requesting for revision of hire charges fixed in 2006 as per G. O. (P) No. 18/2006/Tran. dated the 1st March, 2006, published as S. R. O. No. 215/2006 in the Kerala Gazette Extraordinary No. 522 dated the 4th March, 2006. Having regard to the conditions stipulated in sub-section (1) of section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) and the hike in price of petroleum products and spare parts. Government have decided to revise the hire charges of Autorickshaws and Motor Cabs.

The notification is intended to achieve the above object.
