**S. R. O. No. 460/2013.** In exercise of the powers conferred by clause (i) of sub-section (1) of Section 67 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government of Kerala having considered it necessary in the public interest to do so hereby make the following amendment to the notification issued under G. O. (P) No. 77/2012/Tran. dated 30th November, 2012, and published as S. R. O. No. 830/2012 in the Kerala Gazette Extraordinary No. 1325 dated 30th November, 2012, namely:—

## AMENDMENT

In the said notification in column (2) of the Schedule, in the entries against item 1, for the words and figures, "Beyond the minimum, the rate will be ₹ 8.00 per kilometer and ₹ 2.00 for every 250 meter or part thereof", the following shall be substituted, namely:—

"Beyond the minimum, the rate will be ₹ 8.00 per kilometer and 50 paise for every 62.5 meter or part thereof."

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the G. O. (P) No. 77/2012/Tran. dated 30th November, 2012, published as S.R.O. No. 830/2012, Government had notified the hire charges for autorickshaws and Motor Cabs in the State with a seating capacity of not more than seven persons including the driver. As per the above notification the minimum hire charges for autorickshaws was fixed as ₹ 15 for a distance upto 1.25 km. and beyond the minimum, the rate was fixed as ₹ 8.00 per km. and ₹ 2 for every 250m. or part thereof.

The Secretary, National Auto Drivers Union, Kannur filed a writ petition No. 31560/2012, before the Hon'ble High Court challenging the said notification. In the judgment dated 7th January, 2013 the Hon'ble High Court directed the Government to dispose their representation within a period of two months after hearing the petitioner as well as the representatives of the unions of the drivers of autorickshaws in the State.

Government, after hearing the concerned parties, decided to make amendment to G. O. (P) No. 77/12/Tran. dated 30th November, 2012.

The notification is intended to achieve the above object.
