S. R. O. No. 792/2012.—In pursuance of the powers under clause (iii) of the proviso to sub-rule (1) of rule 108 and sub rules (2), (3) and (4) thereof of the Central Motor Vehicles Rules, 1989 and in supersession of the Notification No. G. O. (P) No. 32/2003/Tran. dated 16th July, 2003, published as S. R. O. No. 651/2003 in the Kerala Gazette Extraordinary No. 1306 dated 17th July, 2003, G. O. (P) No. 6/2005/Tran. dated 4-3-2005 published as S. R. O. No. 237/2005 in Kerala Gazette Extraordinary No. 514 dated 4th March, 2005 and G. O. (P) No. 69/2011/Trans. dated 12-12-2011 published as S. R. O. No. 788/2011 in Kerala Gazette Extraordinary No. 2353 dated 14-12-2011, the Government of Kerala hereby specify that the vehicles

carrying high dignitaries as specified in Schedule I below are permitted to use red light on the top front of the vehicle, that the vehicles carrying the persons specified in Schedule II are permitted to use blue light with flasher at the centre on the top of the hood, that the vehicles specified in Schedule III may be fitted with blue light with or without flasher and that the vehicle specified in Schedule IV are permitted to use multicoloured red, blue and white light, namely:---

Explanatory Note

(This does not form part of the notification, but it is intended to indicate its general purport.)

Rule 108 of the Central Motor Vehicles Rules, 1989 empowers the State Government to specify the high dignitaries for the purpose of the rule and to specify the motor vehicles on which the red, blue and multi coloured lights shall be fitted. The Government have decided to specify the high dignitaries in the State and also to specify the vehicles on which red, blue or multicoloured lights shall be used.

This notification is intended to achieve the above purpose.
