Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The General Secretary, Kerala State Private Bus Operators Federation has requested Government to extent the period of remittance of quarterly motor vehicles tax in respect of the stage carriages to be paid on or before 14th August, 2013 for a further period of 45 days. As per item 2 (ii) of rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, the Government have decided to permit the owners of the Stage Carriages to remit the quarterly tax in respect of the Stage Carriages without fine for a further period of 30 days with effect from 15th August, 2013.

This notification is intended to achieve the above object.
