In exercise of the powers conferred by sub-section (3) of section 213 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Government of Kerala hereby make the following rules further to amend the Kerala Motor Vehicles Rules, 1989, the same having been previously published as notification No.B2/481/2022/Trans. dated 24th February, 2023 in the Kerala Gazette Extraordinary No. 692 dated 27th February, 2023 as required by sub-section (1) of section 212 of the said Act, namely:-



RULES

1. *Short title and commencement.*- (1) These rules may be called the Kerala Motor Vehicles (3rd Amendment) Rules, 2023.

(2) They shall come in to force at once.

2. *Amendment of the Rules.*- In the Kerala Motor Vehicles Rules, 1989, in rule 406, in serial No.4. Assistant Motor Vehicle Inspectors, in item (i), for the words, letters and symbols "Badge with the letters 'KMV' and Kerala Emblem" the words, letters and symbols "crest in a monogram with letters 'KMV' on its centre surrounded by wreath and Ashoka Emblem on its top" shall be substituted.
