WHEREAS, in exercise of the powers conferred by section 22 of the Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976), read with rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, the Government of Kerala have reintroduced

the Scheme for one time settlement of tax for vehicles which are in tax arrears for four years or more due to various reasons, so as to reduce the arrears, as per notification issued under G. O. (P) No. 14/2020/Trans dated 23<sup>rd</sup> March, 2020 and published as S.R.O. No. 252/2020 in the Kerala Gazette Extraordinary No.1005 dated 30<sup>th</sup> March, 2020;

AND WHEREAS, the time granted to remit the arrears of tax, availing one time settlement of tax facility, expired on 31<sup>st</sup> March, 2021;

AND WHEREAS, as it is necessary in the public interest so to do, the Government have now decided to further extend the time for availing the one time settlement of tax facility up to 31<sup>st</sup> March, 2022 in view of the situation prevailing in the State due to Covid-19 Pandemic;

NOW, THEREFORE, in exercise of the powers conferred by section 22 of the Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976), read with rule 5 of the Kerala Motor Vehicles Taxation Rules, 1975, the Government of Kerala hereby extend the time for remitting the said arrears of tax till 31<sup>st</sup> March, 2022 and make the following consequential amendment to the above notification, namely:-

#### AMENDMENT

In the said notification, in the ninth paragraph, for the figures, letters, symbol and word "31<sup>st</sup> March, 2021" the figures, letters, symbol and word "31<sup>st</sup> March, 2022" shall be substituted.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

For the reasons stated in the notification, Government have decided to extend the time granted to remit the arrears of tax due by availing the one time settlement of tax facility as per notification issued under G.O.(P)No.14/2020/Trans dated 23<sup>rd</sup> March, 2020 and published as S.R.O No. 252/2020 in the Kerala Gazette Extraordinary No.1005 dated 30<sup>th</sup> March, 2020, upto 31<sup>st</sup> March, 2022 and make consequential amendment to the said notification.

The notification is intended to achieve the above object.
