In exercise of the powers conferred by Notification dated 12th June, 1989 of the Government of India, Ministry of Surface Transport issued under sub-section (6) of section 41 of the Motor Vehicles Act, 1988, (Central Act 59 of 1988) and published as S.O.No.444(E) in the Gazette of India dated 12th June, 1989 in Part II, section 3, sub-section (ii), the Government of Kerala hereby make the following amendment to the notification issued under G.O.(P)No.68/89/PW&T dated 30th June, 1989 and published as S.R.O.No.1148/89 in the Kerala Gazette Extraordinary No.619 dated 1st July, 1989,



namely:-

### AMENDMENT

In the said notification, in the TABLE, for serial number 15 and the entries therein column (2) and (3), the following serial numbers and entries shall respectively be substituted, namely, -

“15 Regional Transport Office (Nationalised Sector)-I 15

15A Regional Transport Office (Nationalised Sector)-II 90”

It shall come into force at once.

### Explanatory Note

( This does not form part of the notification, but is intended to indicate its general purport.)

It is as per G.O.(Rt.)No.388/2023 dated 18th September, 2023, the Government classified Regional Transport Office (Nationalised Sector) into Regional Transport Office (Nationalised Sector)-I and Regional Transport Office (Nationalised Sector)-II. In order to prevent misuse of Government vehicles in public road, it is decided to introduce a separate series and establish a separate registering authority for vehicles owned by Government, Quasi-Government, Public Sector Undertakings and Local Self Government Institutions. The Government have decided to register vehicles other than motor cars and jeeps owned by the Kerala State Road Transport Undertakings in Regional Transport Office (Nationalised Sector)-I with Code Number 15 and vehicles owned by the Government, Quasi-Government, Public Sector Undertakings and Local Self Government Institutions in Regional Transport Office (Nationalised Sector)-II with Code Number 90 series.

This notification is intended to achieve the above object.
