In exercise of the powers conferred by section 22 of the Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976) the Government of Kerala, being satisfied that it is necessary in the public interest so to do, hereby allow instalment facility to the registered owners for remitting arrears of tax due



from 1<sup>st</sup> April 2016 to 31<sup>st</sup> March 2020 in respect of motor vehicles of any class subject to the following conditions, namely:-

- 1. Vehicles having tax arrears from 1<sup>st</sup> April 2016 including additional tax and interest due as on the date of last instalment.
- 10 equal monthly instalments and the first instalment shall be remitted on or before 20<sup>th</sup> March, 2021 and the balance instalments shall be remitted on or before 20<sup>th</sup> of every succeeding months.
- 2. Vehicles having tax arrears from 1<sup>st</sup> April 2018 including additional tax and interest due as on the date of last instalment.
- 8 equal monthly instalments and the first instalment shall be remitted on or before 20<sup>th</sup> March, 2021 and the balance instalments shall be remitted on or before 20<sup>th</sup> of every succeeding months.
- 3. Vehicles having tax arrears from 1<sup>st</sup> April 2019 including additional tax and interest due as on the date of last instalment.
- 6 equal monthly instalments and the first instalment shall be remitted on or before 20<sup>th</sup> March, 2021 and the balance instalments shall be remitted on or before 20<sup>th</sup> of every succeeding months.

#### **Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

One Time Settlement facility for payment of tax was allowed to Non -Transport vehicles and Transport vehicles which are in arrears for a period of four years and more as on 31<sup>st</sup> March, 2020, as per notification issued under G.O.(P) No. 14/2020/Trans dated 23<sup>rd</sup> March, 2020 and published as S.R.O. No.252/2020 in the Kerala Gazette Extraordinary No.1005 dated 30<sup>th</sup> March, 2020, the One Time Settlement facility which was allowed up to 31<sup>st</sup> December, 2020 has been further extended up to 31st March, 2021 vide notification issued under G.O.(P) No.1/2021/Trans dated 1st January, 2021 and published as S.R.O. No.6/2021 in the Kerala Gazette Extraordinary No.9 dated 1st January, 2021. Government have received representations from vehicle owners for remitting the arrears of tax due w.e.f. 1st April 2016 in respect of the vehicles which are not covered under the One Time Settlement Scheme. Moreover, the vehicle owners are not in a position to remit the arrears of tax in lumpsum on account of the financial crisis faced by them in the wake of Covid–19 pandemic. Government have considered the request of the vehicle owners and decided to allow instalment facility to all registered owners for remitting arrears of tax in respect of all classes of motor vehicles, which are due from 1st April, 2016 to 31st March, 2020 subject to the conditions mentioned in the notification.

The notification is intended to achieve the above object.
