#### NOTIFICATION

G. O. (P) No. 68/2020/TRANS.

*Dated, Thiruvananthapuram, 11th December, 2020.*

The provisional Seniority List of Joint Regional Transport Officers as on 1-1-2019 has been forwarded to the Transport Commissioner for circulating among the incumbents for filing objections. Six incumbents filed objections and some of them requested personal hearing. Government have examined the matter and afforded a hearing to the following officers on 10-7-2019.

- (1) Sri P. M. Shabeer, Joint Regional Transport Officer
- (2) Sri Bharathan K., Joint Regional Transport Officer



- (3) Sri Jebi I. Cherian, Joint Regional Transport Officer
- (4) Sri Sreeprakash B., Joint Regional Transport Officer
- (5) Sri Manoj K., Joint Regional Transport Officer
- (6) Sri E. S. Unnikrishnan, Joint Regional Transport Officer.

In the case of Sri P. M. Shabeer, the DPC(H) held on 18-11-2019 considered his case on the basis of the order in O.A.(EKM)No. 1457/2018 dated 24-7-2018, and the Committee observed that he was awarded a punishment of barring one increment for a period of six months in a disciplinary case. Hence the Committee decided not to include his name in the Select List of Joint Regional Transport Officers for 2013.

In the cases of Sri Bharathan K., Sri Jebi I. Cherian, Sri Sreeprakash B., the ad hoc DPC(H) held on 17-3-2020, observed that Sri Bharathan K. was awarded a punishment of Censure. Hence the Departmental Promotion Committee decided to include him in the Select List for the year 2017, as Sl. No. 5(a) in between Sri C. U. Mujeeb (Sl. No. 5) and Sri K. Rajan (Sl. No. 6). Hence the Seniority of Sri Bharathan K., revised as 76 in between Sri Mujeeb C. U. (Sl. No. 75) and Sri Rajan K., (Sl. No. 76), and now the seniority of Sri Rajan K. is revised as 77. The Committee also rejected the claims of Sri Jebi I. Cherian and Sri Sreeprakash B.

Sri Manoj K. (Sl. No. 70) has filed an objection that his date of birth may be corrected as 2-3-1970 instead of 3-2-1970 qualification may be corrected as DME, Account Test, MV Act and Rules and date of entry in present post may be corrected as 6-11-2017 instead of 11-6-2017. His objection is verified with relevant records and found corrected in the Seniority List.

Sri E. S. Unnikrishnan, stated that in the seniority list of AMVIs, his position is in-between Sri M. P. James (Sl. No. 6) and Sri Anoop Varkey (Sl. No. 10). But in the seniority list of MVIs, he was in between Sri Biju James (Sl. No. 22) and Sri K. Bijumon (Sl. No. 24). By this wrong fixation, he had lost his seniority and 20 junior officers had been placed above him. Now this is followed in the provisional Seniority List. Hence, he requests to refix his seniority in-between Sri Biju James (Sl. No. 6) and Sri Anoop Varkey (Sl. No. 10). Also, the date of birth of him is wrongly entered as 15-3-1967 instead of 15-3-1974.

The Government considered his claim and found that the DPC(H) held on 20-2-2015, assessed the eligibility of Sri E. S. Unnikrishnan, and placed him in between Sri Biju James (Sl. No. 22) and Sri Bijumon (Sl. No. 24) for promotion to the post of JRTOs [G.O.(P)No. 17/2015/Trans. dated 23-3-2015]. And also seen that in the Seniority List of JRTOs



as on 1-1-2016, he was placed in between Sri Biju James (Sl. No. 61) and Sri Bijumon (Sl. No. 63) [G.O.(P)No. 14/2017/Trans. dated 9-5-2017] Hence his claim for restore his seniority is rejected. And in the case of his date of birth, it verified with relevant records and corrected in the Seniority List.

The Seniority List of Joint Regional Transport Officers in the Motor Vehicles Department as on 1-1-2019 as appended to this is approved.
