## PART III State Transport Authority

### MOTOR VEHICLES DEPARTMENT NOTIFICATION

No. CI/14217/TC/2015. 21st November 2015.

WHEREAS, vide Notification No. MG/1524/TC/1962 dated 1st January 1963, Transport Commissioner has specified the uniform for Drivers and Checking Inspectors for transport vehicles and vide Notification No. CI/16658/TC/94 dated 20th April 1995, Transport Commissioner has specified the uniform for the Drivers of transport vehicles;

AND WHEREAS, as per Rule 41 of the Kerala Motor Vehicles Rules, 1989, a driver of transport vehicle shall, while on duty, be cleanly dressed in the uniform specified by the Transport Commissioner and as per Rule 85 of the Kerala Motor Vehicles Rules, 1989, every conductor of transport vehicle shall, while on duty, be cleanly dressed in the uniform specified by the Transport Commissioner;

AND WHEREAS, The Chairman & Managing Director, Kerala State Road Transport Corporation has requested to modify the uniform prescribed for Conductors, Drivers and Checking Inspectors of Kerala State Road Transport Corporation;

NOW THEREFORE, in exercise of powers conferred under Rule 41 and 85 of the Kerala Motor Vehicles Rules, 1989 the Transport Commissioner hereby modifies Notification Nos. MG/1524/TC/1962 dated 1st January 1963 and CI/16658/TC/94 dated 20th April 1995 as follows namely:

1. In Notification No. MG/1524/TC/1962 dated 1st January 1963, after Serial No. 3, the following shall be inserted, namely:

“Provided that the conductors of Kerala State Road Transport Corporation shall wear navy blue pants and sky blue shirt or churidar while on duty and

Checking Inspectors of Kerala State Road Transport Corporation shall wear Black Pants and Half Sleeve White Shirt while on duty”

2. In the Notification No. CI/16658/TC/94 dated 20th April 1995, after the first proviso, the following shall be inserted, namely:

“Provide further that the drivers of Kerala State Road Transport Corporation shall wear Navy Blue pants and Sky Blue shirt or churidar while on duty”

The Notification shall come into force at once.

#### Explanatory Note

(This does not form the part of the above notification, but is intended to indicate its general purport.)

The Chairman & Managing Director, Kerala State Road Transport Corporation has requested to modify the uniform prescribed for Conductors, Drivers and Checking Inspectors of Kerala State Road Transport Corporation as part of modernization of Kerala State Road Transport Corporation. The Transport Commissioner has examined the matter in detail and decided to modify the notifications concerned accordingly.

The notification is intended to achieve the above object.
