### ORDER

As per the orders read as 1<sup>st</sup> and 2<sup>nd</sup> paper above, Government have granted permission to the Makaliyam Institute of Fire Safety Training (IFST), Irimpanam, Tripunithura and the Institute for Advanced Driving Skills and Safety Training, M Square, Near HPCL, Irimpanam, Eranakulam, respectively for imparting training to the drivers of vehicles carrying hazardous goods.

As per the letters read as 4<sup>th</sup> and 5<sup>th</sup> paper above, Transport Commissioner has recommended to cancel the license issued to the Makaliyam Institute of Fire Safety Training (IFST) and the Institute for Advanced Driving Skills and Safety Training (IFASS) as these institutes committed grave irregularities in connection with issuance of course certificate.

3. As per the order read as 3<sup>rd</sup> paper above, Government issued guidelines to the institutions conducting training to drivers of vehicles carrying hazardous goods.

4.The directors of Makaliyam Institute of Fire Safety Training (IFST) and Institute for Advanced Driving Skills and Safety Training (IFASS) were heard on 12/09/2024.

5. Government have examined the matter in detail and decided to cancel the permission granted to Makaliyam Institute of Fire Safety Training (IFST) Irimpanam, Tripunithura and the Institute for Advanced Driving Skills and Safety Training (IFASS), M Square, Near HPCL, Irimpanam, Eranakulam as they have violated the norms and guidelines issued by Government. Transport Commissioner shall take appropriate action to cancel the license.
