The following draft rules further to amend the Kerala Motor Vehicles Rules, 1989, which the Government of Kerala propose to make in exercise of the powers conferred by sections 65 and 96 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988) is hereby published for general information as required by sub - section (1) of section 212 of the said Act.

DRAFT RULES

- 1. Short title and commencement. (1) These rules may be called the Kerala Motor Vehicles (...... Amendment) Rules, 2022.
 - (2) They shall come into force at once.
- 2. Amendment of the rules.- In the Kerala Motor Vehicles Rules, 1989, for sub-rule (1) of rule 260A, the following sub-rule shall be substituted. namely:-

"260A. Special provision applicable to a stage carriage permitted to be operated as certain classes of services. - (1) A stage carriage older than ten years from the date of its registration shall not be permitted to be operated as a Fast Passenger Service, a Super Fast Service, a Luxury Service, a Super Deluxe Service or a Super Express Service."
