Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Commander, Naval Analysis Unit Southern Naval Command has requested the Government of Kerala to exempt the two Hero Super Splendor Motorcycles bearing Chassis No. MBLJA05EM9M26641 and Engine No. JA05ECE9M26271 and Chassis No. MBLJA05EMF9K11538 and Engine No. JA05ECF9K06862 belonging to Naval Analysis Unit Headquarters, Southern Naval Command, Kochi-682 004 from payment of tax under the Kerala Motor Vehicles Taxation Act, 1976. The Government have examined the request and decided to exempt the said vehicles from payment of motor vehicle tax under section 22 of the Kerala Motor Vehicle Taxation Act, 1976 (19 of 1976), subject to the condition that the vehicles shall solely be used for the official purpose of the unit.

The notification is intended to achieve the above object.
