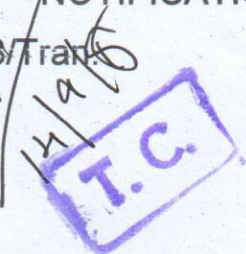

S.R.O. No...../2018. - In exercise of the powers conferred by section 28 of the Kerala Motor Vehicles Taxation Act, 1976 (19 of 1976), the Government of Kerala hereby make the following rules further to amend the Kerala Motor Vehicles Taxation Rules, 1975, namely:-

**RULES**

1. *Short title and commencement* - (1) These rules may be called the Kerala Motor Vehicles Taxation (Amendment) Rules, 2018.

(2) They shall come into force at once.

2. *Amendment of the Rules* - In the Kerala Motor Vehicles Taxation Rules, 1975, in rule 5, after the entries in column (2) against sub-item (ii) of item 2, for the existing proviso, the following proviso shall be substituted, namely:-

“Provided that the period within which the tax is to be paid for the quarter commencing from 1<sup>st</sup> day of July, 2018 shall be up to the 30<sup>th</sup> day of September, 2018.”

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Private Bus Operators of the State have requested the Government to extend the period of remittance of quarterly tax for the quarter commencing from the 1<sup>st</sup> day of July, 2018 up to the 30<sup>th</sup> day of September, 2018 in addition to the period already extended, since they are facing acute financial crisis due to the unprecedented flood affected in the State.

The Government have already extended the period of remittance of quarterly tax in respect of the said quarter, for a further period of 30 days vide notification under G.O. (P) No. 28/2018/Tran. dated 13<sup>th</sup> August, 2018 and published as S.R.O. No. 565/2018 in the Kerala Gazette Extraordinary No. 2144 dated the 13<sup>th</sup> August, 2018. There is no provision in the Kerala Motor Vehicles Taxation Rules, 1975 further to extend the period of remittance of the said quarterly tax. Hence Government have examined the matter in detail and decided to amend the said Rules extending the period of remittance of tax up to 30<sup>th</sup> September, 2018 for the quarter commencing from the 1<sup>st</sup> day of July, 2018.

The notification is intended to achieve the above object.
