A	INSTRUCTION TO BIDDERS
1	Mode of submission of bids: - Online. All Bid documents shall be submitted only in online procedure through the e-GP website www.etenders.kerala.gov.in in the designated covers. No other mode of submission shall be accepted and such tenders will be rejected outright.
2	Bid System: - Two bid systems. i) Technical Bid ii) Financial Bid.
3	Downloading of tender documents: - The tender document shall be downloaded from the e-GP portal www.etenders.kerala.gov.in from date of floating till last date of submission. No physical tender document will be issued.
4	Submission of tender documents: - All required documents shall be submitted online through the e-GP portal www.etenders.kerala.gov.in well in advance before the last date mentioned above. The department, if desired, shall instruct to submit documents physically at the time of evaluation of bids.
5	Payment of tender fees: - A non-refundable tender fee of ₹15,000/- [Rupees Fifteen thousand only] shall be paid in online mode through the e-GP website www.etenders.kerala.gov.in at the time of bid submission. No other mode of payment shall be accepted. The tenders of bidders who do not remit fees through online will be rejected outright.
6	Payment of Earnest Money Deposit: - An amount of ₹5,00,000/- (Rupees Five Lakhs only) as EMD shall be paid in online mode through the e-GP portal www.etenders.kerala.gov.in at the time of bid submission. No other mode of remittance shall be accepted.
7	Exemption from payment of EMD: - Bidders who are exempted from payment of EMD as per Govt. of India/ Govt. of Kerala are required to submit valid documentary proofs. Bidders who do not remit EMD or upload documentary proof for exemption of EMD will be rejected outright.
8	Withdrawal and re-submission of tender: - Bidders are at liberty to withdraw the submitted tender/documents and to submit fresh tender/documents till the last date and time of submission after which withdrawal/re-submission will not be allowed.
