While complying the direction it is found that this three wheeler passenger has been parking in front of the shops in an obstructive manner on 16/08/2023 and the "NO PARKING" board placed by the Police with the help of MVD has been removed from there.

This is the violation of the decision of RTA dated 27/03/2023 and the judgment of Hon'ble High Court of Kerala in WPC No.7453/2021 dated 03/09/2021. But this is a Non Transport Vehicle with effect from 24/08/2023.

Hence RTA may consider the matter, hear the permit holders and take a decision.

- ♦ Person in charge of a vehicle cause or allow the vehicle to cause or likely to cause danger or obstruction or undue inconvenience to the use of public place.(Obstructive parking)Act S122 RW S177.


