The applicant has applied for renewal of permit for the period from 10-10-2011 to 09-10-2016 and 10-10-2016 to 09-10-2021 by stating that he has applied for renewal of permit on 14-10-2011.As per the order of Hon STAT in MP 645 in MVARP 190/2011 clearance certificate was issued without surrendering the permit on 07/07/2011.But he has not produced any suitable vehicle for replacement for last 9 years..Now the applicant has applied for renewal of permit for the further period of 10-10-2016 to 09-10-2021 only on 17/09/2020.As per section 81(2) of MV Act application for renewal of permit shall be made not less than 15 days before expiry. This authority has not satisfied that the applicant was prevented by good and sufficient cause from making an application with in the time specified. Under this circumstances the application for renewal of permit is Rejected.

2.The application for variation of permit can be considered only for a valid permit. In this case the vehicle has no valid permit .Hence application for variation of permit is rejected.

3.The application for replacement of vehicle can be considered only for a valid permit. In this case the vehicle has no valid permit .Hence application for replacement of vehicle is rejected
