

**DECISION OF THE REGIONAL TRANSPORT AUTHORITY KOZHIKODE BY  
CIRCULATION U/S 130 DATED 09.07.2021**

CIRCULATION ITEM NO 1

Ref C/E-28232/2021/D

This is an application vide notification GOP No.41/2018/Tran dated 22/11/2018, 2000 Electric Autorickshaws permit allotted by Government in city limits reg. The following introductions were given for implementation. As per the notification issued under GO[P] no 189/95 PWD dtd 12.12.1995 and published as SRO No 1502/1995 in the Kerala Gazette Extra ordinary no 1255 dtd 14.02.1998 ,the state Govt. head directed RTA's to limit the number of Autorickshaws in the cities Kozhikode, Kochi and Thiruvananthapuram to the extend notified there in and whereas by notification issued under GO[P] no 04/2011/Trans dtd 27.01.2011 and published as SRO no 76/2011 in the Kerala Gazette extra ordinary no 197 dtd 27.01.2011 the state Govt. had directed the RTA to raise the limit fixed for Autorickshaws in the city of Kozhikode as 4337 and where as to control and to permit issue of alternate fuel other than Petrol and Diesel. Government has decided to fix the limit exclusively for Auto LPG/CNG/LNG. Electric Autorickshaws in each of the cities of Thiruvananthapuram, Kochi and Kozhikode as 3000 number apart from the autorickshaws permit already fixed. And now whereas, therefore in exercise of the powers co by clause (a) of subsection (3) of sec 74 of the MV Act 1958[Central Act 59 of 1988. The Govt. of Kerala hereby direct the RTA concerned to fix the limit for Auto LPG,CNG ,LNG, electric autorickshaws in each of Thiruvananthapuram, Kochi, Kozhikode as 3000 numbers . In this 2000 will be allotted only for electric autos and s separate quota of 1000 permit will be allotted to other fuels

like CNG/LNG/LPG apart from the autorickshaws permit already fixed. The decision of RTA is as follows.

“Perused the notification No, G.O (P) 41/2018/ Tran dated 22/11/2018 granting 3000 Auto permits in city limit out of which 2000 permits earmarked for electric Auto rickshaws and the remaining for operating on fuels like LPG/CNG/LNG etc.

This authority have discussed the matter in details and decided to implement following additional conditions for the issue of newly allotted permits.

### **Conditions**

1. The Electric Autos and LPG/CNG/LNG autos which are registered in the **jurisdiction of RTO Kozhikode** up to 31.12.2020 are permitted to ply in Kozhikode city on a condition of first come first serve basis.
2. The applicants having electric autos and LPG/CNG/LNG autos registered after 01.01.2021 and permanent residents of Kozhikode Corporation are permitted to ply in city on a condition of first come first serve basis.
3. The following additional conditions in case of Autos permitted to ply in city limit are as follows.
  - a) The applicants should be the permanent resident of Kozhikode Corporation.
  - b) Only one permit will be issued to an individual.
  - c) The applicant shall provide two address proofs for proving their address.
  - d) The Transfer of ownership shall only be permitted between the natives of Kozhikode Corporation.
  - e) All autos shall exhibit the registered mark and any other sign as directed by RTA time to time.
  - f) The fare rates, fare chart should be provided in the Autos.
  - g) The driver of each auto shall wear identity card issued by Police department or Competent Authority.
  - h) The checked slip provided by MVD shall exhibit on the left top portion of the wind shield.
  - i) Violation of any conditions stipulated above will attract Suspension/ revocation of permits.
4. The letter CCe should be in white color in green background.
5. The Secretary RTA shall maintain a register on this behalf.
6. New CC permit will not be granted /allowed to the applicant who already holds a CC permit ”

In the above decision there occurred a typing error in **condition 1**, that is instead of **Kozhikode Taluk** wrongly typed as **Jurisdiction of RTO Kozhikode**. In order to correct this error, permission sought from Chairman RTA on 09.07.2021 and same was granted.

***Examined the records and modified the Condition 1 in the decision of item no 73 of this authority dated 03.02.2021 as “The Electric Autos and LPG/CNG/LNG autos which are registered in the Kozhikode Taluk up to 31.12.2020 are permitted to ply in Kozhikode city on a condition of first come first serve basis.***

## **CIRCULATION ITEM NO 2**

### **C3/67502/2019/D**

This is an application in respect of S/C KL 57 N 6060 stands registered in the name of Sri. Moosakutty Pullanholi house, Pannikkootoor PO, Koduvally. Regular permit of this vehicle expired on 24.06.2019. Renewal of permit application received on 20.06.2019. Renewal application is not in time. Registered owner deceased on 21.04.2019. The vehicle having temporary permit u/s 87[1]d validity upto 27.02.2020. Tax paid up to 31.03.2020 and certificate of fitness valid up to 21.07.2021. Legal heirs produced Death certificate, legal heirship certificate and notary affidavit and authorize Shabna as the legal heir to transfer the permit from the name of the deceased person. Secretary RTA heard the legal heirs on 19.09.2019 and found that the other legal heirs have no objection for the transfer of permit to the succeeding possessor Smt Shabna. The application for death transfer and renewal of regular permit is found genuine.

This application placed in RTA dated 03.02.2021 vide item no 65 decision taken only for transfer of permit application. Hence the application for renewal circulated with the permission of Chairman RTA .

***“Heard. Verified the records and Renewal granted, subject to the production of NOC from HP Company and clearance of dues to Government, if any.”***

### **CIRCULATION ITEM NO 3**

**C2/KL20030622007106/2020/D**

This is an application in respect S/C KL 11 BR 3029 for variation of permit as addition of one trip from Atholi at 5.23 pm to Cheekkilode conducting service on the existing route with a regular permit no.11/144/2002 valid up to 25/12/2022. Permit holder of this vehicle filed application for variation of permit on 07/03/2020.

RTA dated 03.02.2021 considered this application and the decision was **“Heard.** Variation involves extension of one single trip from Atholi to Cheekkilode. It is reported that the one additional trip during the peak hour at evening is beneficial to the travelling public. Hence variation granted, subject to settlement of timings. Hence the application for variation of permit is **rejected.”**

The Clerical error in the above decision is verified as per the permission of Chairman RTA.

***“Heard. Variation involves extension of one single trip from Atholi to Cheekkilode. It is reported that the one additional trip during the peak hour at evening is beneficial to the travelling public. Hence variation granted, subject to settlement of timings.”***

### **CIRCULATION ITEM NO 4**

**C2/KL20012124619628/2020/D**

This is an application in respect S/C KL18Q3969 to correct the clerical error in the decision of RTA Kozhikode dated 03.02.2021 vide item item No 32 with the permission of Chairman RTA .

***“Heard. Verified the records. This is an application for transfer of permit and renewal of permit in respect of stage carriage KL 18 Q 3969 with permit no 11/224/1995 operating on the route Kozhikode –Thrissur. This permit was issued before 01.06.2006 and presently route length below 140km. Hence transfer of permit granted subject to the production of HP Noc and clearing of Government dues if any.***

***On verification it is seen that variation granted by RTA Dated 12.04.2018 Vide Item no 67 effected, but new timings not settled. Hence Secretary RTA is directed to obtain fresh timings from the applicant, verify the feasibility and issue after conducting timing conference by issuing notice to all enroute operators including KSRTC. Renewal of permit granted subject to said condition.”***
