2.Letter no.D2/188/2025-TC Dated 01.01.2026**

The matter under consideration is the grant and issue of fresh stage carriage permits under section 72 and permission to replace the existing stage carriages under section 83 by stage carriages registered as such in other states and brought in to the state of Kerala on transfer of ownership or change of address under section 50 or section 49 as the case may be.

The matter was elaborately discussed and considered. Various associations of the private bus operators put forth their objections and suggestions. They have fully supported the proposal to impose restrictions on the grant of fresh stage carriage permits to vehicles registered in other states and brought into the state of Kerala, but they have expressed their concern about the proposed denial of permission to replace the existing route buses in the state by old model / condemned/ discarded stage carriages from any other states. The argument that replacement of buses is for the purpose of continuation of existing permit and therefore the denial of such replacement would adversely affect the existing operators in the state is not acceptable to this authority, the reason being that the registration of the motor vehicles and the physical features of the vehicle registered in many other states would not satisfy the provisions of Chapter VII of the MV Act and the special rules applicable for the state of Kerala.

Section 46 envisages that motor vehicles registered under Chapter IV in a state shall be valid in any other state in India. Notwithstanding anything so contained in section 46, registration of motor vehicles in other states in contravention of the provisions of Act and Rules if any, is not binding on the authorities of this state and it will be open to the authorities to ensure compliance afresh of such requirements as held by the Hon'ble High court of Kerala in *Jaleel Vs State of Kerala* (2002 (2) KLT 709).

It has been brought to the notice of this authority that passenger vehicles registered in certain states like Delhi, Haryana, Himachal Pradesh, Rajasthan etc. are often excluded from stage carriage services on attainment of specified age limits and are condemned or discarded, and such vehicles are bought at cheaper rates and brought into this state for obtaining permits with a view to practice trafficking of permits or replacing the existing route buses thereby making the state of Kerala a 'dumping yard' for such discarded vehicles. Such vehicles are obviously unfit for providing safety and comfort to passengers. Also such end-of-life vehicles imperil the State's air quality. Permission if any granted for such replacement would not advance the objects of the Act especially public safety and convenience.

Under the circumstances, it is decided that passenger motor vehicles registered in any other state and brought into the state of Kerala shall not be permitted to replace the existing route buses in the state unless such vehicles comply with the AIS standards and BS norms in force as provided for under Rule 125-C of CMV Rules, which shall be meticulously examined and ensured by competent authorities in the state.

Decision of State Transport Authority in Departmental Item 1(2)

GPS/ AI based time scheduling using Geo-Fencing technology :-

- a. The State Transport Authority has decided to implement the geo-fencing system on a voluntary basis for private stage carriages, as suggested by the Bus Operators' Association.
- b. As a first step, all RTOs are directed to convene meetings with bus operators urgently. Each RTO must identify at least one route from both urban and rural areas within their jurisdiction for the implementation of the geo fencing system as a pilot project. Care should be taken that the selected routes are relevant.
- c. The geo-fencing system must be implemented voluntarily in such selected routes before 01.11.2025.
- d. All Deputy Transport Commissioners are directed to supervise the district wise/ RTO wise meetings to streamline the timings as per the new system 5 minutes /10 minutes time gap must be made at source location (Termini)
