It operates on the Interstate route Kozhikkode – Mangalore (Via Thalasserry, Kannur, Kasargod, Kamabala, Kurichipally, Manjeshwar, Thalapady and Ullal) on single point tax basis.

The route included in the Interstate Agreement entered between the states of Kerala and Karnataka.

The vehicle has not yet attained the age of 15 years. The Registration date of vehicle is 21.07.2010. The Permit holder submitted an application dated 06.01.2025 for renewal of Permit for a further period of five years from 17.02.2025. No pending check report was found and the tax has been paid up to 31.12.2024. The STA may review the records, hear the applicant and objectors, and make a decision.
