1. KSRTC raised objections before the STA and said that the Rule 172(3) of the KMV Rules 1989 dealt with the renewal of the permit.

- (1) The rules says that the Transport Authority sanctioning an application for renewal of a permit shall call up the permit holder to produce the registration certificate of the vehicle and endorse the renewal of the permit and returned to the holder.
- (2) The Transport Authority may revoke its sanction of the application for renewal, if the permit holder fails to produce documents within one month from the date of dispatch of the order requiring the production of the records.
- (3) If the applicants having sufficient ground, the Transport Authority can grant extension of time another 3 months.
- (4) If the renewal of permit is not availed by producing the current records within 4 months that is maximum time limit prescribed in Rule 172(3), the said permit become lapsed.

- (5) There is no provision in the Motor Vehicle Act or the Kerala Motor Vehicle Rules enabling the RTA/STA to extent time for production of current records beyond 4 months from the date of dispatch of the proceedings of granting permit. The very similar issue concerned in the Hon'ble High Court reported the decision Seethal Vs RTO Thrissur, 2003 KLT 357, if the current records are not produced within the 4 months from the date of communication of grant of the permit by the grantee, then the permit shall stand cancelled without the RTA requiring to cancel it as that is the necessary consequence of the operation of the condition of permit granted under Section 72(2) read with Rule 159(2).

2. Applicant's grievance:

- (1) Earlier this authority considered our request and that was rejected. Then we filed an appeal before STAT, the appeal is pending. Appeal No. 214 of 2023.
- (2) In another case Justice B K Singh has clarified that the word used is make so sufficient discretions there the Transport Authority can control the delay in producing the records of the vehicle and take a decision.
- (3) It is the saved permit included in Inter State Agreement. Some delay occurred due to producing the current records, because my father expired.

any other law. Every Scheme published by the State Government is a law and that scheme will override all the provisions notwithstanding anything inconsistent with Chapter V of MV Act or any other law for time being is imposed. This is an interstate permit which is always subject to the scheme. Earlier occasion 2010 this Hon'ble STA granted Inter State Permit route Kannur – Manglore without considering the validity of the approved scheme. Then KSRTC brought up this matter before the STAT by filing statutory appeal. Appeal is permitted by STAT, for fresh consideration with a specific findings that the scheme is applicable to the Inter State Permit. The STA took the decision in Item No.16 of 25/06/2015, that the Inter State Permit is always subject to the scheme.

The applicant give their grievances before STA that it is the existing permit and continuously renewing the permit. Karnataka STA renewed the permit and countersignature is requested to STA Kerala. Inter State route are saved permit and this route is included in Inter State Agreement SL.16 Appendix 1 of Inter State Agreement 1976.
