Accordingly, Provisional License No. 30/MCY/STA/2025 was issued with effect from 09.05.2025, in compliance with the interim order of the Hon'ble High Court of Kerala in W.P.(C) No. 17262/2025 dated 09.05.2025. Thereafter the Government Pleader has sought objections, if any, to making absolute the provisional license issued in compliance with the said interim order. As such a DTC, South Zone is directed to conduct a detailed verification and report on the genuineness and eligibility of the applicant for the grant of a Rent a Motor Cycle License under the Rent a Motor Cycle Scheme, 1997. The report is awaited.

Agenda :	Revision of Time Gaps for Private Stage Carriages in Kerala, Implementation of Geo-Fencing System & Resolution of Time Slot Conflicts - Reg

NOTES :	<p>There has been a significant rise in traffic accidents across several districts in Kerala—including Pathanamthitta, Kottayam, Kozhikode, Palakkad, Idukki, Ernakulam, and Thiruvananthapuram—many of which involve state-run buses. Investigations indicate that a key contributing factor is the excessive speed and unsafe competition among buses operating on similar routes and schedules.</p> <p>Despite holding valid permits, buses frequently attempt to collect passengers at the same time, leading to dangerous overtaking, erratic driving, and failure to adhere to designated timings. This practice increases the likelihood of accidents, particularly in densely populated urban areas, putting public safety at risk.</p> <p>Inadequate scheduling and poor time gap management also reduce the reliability of public transport services, especially in urban regions where multiple buses operate concurrently. As a result, the public is often compelled to rely on private vehicles,</p>

contributing to traffic congestion and environmental pollution.

To address these challenges, it is essential to revise and regulate the time gaps between private stage carriages. By enforcing proper scheduling, public trust in the transport system can be restored, while improving overall safety and service quality.

In accordance with the Kerala High Court judgment dated 27.03.2025 in WP(C) No. 32680/2008, and the directive issued by the DIG on 25.03.2025 (File No. D2(b)24632/2025/EC), it has been recommended that bus services be operated with adequate time intervals to avoid competition and ensure road safety.

Permission has been granted by the Hon. Special Secretary to Transport vide letter No.B1/86/2025/TC dtd 25.6.2025 to issue a notification;

Fixing time tables for private stage carriages in both Municipal and panchayath areas,

Authorizing the state Transport Authority [STA] to issue a notification as per Rule 212[1] of the Kerala Motor Vehicles Rules regarding scheduling.

I. Proposed time gap revisions are as follows:

1 . **In urban areas** (municipalities and corporations): **Minimum 5-minute gap** between

preceeding and succeeding private stage carriage buses in the same Route.

2 . In rural areas (panchayats): **Minimum 10-minute gap** between preceeding and succeeding private stage carriage buses in the same Route.

(Implementing these revised intervals will help reduce congestion at bus stops, minimize aggressive driving behavior, and significantly lower the risk of accidents.)

II. Implementation of Geo-Fencing System

It is proposed to implement a **GPS-based geo-fencing and monitoring system** across all public transport vehicles in Kerala. This system aims to:

- Ensure adherence to scheduled timings,
- Monitor and regulate vehicle speed,
- Enhance accountability in service operations.

The **State Transport Authority (STA)** is requested to review the proposal and take a suitable decision for implementation.

III. Resolution of Time Slot Conflicts

In cases where multiple applicants request the same time slot for stage carriage operation, it is proposed that such conflicts be resolved through a **transparent auction process**. This measure will ensure fairness in allocation and prevent unauthorized competition on the same route and time.

STA may peruse the matter and take appropriate
