Stage Carriage No. KL 12 M 9696, covered by Permit No. 83/STA/1985, was valid up to 31.12.2021 and has been operating on the inter-State route Kozhikode–Devala (via Koduvally, Vythiri, Cherampady) on a single-point tax basis.

The permit holder applied for renewal of Permit No. 83/STA/1985 for a further period of five years, from 01.01.2022 to 31.12.2026, as a Limited Stop Ordinary Service (LSOS). The Route length is 119 Km. The route is included in the Inter State Agreement entered into between the States of Kerala and Tamil Nadu, listed at SL. No. 44, Part-B of the 1976 Agreement. **The Kerala State Transport Authority (STA), in its meeting held on 31.08.2022, considered and approved the renewal of the permit as an Ordinary Service, arising out of Government Order G.O.(P) No. 13/2023/Trans dated 03.05.2023.** This decision was duly communicated to the applicant.

Subsequently, the matter regarding conversion of the service as Limited Stop Ordinary Service (LSOS) was again placed before the **STA in its meeting held on 07.06.2023.** As per the decision communicated earlier, the request for conversion was **rejected, and the vehicle was permitted to operate only as an Ordinary Service.** Accordingly, the applicant was directed to submit a revised time schedule for Ordinary Service, which was complied with. **At present, the time settlement of the vehicle is pending with both the RTO, Wayanad and the RTO, Kozhikode.**

Hence, the vehicle is being operated on the strength of a Temporary Permit. The permit holder has applied for a Temporary Permit for the period from 13.09.2025 to 10.01.2026.

**In the judgment dated 16.06.2025 in WP(C) No. 25693/2024 filed by Shri Nayak, which was received on 25.11.2025, the Hon'ble High Court observed that Government Notification G.O.(P) No. 13/2023/Trans dated 03.05.2023 had already been quashed in WP(C) No. 17469/2023. Accordingly, the Hon'ble Court directed the State Transport Authority to reconsider the application of the petitioner.**

In view of the above, the State Transport Authority may peruse the records, hear the applicant and any objectors, and take an appropriate decision in the matter.
