Implementation of AIS-052 Code of Practice for bus body design shall be made mandatory for granting fresh stage carriage permits on new routes.</li> <li>2. Implementation of BS VI exhaust emission standards shall be mandatory for the issuance of fresh stage carriage permits.</li> <li>3. Fresh bus permits require new buses.</li> </ol> <p>These decisions were made by the State Transport Authority</p>

(STA) to prevent permit trafficking and to ensure public safety, pollution control, and environmental protection. Similar decisions had been taken by certain Regional Transport Authorities (RTAs) prior to 31.08.2025. All such decisions taken by the RTAs were unified across Kerala With effect from 01.09.2025, by implementing the STA decision dated 08.08.2025.

Aggrieved by this, several writ petitions have been filed in connection with the implementation of the matter, and clarifications have been sought from various office heads.

In view of certain terms/ expressions which created ambiguity in the STA decision dated 08.08.2025, it is deemed necessary that such terms/ expressions be made explicit by incorporating appropriate explanatory notes below the said decision. The following meanings shall be assigned to such terms and expressions.

Explanatory notes:- For the purpose of STA decision dated 08.08.2025, departmental Agenda Item-II (Additional)

The term "new buses" in item 3 of the decision shall mean 'Stage carriages complying with the requirements of AIS standards and BS norms in force from time to time.'

The term "new stage carriage routes" referred to in the body of the decision and the term "new routes" in item No. 1 shall mean 'routes on which permits are granted afresh'.
