Tax in respect of the vehicle is paid up to 31-03-2024 and No Hypothecation is pending against the vehicle. No Check report or departmental action pending against the vehicle at present.

The Motor Vehicles Inspector who enquired into the matter reported the followings

"With reference to the above, conducted enquiry and it reveals the following facts.

- i) The permit holder (Applicant 1<sup>st</sup>) of stage carriage KL-01-BC-8787 is Ramamoorthy, S/o Venkitarama Iyer, TC 52/1312(5), Krishna Prabha, Poozhikunnu, Industrial Estate P.O, Thiruvananthapuram - 695011.
- ii) Now the Applicant 1<sup>st</sup> intends to transfer this permit (1/10001/2006) to Applicant 2<sup>nd</sup> Al Amaan M S S/o Muhammed Shereef B, Al Ameen Manzil, Panachamoodu P.O, Vellarada, TVPM - 695011.
- iii) The applicant 1<sup>st</sup> is handing over the permit to the applicant 2<sup>nd</sup> with all the existing facilities including staff and has no chance of labour dispute.
- iv) The applicant 1<sup>st</sup> has not claimed for any honorarium for this transaction.
- v) There is no dispute between the two applicants regarding this transaction
- vi) The applicant 2<sup>nd</sup> is financially stable enough to conduct a stage carriage service properly.

Heard both the applicants and they admitted the above mentioned facts, the application for transfer of permit is genuine.
