The above appointment is subject to Rule 3(c) of the General Rules of the Kerala State and Subordinate Service Rules, 1958 and under clause (i) of Sub Rule (a) of Rule 9 of the General Rules as provided for in Rule 10(b) of those Rules.

On appointment as Assistant Motor Vehicles Inspector, candidates are directed to join for duty, before the Heads of Offices at the station

concerned on 28.03.2025. The Heads of Offices shall admit the candidates for duty after satisfying themselves about the genuineness. The candidate shall undergo training for a period of ten months during the period of probation as per the schedule notified by the Transport Commissioner. As such the Heads of Offices are directed to relieve the candidates on the day itself, with direction to report before the Principal, Police Training College, Thiruvananthapuram by 5.00 PM on 29.03.2025, so as to enable them to attend 5 months (120 working days) basic training. The candidates are directed to pay an advance amount of Rs. 6000/- as mess deposit while reporting for training. Instructions for training are enclosed.

If the candidate relieved from the department before completion of the training period, he shall remit the amount incurred for the training by the department.

The candidates are directed to produce the following documents before the Head of Offices at the time of reporting for duty;

- A. Original one time verification certificate issued by Kerala Public Service Commission.
- B. The documents to prove the identity, age, date of birth and qualifications, in original and attested photostat copies of the same.
- C. A Medical certificate prescribed under Rule 13 of Part I, KSRs, obtained from a Medical officer not below the rank of a Civil Surgeon or from the Head of Department of Indian System of Medicines shall be produced at the time of joining duty. The medical certificate should contain the photograph and thumb impression of the candidate duly attested by the Medical Officer as prescribed in G.O (P) No. 20/2011/P&ARD dated 30.06.2011.
- D. The proforma as stipulated in G.O.(P) No. 79/2009/Home dated 05.06.2009

for verifying the character and antecedents of the candidate. **(Copy enclosed)**

- E. Property statement as stipulated in the G.O. (P) No. 17/2016/Fin dated 15.11.2016. **(Copy enclosed)**
- F. Form No. 15 as per Rule 13 A, Part -I, KSRs. **(Copy enclosed)**
- G. The candidates against SL Nos. 2, 6, 7 & 9 should produce the Community Certificate in original. SL Nos. 1 & 10 should produce should produce the Non Creamy Layer Certificate in original. SL No. 4 should produce EWS Certificate in original.
- H. The candidates who were in Government service or Board/ Corporations/ PSU/ Aided/ Autonomous Body prior to 01.04.2013 and continuing and who are eligible to continue in Statutory Pension scheme vide GO (P) No. 209/2013/Fin Dated 07.05.2013 and GO (P) No. 279/2014/Fin Dated 14.07.2014 should submit their option for retention in Statutory Pension Scheme before the appointing authority within 3 months from the date of joining.
- I. The candidates who are already in Government service/ Board/Corporations / PSU/ Aided/ Autonomous Body/ Private firms etc. should produce the proper relieving order from the previous employer.

Application for correction of date of birth, if any shall be submitted within 5 years from the date of joining duty as stipulated in GO (P) No. 45/91/P&ARD dated 30.12.1991.

The service will be confirmed after successful completion of training and probation. The Officer will be on probation for a period of 2 years on duty within a continuous period of three years. In case of any disciplinary infractions or any other deficiencies in character and antecedents found later, the provisional appointment of the candidate will be cancelled and is liable to be terminated from service.

The appointment is subject to the final outcome of court cases such as OAs / OPs / WP(C)s etc. if any pending before various Courts / Tribunals.
