- D. The proforma as stipulated in G.O.(P) No.79/2009/Home dated 05.06.2009 for verifying the character and antecedents of the candidate. (Copy enclosed)
- E. Property Statement as stipulated in the G.O.(P) No. 17/2016/Fin dated 15/11/2016. (Copy enclosed).
- F. Form No. 15 as per Rule 13A, Part-I, KSRs. (Copy enclosed).
- G. Community Certificate in Original.
- H. The candidates who are in Govt. Service / Board/Corporations
 /PSU/Aided/Autonomous Body prior to 01/04/2013 and continuing and who are eligible to continue in Statutory Pension scheme vide GO(P)No.209/2013/Fin Dated 07/05/2013 and GO(P)No.279/2014/Fin Dated 14/07/2014 should submit their option for retention in Statutory Pension Scheme before the Appointing Authority within three months from the date of joining. The option form submitted after 3 months from the date of joining cannot be accepted at any cost as per G.O(P)No.209/2013/Fin Dated 07/05/2013 and GO(P)No.279/2014/ Fin Dated 14/07/2014.
- I. The candidates who are already in Govt. Service / Board/Corporations /PSU/ Aided/ Autonomous Body/Private Firms etc shall produce the proper relieving order from the previous employer.

4. The Heads of Offices shall admit them for duty after satisfying themselves about the correctness/ genuineness of the certificates produced by the candidates.

5. Application for correction of date of birth, if any shall be submitted within 5 years from the date of joining duty as stipulated in GO(P)No.45/91/P&ARD dated 30.12.1991.

6. The candidate shall undergo training for a period of ten months as per schedule notified by the Transport Commissioner. As such a Head of Offices are directed to relieve the candidates on the AN of 01.01.2025 with direction to report before the Principal, Police Training College, Thiruvananthapuram at 5.00 PM on 02.01.2025, so as to enable them to attend 5 months basic training. The candidates are directed to pay an advance amount of Rs. 6000/- as mess deposit while reporting for training. Instructions for training are enclosed.

7. The service will be confirmed after successful completion of training and probation. The Officer will be on probation for a period of 2 years on duty within a continuous period of three years. In case of any disciplinary infractions or any other deficiencies in character and antecedents found later, the provisional appointment of the candidate will be cancelled and is liable to be terminated from service.

8. In the event of discharge from service for want of vacancies, he may either re-register their names in the Office of the PSC/District Office of the PSC from where he was advised and get himself re-appointed on further advice by the PSC or he may wait for his tun for re-appointment to the post in the Department, in case he desires to continue as probationer in the post from which he is discharged (Vide Government circular memorandum No.3737/Rules-1/90/P&ARD dated 29.03.1990 and GO(P)No.7/91/P&ARD dated 15.02.1991).

9. The appointment is subject to the final outcome of court cases such as OAs/OPs/WP(C)s etc. if any, pending before various Courts/Tribunals.
