Shri. Rajeevan K (PEN135817), Motor Vehicles Inspector has requested to restore his seniority in the cadre of Assistant Motor Vehicles Inspector on the basis of his seniority the entry cadre of L D Clerk ( Renamed as Clerk) rather than on the basis of the date of joining in the cadre of Assistant Motor Vehicles Inspector, on appointment 'by transfer'.

Shri. Rajeevan K was appointed as Assistant Motor Vehicles Inspector through By Transfer as per Order No. A3/5228/2011/TC from the cadre of Senior Clerk along with three other officers as detailed below; on 08.07.2011. Shri. Rajeevan K was the senior most among these four officers in the entry cadre of L D Clerk ( Renamed as Clerk). As per the final seniority list of Assistant Motor Vehicles Inspectors published as per the order read as 2nd paper above, he was placed below the other three officers on the basis of date of joining in the post of Assistant Motor Vehicles Inspector.
