Consequent to the promotion of Shri. Rose Chandran, HA/HC/PRO, SRTO Nilambur, as Junior Superintendent as per the order read as 7th paper above, and the sanction of commuted leave to Shri. John Philip, HA/HC/PRO, RTO Pathanamthitta, two vacancies have arisen in the cadre of Head Accountant/Head Clerk/Public Relations Officer in the Motor Vehicles Department.

In addition, Smt. Sreelatha K. S., HA/HC/PRO, RTO Malappuram, has requested a transfer to SRTO Nilambur on compassionate grounds.

Further, Shri. Tijo Francis, Senior Clerk, RTO Muvattupuzha, who was denied promotion to the post of HA/HC/PRO due to the pendency of disciplinary proceedings, filed OA (EKM) No. 1255/2025 before the Hon'ble Kerala Administrative Tribunal, Ernakulam Bench, challenging the said denial. As per the Interim Order read as 4th paper above the Hon'ble

Kerala Administrative Tribunal directed the 2nd respondent, ie, Transport Commissioner to grant promotion to the applicant, Shri. Tijo Francis within 10 days as his junior is already promoted.

It is also noted that Shri. Bajesh C. K., who is senior to Shri. Tijo Francis in the seniority list of Senior Clerks, was also denied promotion earlier due to pending disciplinary proceedings, which have since been finalized, exonerating him of the charges vide GO read as 3rd paper above.

In view of the above circumstances, the following promotions in the cadre of Head Accountant/Head Clerk/Public Relations Officer are hereby ordered:

The interim order dated 17.10.2025 of the Hon'ble Kerala Administrative Tribunal in OA (EKM) No. 1255/2025 is complied with accordingly.
