ORDER NO. A4/83/2023/TC DATED:06-02-2024

A12 representation (representation dated 03.01.2024, filed with a plea to consider him for transfer to SRTO Kayamkulam/Karunagappally/Mavelikkara) after according due consideration for the benefit claimed under Ann.A3 (GO(Ms)No. 22/2022/P&ARD dated 26.09.2022), at the earliest, at any rate, within a period of one month from the date of receipt of a copy of this order. Till such time, Ann A11 order (order dated 29.12.2023) to the extent it relates to the applicant and respondents 3 (Sri Suraj R) and 4 (Sri Santhosh T L) shall not be implemented.
