**ORDER NO. A4/9/2024/TC DATED:11-03-2024**

As per the final seniority list of Senior Superintendents as on 01/07/2022 vide order read as 2nd paper above, the following are the next senior most Senior Superintendents eligible for Ratio Based Higher Grade.

The disciplinary actions initiated against Sri Satheesan C and T V Pramod are pending and a vigilance case is pending against Smt Manjula C V. Government, vide G. O. (Rt) No. 349/2021/TRANS dated 13/10/2021 have observed that *the seniority is the basic criterion for granting ratio promotions. The embargo on promotions to selection posts owing to the pendency of departmental action for major penalties, criminal case, vigilance case etc. are not applicable in the case of such promotions. The incumbent was promoted as Junior Superintendent and probation has been declared in that category during the pendency of said vigilance case itself. Since assessment of merit or suitability*

*is not done while effecting ratio promotions, pendency of a vigilance case where final report not been submitted, need not stand in the way of granting ratio promotion to the incumbent.*

In view of the above, the following Senior Superintendents of Motor Vehicles Department are granted Ratio Based Higher Grade in the scale of pay of Rs. 56500-1400-60700-1500-65200-1600-70000-1800-79000-2000-89000-2200- 97800-2500-115300-2800- 118100 with effect from the date noted against their names as provided in the Government order read above.
